INDEPENDENT AUDITORS' REPORT

To The Echo Design Group, Inc. 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Echo Design Group, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of The Echo Design Group, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, which was adopted on May 1, 1966, is a defined contribution plan covering all eligible employees of The Echo Design Group, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan trustees are responsible for the oversight of the Plan and determine the appropriateness of the Plan’s investment offerings and monitor investment performance in conjunction with the custodian and the Plan’s investment advisor.

Contributions

Employees whose employment is not governed by a collective bargaining agreement, are not non-resident aliens with no earned income as defined in the Plan, who have completed thirty days of service, and are of age twenty-one or older, may elect to make pretax elective or post-tax Roth elective contributions up to 75% of their eligible compensation, as defined in the Plan. In addition, employees who are regularly scheduled to complete less than 1,000 hours of service in an eligibility computation period. Provided that if they do complete at least 1,000 hours of service within such eligibility computation period they will be eligible to participate. Effective July 1, 2023 the Plan also allows participation for long-term part-time employees who work at least 500 but less than 999 hours of service for three consecutive years. Contributions made by all eligible participants are limited to the maximum allowable amount in accordance with the applicable sections of the Internal Revenue Code (“IRC”). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, increasing by 1% annually until such time as the default deferral percentage is 10%, and their contributions invested in a designated balance fund until changed by the participant.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Contributions (Continued)

Participants are eligible for profit sharing contributions provided the participant has met the eligibility requirements for employee contributions, has 500 hours of service for the year and is employed on the last day of the Plan year. Profit sharing contributions are provided at the Company's discretion and are allocated to eligible participants pro rata in the ratio that each participant's compensation bears to the compensation of all eligible participants. There were no Employer profit sharing contributions announced or accrued the Plan for the year ended June 30, 2024. Employer profit sharing contributions of \$114,121 were paid on September 13, 2023 and were fully accrued by the Plan for the year ended June 30, 2023.

Participant Accounts

Each participant's funds are kept in their own separate pre-tax, post-tax Roth and Company contribution accounts. Each participant's account is credited with the participant's contribution, and the Company's discretionary contribution, if any, is credited to the participant's Company contribution account. Net investment gains or losses and administrative expenses are allocated to each participant's account in proportion to account balances, as defined.

Forfeitures of terminated participants' nonvested Company contribution accounts are used to reduce the Company's future contributions or expenses of the Plan.

Information as to investment options and benefit payments has been published and made available to all participants.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant will receive the vested value of his or her account in a lump sum distribution or as defined in the Plan agreement.

Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested portion of their account balance. Loan terms may not exceed five years unless the loan is for the purpose of acquiring a principal residence. The loans are secured by the vested balance in the participant's account and bear interest at a reasonable rate of interest as determined at the time of the loan application by the Company. Loans outstanding during the year had interest rates which ranged from 5.75% to 9.50%. Principal and interest are paid ratably through bi-weekly payroll deductions or directly from the borrower and credited to the borrower's account balance.

Plan Expenses

The Plan provides that expenses of operating and administering the Plan will be paid from the Plan assets or by the Company. The Plan is currently paying substantially all of the administrative expenses.

Forfeitures

At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$1,374 and \$8,972, respectively. These accounts will be used to reduce future employer contributions. In 2023, employer contributions were reduced by \$8,446 from forfeited nonvested accounts which were remitted to the Plan on September 13, 2023.

Investment Options

Participants in the Plan direct employee and employer contributions among various investment funds having different investment objectives, as well as a discretionary brokerage account managed by Neuberger Berman Trust Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. No allowance for credit losses has been recorded as of June 30, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments are recorded when paid.

NOTE 3 - UNAUDITED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company and Principal Life Insurance Company, the trustees/custodians of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS (UNAUDITED)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The Plan also utilizes a practical expedient to estimate the fair value of investments that have calculated net asset value (“NAV”) per share. Accordingly, the Plan estimates the fair value of an investment using the NAV of the investment (or its equivalent) without further adjustment unless the Plan determines that the NAV is deemed to be not reflective of fair value.

The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 4 - FAIR VALUE MEASUREMENTS (UNAUDITED) (CONTINUED)

Level 3: Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. In evaluating the level at which the Plan's investments have been classified, the Plan has assessed factors including, but not limited to price transparency, the ability to redeem at net asset value at the year-end and the existence or absence of certain restrictions at year-end.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stock: Valued at the closing price reported on the active market on which the individual securities are traded.

Pooled separate accounts: Valued at the NAV or equivalent of the shares held by the Plan. The pooled separate accounts are not available in an exchange or active market; however the fair value is determined based on the pro-rata share of the underlying investments in the pooled separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Due to the nature of the pooled separate accounts, there are no unfunded commitments or redemption restrictions.

Common collective trust: The investment fund in the managed fund category of the common collective trust is a stable value fund which invests in synthetic investment contracts and GICs with associated underlying assets, and high-quality, fixed income instruments valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

NOTE 4 - FAIR VALUE MEASUREMENTS (UNAUDITED) (CONTINUED)

Interests in each fund are represented by units of beneficial interest. Each unit represents an equal pro rata interest in the net assets of a fund. There are no unfunded commitments with respect to the common collective trust. The fund generally provides for daily redemptions by the Plan at reported NAV per share, without any advance notification. The fund may in its sole discretion, impose restrictions on issues and redemptions of units. The plan administrator does not believe that the occurrence of any such event is probable.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal Trust Company. Principal Trust Company is the Plan's custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Principal Trust Company provides certain administrative services to the plan pursuant to a Custodial Agreement between the Company and Principal Trust Company. Principal Trust Company receives revenue from mutual fund service providers and collective trust fund service providers for services Principal Trust Company provides to the funds. This revenue is used to offset certain amounts owed to Principal Trust Company for its administrative services to the Plan.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS (CONTINUED)

If the revenue received by Principal Trust Company from such mutual fund or collective trust fund services providers exceeds the amount owed under the Custodial Agreement, Principal Trust Company remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During the Plan year ended June 30, 2024 there were no excess amounts. The Plan or Plan Sponsor may make a payment to Principal Trust Company for administrative expenses not covered by the revenue sharing.

Fees paid by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments.

NOTE 6 - PLAN TERMINATION

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, or partial termination of the Plan, participants' accounts shall be fully vested as of the date of such termination. The Company determines the date and manner in which participants' accounts will be distributed in accordance with ERISA.

NOTE 7 - TAX STATUS

The Internal Revenue Service has determined and informed the Plan administrator by a letter dated June 30, 2020, that the form of the volume submitter plan is acceptable under the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the advisory letter. However, the Trustees of the Plan believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Trustees have analyzed the tax positions taken by the Plan, and have concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require adjustment to or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - LIFE INSURANCE CONTRACTS

Plan participants may purchase insurance policies in accordance with the provisions of the Plan. Premiums totaling \$50,216 were included in benefits paid to participants in the statement of changes in net assets available for benefits for the year ended June 30, 2024. The cash surrender value of these policies is excluded from net assets available for benefits in the accompanying financial statements as the proceeds on maturity are paid to the participants' beneficiaries.

NOTE 10 - SUBSEQUENT EVENTS

Subsequent events have been evaluated through April 7, 2025, which is the date the financial statements were available to be issued.
