Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Preble Street 403b Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from qualified institutions as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in the "Information Prepared and Certified by Custodians" note to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. DESCRIPTION OF PLAN

The following description of the Preble Street 403b Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all eligible employees of Preble Street (the “Sponsor”). The Plan was established in 1999 to allow participants to set aside a portion of their compensation on a pre-tax basis and to match a portion of such deferrals with employer contributions on a discretionary basis. The Plan was restated January 1, 2009, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility - As of December 1, 2014, all employees are eligible to make elective deferrals beginning on their date of hire. All employees are eligible to receive employer matching contributions beginning on the date of their initial elective deferral.

Prior to December 1, 2014, employees who were regularly scheduled to work less than 20 hours per week were not eligible to participate in the Plan.

Contributions - During the period covered by the Plan, participants may make salary reduction contributions up to the maximum annual limits prescribed by law. Participants may modify salary deferral elections on a daily basis. Participant contributions may also consist of rollovers or transfers from other qualified plans provided they meet the requirements of the Plan as determined by the Plan Administrator.

The Sponsor contributes 25% of the first 4% of compensation that a participant contributes to the Plan.

Participant Accounts - Each participant’s account is credited with the participant’s contributions, the Sponsor’s matching contribution, and an allocation of Plan earnings based on account balances.

Vesting - Participants are 100% vested in their own contributions, employer matching contributions, and employer non-elective contributions, plus actual earnings thereon. Thus, participants are always entitled to the full amount in their accounts.

Benefits - A terminating participant with a vested benefit is entitled to a distribution, as soon as administratively practicable, upon the participant’s election. Minimum distributions are required beginning April 1st of the calendar year following the later of the year in which the participant attains age 72 or retires prior to January 1, 2023, or age 73 or retires after January 1, 2023.

In-service distributions to participants who have not separated from service may be made upon obtaining the age of 59½. Distributions are permitted from the Plan upon death or meeting certain disability or hardship qualifications. Beginning in fiscal year 2022, Roth deferrals are available for in-service withdrawals. Participant rollover distributions may be distributed upon the request of the employee.

Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to 50% of their account balance or \$50,000. The loans are secured by the balance in the participant’s accounts. At June 30, 2024, the interest rate on outstanding loans was 10.5%. At June 30, 2023, the interest rate on outstanding loans was 10.25%. Principal and interest is paid ratably through bi-weekly payroll deductions.

DESCRIPTION OF PLAN, CONTINUED

Amendments - As of November 24, 2010, the Plan was amended to adopt the HEART/WRERA Amendment.

Effective July 1, 2013, the Plan was amended to exclude bonuses from the definition of plan compensation.

Effective December 1, 2014, the Plan was amended so that all employees are eligible to participate.

Effective February 1, 2018, interest rates on notes receivable from participants are determined at a rate of prime plus 2%.

Forfeitures - Portions of employer contributions in which a participant is not fully vested at the time of termination or withdrawal from the Plan are considered forfeited and are used first to pay reasonable Plan expenses and then to apply to employer matching contributions. There were no forfeited non-vested accounts for either of the years ended June 30, 2024 and 2023.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Operating Expenses - Certain plan expenses are paid by the Sponsor. All other expenses of maintaining the Plan are paid for by the Preble Street 403b Retirement Plan. Expenses that are paid by the Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest at rates deemed to be reasonable. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document. All outstanding notes receivable balances are deemed fully collectible, thus no allowance for uncollectible notes has been recorded at June 30, 2024 and 2023.

Investment Valuation and Income Recognition - Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's personnel committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See "Fair Value Measurements" footnote for discussion of such measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold during the year as well as held at year end.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - The Plan has evaluated subsequent events through March 28, 2025, which is the date the financial statements were available to be issued.

PLAN TERMINATION

While the sponsor has not expressed any intent to terminate the Plan, it is able to do so at any time subject to the provisions of ERISA. In such event, net assets of the Plan are to be distributed to participants by the Plan's custodian.

INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following investment information was certified by Empower Retirement and Lincoln Financial Group, the custodians of the Plan, and was not subjected to any auditing procedures:

- a. Total investments as shown in the accompanying statements of net assets available for benefits of \$4,646,659 and \$3,931,034 at June 30, 2024 and 2023, respectively.
- b. Total notes receivables from participants as shown in the accompanying statements of net assets available for benefits of \$27,382 and \$2,530 at June 30, 2024 and 2023, respectively.
- c. Investment income as shown on the accompanying statements of changes in net assets available for benefits of \$524,116 and \$284,544 in net appreciation in fair value of investments, \$59 and \$51 in net appreciation in investments at contract value, \$111,445 and \$149,345 in interest and dividends, and \$1,434 and \$187 in interest on notes receivable from participants for the years ended June 30, 2024 and 2023, respectively.

FAIR VALUE MEASUREMENTS

FASB ASC 820 *Fair Value Measurement and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs include quoted prices for similar or identical assets or liabilities in active or inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at June 30, 2024 and 2023.

In accordance with FASB ASC 820-10, *Fair Value Measurement and Disclosures*, investments for which fair value is measured using the net asset value per share as a practical expedient are not categorized within the fair value hierarchy below. The Plan had no assets measured using the net asset value per share as a practical expedient at June 30, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

GENERAL INVESTMENT CONTRACTS

The Plan has a general annuity contract with Lincoln Financial Group, provided through a group annuity contract. Effective January 1, 2008, this contract was frozen with the transfer of the Plan from Lincoln Financial to MassMutual Retirement Services. No new contributions to this annuity contract are permitted. During February 2018, the Plan entered into a second general annuity contract with Empower Retirement, provided through a group annuity contract. There was no outstanding balance of the contract held with Lincoln Financial Group as of June 30, 2024 and 2023. The balance of the contract held with Empower Retirement as of June 30, 2024 and 2023 was \$4,296 and \$4,290, respectively.

Under the terms of each of these group annuity contracts; a credit rate is established for amounts invested in the guaranteed interest accounts and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees.

For investment contracts that are fully benefit-responsive, contract value is the relevant measurement to be included in the financial statements, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The Plan administrator believes that contract value approximates fair value for these investment contracts.

Certain events may limit the ability of the Plan to transact at contract value with the contract issuer, including: 1) termination of the contracts by the Plan; 2) Plan termination; and 3) Plan sponsor events that would affect the Plan's normal operations. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer or the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle for an amount that differs from contract value. Examples of possible events include: 1) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code 2) termination of the contracts 3) Plan termination or 4) a material breach of contract by the Plan.

PARTY-IN-INTEREST

Empower Retirement is the record keeper of the Plan. Empower Retirement, as well as Lincoln Financial Group, are the custodians of the Plan. The custodians hold and manage the Plan's assets and make distributions in accordance with the instructions of the plan administrator. Some of these investments are shares of funds managed by the custodians. Fees paid by the Plan for the investment management services amounted to \$51,719 and \$41,557 for the years ended June 30, 2024 and 2023, respectively. In addition, certain distributions made by the custodians are in the form of loans to the Plan's participants. These distributions are also considered to be party-in-interest transactions.

RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

TAX EXEMPT STATUS

A 403(b) plan, also known as a tax-sheltered annuity (TSA) plan, is a retirement plan for certain employees of public schools, employees of certain tax-exempt organizations, and certain ministers. Such plans are exempt from federal income taxes.

The Internal Revenue Service has announced its intention to establish a determination letter program for 403(b) plans, although as of the date of this report such a program has yet been implemented. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been made by the Plan.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
