NOTE 1: DESCRIPTION OF PLAN

The following description of the Esperanza Health Center 401(k) Savings Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General - The Plan is a defined contribution plan, established and effective July 1, 2008, to provide eligible employees of Esperanza Health Center, Inc. (Company), a Pennsylvania not-for-profit corporation, the opportunity to accumulate savings that provide benefits in the event of retirement, disability, or death. The Plan was most recently restated July 1, 2022. The Plan is structured to comply with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for oversight of the Plan. Participation in the Plan is voluntary.

Eligibility - Employees, excluding leased employees, become immediately eligible to participate in the Plan. An eligible employee may enter the Plan the first day of each calendar month following the date of eligibility. In addition, an employee becomes eligible to receive safe harbor nonelective contributions and discretionary employer matching on the first day of the calendar month after earning a year of service, which is defined as at least 700 hours of service in a 12-month period.

Contributions - Each year, participants are eligible to contribute up to 85% of pretax or after-tax annual compensation, as defined in the Plan, up to the maximum permitted by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into a menu of diversified investment options offered by the Plan. The Company made safe harbor nonelective contributions of up to 3% of eligible participants' compensation for a total of \$307,309 during the year ended June 30, 2024. The Company also made discretionary matching contributions to eligible participants. During the year ended June 30, 2024, the Company made discretionary matching contributions of up to 3% of eligible participants' compensation for a total of \$238,347. Contributions are subject to limitations to comply with the nondiscrimination requirements of the Internal Revenue Code (IRC).

Participant Accounts - Each participant's account is credited with the participant's contributions, Company safe harbor nonelective contributions, and discretionary matching contributions, plan earnings, and charged with an allocation of administrative expenses, if applicable. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their account balances.

NOTE 1: DESCRIPTION OF PLAN - CONTINUED

Forfeitures - As of June 30, 2024 and 2023, forfeited nonvested accounts totaled \$11 and \$10, respectively. These accounts will be used to reduce future employer contributions. During the year ended June 30, 2024, forfeitures totaling \$0 were used to reduce employer contributions.

Payment of Benefits - Upon termination of employment, attaining normal retirement age (65), disability, or death, a participant may elect to receive an amount equal to the value of his or her eligible account balance paid through a single lump-sum payment or amount equal to the value of the vested interest in his or her account, substantially equal payments, partial withdrawal for required minimum payments, or delay withdrawal until a future date, if the account is over \$5,000. If a terminated participant does not elect to have a mandatory distribution not exceeding \$1,000 paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, the plan administrator will direct the trustee to immediately distribute such benefit in a lump sum without the participant's consent. For any distribution exceeding \$1,000, but not in excess of \$5,000, the participant shall be given the option to elect to have such distribution paid directly to an eligible retirement plan specified by him or her in a direct rollover or to receive the distribution directly. If neither option is selected, the plan administrator shall make such distribution in a direct rollover to an individual retirement plan designated by the plan administrator and shall provide written notice to the participant informing the participant that he or she has the option to transfer such amount into another individual retirement plan of his or her own choice.

A participant who has reached age 59½ may elect to withdraw all or a portion of his or her entire account while still employed by the Company. As required under Section 401(a)(9) of the IRC, a participant must begin receiving required minimum distributions from the Plan by April 1 of the calendar year following the later of (i) the calendar year following the year in which the participant reaches age 72, or (ii) the calendar year in which the participant retired. Effective January 1, 2023, the required age increased to 73.

Hardship Withdrawals - Participants may withdraw the vested balance of their employee pretax accounts, employee Roth accounts, rollover contributions, and any employer accounts in the form of a hardship withdrawal to satisfy an immediate and heavy financial need, as defined by the Plan. The distribution may exceed the immediate and heavy financial need by the amount of federal, state, or local income tax or penalties reasonably anticipated to result from the distribution. The participant must exhaust all other avenues prior to obtaining a hardship withdrawal.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received for the sale of an asset or paid for the transfer of a liability in an orderly transaction between market participants at the measurement date. The plan's pension committee determines the plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses in investments bought and sold as well as held during the year and is shown net of fees incurred by the Plan for investment management services.

Contributions - Contributions from plan participants are recorded in the year in which the participant contributions are withheld from compensation.

Employer Contributions Receivable - Employer Match Contributions Receivables were \$2,052 and \$0, as of June 30, 2024 and 2023, respectively. Employer Safe Harbor NEC Receivables were \$3,308 and \$0, as of June 30, 2024 and 2023, respectively.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Costs associated with participant-initiated transactions are paid by the respective participants' accounts.

Subsequent Events - The Company's policy is to evaluate events and transactions subsequent to its year end for potential recognition in the financial statements or disclosure in the notes to the financial statements. The Company has evaluated events and transactions through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used as of June 30, 2024 and 2023.

NOTE 3: FAIR VALUE MEASUREMENTS - CONTINUED

Registered Investment Companies (Mutual Funds) - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5: RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Company has not considered normal plan operations such as participant and employer contributions or benefits accrued or paid to participants as party-in-interest transactions that require separate disclosure. Certain plan investments are shares of registered investment companies (mutual funds) held by the trustee. Fees paid during the year for professional services rendered by parties in interest were partially absorbed by the Company. Participant-initiated transaction fees, such as distribution fees, are paid out of the relevant participants' accounts. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would remain 100% vested in their accounts.

NOTE 7: TAX STATUS

The underlying ADP, LLC prototype non-standardized profit-sharing plan with Cash or Deferred Arrangement (CODA) has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the Plan is qualified under Section 401 of the IRC and therefore, the related trust is tax exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and therefore, believes the Plan is qualified and the related trust is tax exempt.

NOTE 7: TAX STATUS - CONTINUED

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS or DOL. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability, asset, or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process. The Plan's federal Form 5500 is subject to examination from regulatory authorities, generally for the three years after it was filed.

NOTE 8: RISKS AND UNCERTAINTIES

The Plan invests in various registered investment companies, which are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9: COMMITMENTS AND CONTINGENCIES

In the normal course of business, there may be various commitments and contingencies outstanding which are not reflected in these financial statements. In the opinion of the Company, the outcome of such events, if any, would not have a material effect on the Plan's financial position or operations.
