## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the  
Hawkswood, Inc. 401(k) Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Hawkswood, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1: DESCRIPTION OF PLAN**

The following description of the Hawkswood, Inc. 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan was established on August 20, 2015 and is a defined contribution plan covering all eligible employees of Hawkswood, Inc. (the “Plan Sponsor”), as defined in the Plan document. There are no age or service eligibility requirements for the elective deferral portion of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is administered by the Plan Sponsor’s board of directors. The board of directors has the sole responsibility for the administration of the Plan, as defined in the Plan’s provisions. The Plan is managed through Alerus Financial, N.A. (“Alerus”).

The Plan was most recently restated effective July 1, 2023 to adopt the Planned Retirement Consultants & Administrators, LLC Pre-Approved Volume Submitter IDP Plan.

**Contributions**

Each year, participants may contribute up to maximum Internal Revenue Service (“IRS”) limitations during the Plan year. For the year ended June 30, 2024, the applicable dollar amount was \$23,500. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The maximum catch-up contribution was \$7,500 for the year ended June 30, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution Plans (rollover). All contributions are subject to certain IRS limitations.

The Plan Sponsor may make a discretionary matching contribution. In order to be eligible for the Plan Sponsor's discretionary matching contribution, participants must have achieved one year of service and make an elective deferral contribution of at least 5% of employees’ annual salary during the year for which the contribution is made. For the year ended June 30, 2024, the match percentage was 7%. The discretionary matching contribution totaled \$409,897 for the year ended June 30, 2024.

The Plan also allows for a discretionary nonelective profit sharing contribution to be made by the Plan Sponsor in an amount based determined annually by the Plan Sponsor. To be eligible for the nonelective profit sharing contribution, participants must have achieved one year of service and be credited with 1,000 or more hours of service in the Plan year for which the contribution is made. Additionally, the participant must be employed on the last day of the Plan year. The nonelective profit sharing contribution totaled \$882,497, net of forfeitures, for the year ended June 30, 2024. The nonelective profit sharing contribution is allocated based on the chart below.

The Plan Sponsor contributed between 7.50% and 12.71% of its employees' eligible compensation for the year ended June 30, 2024, based on individual employee classifications as follows:

All Plan Sponsor contributions are recorded as receivables on the accompanying statements of net assets available for benefits as they are not remitted by the Plan Sponsor until the subsequent fiscal year. Contributions receivable are recorded net of Plan Sponsor advances. Contribution advances totaled \$600,000 and \$250,000 during June 30, 2024 and 2023, respectively.

**Participant Accounts**

Participants' investments are self-directed from a choice of investments provided by Alerus. Each participant's account is credited with the participant's and Plan Sponsor's contributions, Plan earnings, and an allocation of administrative expenses. Allocations are based on a percentage of contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service.

Participants are immediately 100% vested upon death or total and permanent disability.

**Forfeitures**

Participants in the Plan who terminate employment prior to completing six years of service forfeit the non-vested portion of their account. Forfeitures may be used to reduce Plan Sponsor contributions or pay administrative expenses. As of June 30, 2024 and 2023, forfeitures available to the Plan totaled \$119,539 and \$119,852, respectively. Forfeitures totaling \$79,674 and \$115,741 were used to reduce Plan Sponsor contributions during the years ended June 30, 2024 and 2023, respectively.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount of the lesser of: a) 50% of the participant's vested account or b) \$50,000. No more than one loan may be outstanding at any time. Loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Note terms range from one to five years, with longer terms available for the purchase of a primary residence. Principal and interest are repaid through monthly payroll deductions.

**Payment of Benefits**

Upon termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Upon termination of employment, the Plan has a mandatory cash-out provision for participants with less than \$5,000 in their account, which does not require consent from the participant. Hardship withdrawals from accounts which are fully vested are permitted by the Plan. In-service distributions are allowed for participants after reaching age 55.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures. Accordingly, actual results may differ from those estimated.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor's board of directors determines the Plan's valuation policies utilizing information provided by investment advisors, custodian and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through April 7, 2025, the date the financial statements were available to be issued.

**NOTE 3: INFORMATION CERTIFIED BY ALERUS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended June 30, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Alerus.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the above information which appears throughout the financial statements and supplemental schedule.

**NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial

*Money market funds:* Valued at the quoted NAV of shares held by the Plan at year end.

**NOTE 5: RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Alerus, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants, which are secured by the participant’s account balances. These transactions qualify as party-in-interest transactions.

**NOTE 6: TAX STATUS**

The Plan Sponsor has adopted a pre-approved plan document that has received an opinion letter from the IRS dated August 1, 2023, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes the Plan is generally no longer subject to income tax examination for years prior to 2021.

**NOTE 7: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Plan Sponsor also reserves the right to amend, modify, suspend or terminate the Plan permanently or temporarily, at such time as they deem appropriate. In the event of Plan termination or if the Plan Sponsor elects to discontinue contributions, the total value of each participant’s account will be fully vested.


