### Report on the Audit of the Financial Statements

#### *Opinion*

We have audited the accompanying financial statements of I.B.E.W. Health and Welfare Trust of Southwest Washington Health Care Benefits Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and statements of benefit obligations as of June 30, 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of I.B.E.W. Health and Welfare Trust of Southwest Washington Health Care Benefits Plan as of June 30, 2024, and the changes in its net assets available for benefits and benefit obligations for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

#### *Basis for Opinion*

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Health and Welfare Trust of Southwest Washington Health Care Benefits Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the I.B.E.W. Health and Welfare Trust of Southwest Washington Health Care Benefits Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for more complete information.

**General**

The Plan was established on June 26, 1972, as a result of collective bargaining agreements between the Southwest Chapter, National Electrical Contractors Association, and the International Brotherhood of Electrical Workers Local Union 76. The current Plan provides medical, prescription drug, dental, life, accidental death and dismemberment, time loss and vision benefits for eligible employees and their eligible family members and provides medical and prescription drug benefits for eligible retirees. Benefits are generally paid directly from Plan assets, except for dental, accidental death and dismemberment, and some medical benefits for those participants who elect to be covered through health maintenance organizations. Those benefits not paid directly from Plan assets are paid through contracts with an insurance company and various health maintenance organizations.

**Board of Trustees**

The Plan is administered by a Board of Trustees (the Trustees) composed of four union trustees and four employer trustees.

**Eligibility**

General eligibility rules under the Plan are as follows:

- a. Participating employers will pay the contribution amount described in the labor agreement for each compensable hour of a participant. Contributions for hours worked in any month are deposited to the participant's dollar bank on the first day of the second month following the month worked. A new participant must accumulate an amount in his/her dollar bank sufficient to purchase default/basic coverage in order to satisfy the initial eligibility requirements. Coverage will commence on the first day of the second month after the amount in the dollar bank has reached a level sufficient to pay for default/basic coverage.
- b. After the initial eligibility requirements have been satisfied, coverage will be in effect for each month for which there are sufficient dollars in the dollar bank to pay the amount of premium on the first day of that month. If the amount in a participant's dollar bank falls below one month's premium, the participant may make a self-payment to continue coverage.

Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act (COBRA), has been adopted by the Plan.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Retirees**

Certain retiree benefits are being funded by current employer contributions and monthly contributions from retirees. Some early retirees between ages 59 and 64 are eligible for a subsidized premium rate. For those participants who retired prior to August 1, 2022, the self-pay rates are set so that partial self-pay retirees pay 50% of the projected active benefit cost for the retiree and 10% of this cost for each dependent (maximum of 30% for dependents). Partial self-pay retirees become self-pay retirees at age 65. For those participants that retired on or after August 1, 2022, the partial self-pay retirees pay a rate based on age and service at retirement. Single retirees pay 80% of the couple (retiree & spouse) rates. Self-pay retirees pay a monthly premium based on the estimated cost of their coverage. Surviving spouses are not eligible for partial self-pay benefits and, therefore, pay a monthly premium based on the estimated cost of their coverage.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of Accounting**

The accompanying financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Change in Accounting Policy**

The Plan has adopted the Financial Accounting Standards Board (FASB) Accounting Standards Update (ASU) 2016-13, *Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments*, effective July 1, 2023, utilizing the modified retrospective transition method. The accounting standard modifies the method for estimating credit losses on financial assets from probable or incurred credit losses to lifetime expected future credit losses (CECL). No cumulative effect adjustment to net assets available for benefits as of July 1, 2023, was necessary upon adoption.

**Contributions Receivable**

Contributions due but not paid prior to year-end are recorded as contributions receivable. Contributions are due from employers as specified in the collective bargaining or participation agreement. In general, contributions are due on the 15th day of each month following the work month. Delinquent contributions and payroll audit findings are individually analyzed for collectability. The estimate for expected credit losses considers historical loss experience, current economic conditions, and forward-looking information, including factors such as payment history, employer financial condition, and labor trends. As of June 30, 2024, the allowance for credit losses was insignificant.

**Stop-Loss Recoveries**

Claims that were already paid from the Plan that exceeded the stop-loss coverage and are due to the Plan at year-end are recorded as a receivable. Premiums for stop-loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits.

**Prescription Rebates**

Prescription rebates due from the Plan's pharmacy benefit manager are recorded when earned. Rebates due at year-end are recorded as a receivable on the statements of net assets available for benefits.

**Payment of Benefits**

Premiums paid are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when submitted to the Plan by the third-party claims processor for reimbursement. Claims paid by the claims processor prior to year-end or claim payments submitted to the Plan by the third-party claims processor that are not yet paid are recorded as an amount currently payable in the accompanying statements of benefit obligations.

**Benefit Obligations**

Claims payable and incurred but not reported and accumulated eligibility credits were estimated based on premiums and claims experience data. Claims payable and incurred but not reported is an estimate of the cost to the Plan for claims incurred by participants under the terms of the Plan through June 30 of each year but paid by the Plan subsequent to June 30.

Accumulated eligibility credits are an estimate of the cost to the Plan for benefits earned based on work performed in May and June, which provides eligibility for the following months of July and August. Accumulated eligibility credits also include an estimate of the cost to the Plan for the dollars banked by participants through the work month of June to be used to provide eligibility for a period of up to five months starting the following September. Effective January 1, 2020, the dollar bank was increased to provide for eligibility for a period of up to six months.

Postretirement benefit obligations were actuarially determined by the Plan's actuary. The postretirement benefit obligations are computed as the net cost to the Plan and consider the future contributions received from current participants during their remaining active service and postretirement periods.

**Valuation of Investments**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Risks and Uncertainties**

The actuarial present value of postretirement benefit obligations is calculated based on certain assumptions pertaining to interest rates, participant demographics and other assumptions, all of which are subject to change. The estimate for claims incurred but not reported is based on certain assumptions pertaining to health care trend rates, claims lag, and historical claims date. The estimate for accumulated eligibility credits is based on certain assumptions pertaining to health care trends and inflation rates. Due to uncertainties in the estimations and assumptions process, it is at least reasonably possible that changes in these assumptions in the near term would be material to the disclosure to the financial statements.

The Plan invests in mutual funds and a money market mutual fund. Such investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**Subsequent Events**

The Plan has evaluated subsequent events through April 1, 2025, the date the financial statements were available to be issued.

**NOTE 3 PRIORITIES UPON TERMINATION**

The Plan may be terminated at any time by action of the Trustees. The Plan shall terminate automatically when all collective bargaining agreements and special agreements providing for contributions to the trust have expired and negotiations for extension thereof have ceased. In the event of termination of the Plan, the Trustees shall apply the assets of the Plan to pay, or to provide for payment of, any and all obligations of the trust in accordance with the provisions of the Plan. In no event shall any of the assets remaining in the trust be paid to or recoverable by any employer or Union.

**NOTE 4 TAX STATUS**

The Plan obtained a determination letter, dated October 8, 1972, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code or that any instances of noncompliance would be eligible for correction, including self-correction, under an applicable Internal Revenue Service corrective procedure. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require management to evaluate the tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. The Plan has analyzed the tax positions taken by the Plan and has concluded that, as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan believes it is no longer subject to income tax examinations for the fiscal years prior to 2021.

**NOTE 5 FUNDING POLICY**

The Plan is funded by employer and retiree contributions and from participants electing COBRA coverage. Employer contributions are based on hours of work and are made in accordance with rates set forth in the collective bargaining agreements. Contribution rates for retirees and participants electing COBRA coverage are set by the Board of Trustees based on information provided by the Plan's consultant.

The Plan participates in reciprocity agreements with other electrical workers funds. In accordance with these agreements, the Plan is required to remit funds received and is entitled to receive funds from participating employers on behalf of temporary employees to and from the employees' participating local unions.

For the years ended June 30, 2024 and 2023, the Plan remitted \$2,074,459 and \$1,867,815, respectively, and received \$2,844,782 and \$2,901,071, respectively, of reciprocal contributions in accordance with these agreements. Reciprocal payments are included in the employer's contributions in the statements of changes in net assets available for benefits. No allowance for credit losses as of June 30, 2024 or 2023, was necessary for reciprocal payments due to the Plan.

**NOTE 6 INVESTMENTS AT FAIR VALUE HIERARCHY**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at June 30, 2024 and 2023.

*Short-Term Funds and Mutual Funds:* Investments in the short-term funds and mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 7 CASH CONCENTRATIONS**

The Plan maintains its cash at a single financial institution. The balances are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 in a single institution. The Plan's cash in excess of FDIC insurance coverage at June 30, 2024 and 2023, totaled \$2,406,537 and \$4,869,348, respectively.

**NOTE 8 POSTRETIREMENT BENEFIT OBLIGATIONS**

The postretirement benefit obligations represent the total actuarial present value of those estimated future benefits that are attributed to employee service rendered to June 30 reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for: (1) currently retired employees, (2) active employees after retirement from service with the participating employers, and (3) eligible dependents. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to the employee's service in the industry rendered through the valuation date.

The actuarial present value of the expected postretirement benefit obligations is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of retirement.

The trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the postretirement benefit obligations as of June 30, 2024 and 2023, by \$612,472 and \$427,649, respectively.

Some of the more significant actuarial assumptions used to calculate the postretirement health and death benefit obligations at June 30, 2024 and 2023, are as follows:

Mortality Rates – Healthy:	Pri-2012 Healthy Retiree Blue Collar Headcount-weighted Mortality tables, projected generationally from 2012 using Scale MP-2021.
Mortality Rates – Disabled:	Pri-2012 Disabled Retiree Headcount-weighted Mortality tables, projected generationally from 2012 using Scale MP-2021.
Discount Rate:	For 2024, 5.25%. For 2023, 5.00%.
Retirement Rate:	For 2024 and 2023, 100% at age 65 for participants eligible for Rule of 85 pension, and 100% at age 70 for other participants.

For measurement purposes, at June 30, 2024, the annual rate per-capita cost trend rates are assumed to decrease from 7.0% in 2025 to 4.50% in 2040 and beyond for medical claims, from 12.0% to 4.50% in 2040 and beyond for Rx claims, by 3.00% in 2025 and beyond for vision claims, by 4.00% in 2025 and beyond for dental claims, and by 3.00% for all years for administrative expenses.

At June 30, 2023, the annual rate per-capita cost trend rates are assumed to decrease from 7.0% in 2024 to 4.50% in 2034 and beyond for medical claims, from 9.5% to 4.50% in 2034 and beyond for Rx claims, by 4.00% in 2024 and beyond for vision and dental claims, and by 3.00% for all years for administrative expenses.

Actuarial valuations were performed by Segal as of June 30, 2024 and 2023. The valuations applied the Plan provisions in effect on those dates. As of June 30, 2024 and 2023, the trends on per-capita health costs were updated to reflect changes in projected costs and retiree contributions.
