SUMMARY ANNUAL REPORT

For KECK & SCHMIDT TOOL & DIE INC 401K PLAN

This is a summary of the annual report Form 5500-SF Annual Return/Report of Small Employee Benefit Plan for KECK & SCHMIDT TOOL & DIE INC 401K PLAN, EIN 95-2833957, Plan No. 001, for period July 1, 2023 through June 30, 2024. The Form 5500-SF annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a single-employer defined contribution plan.

Basic Financial Statement

Benefits under the plan are provided by a Group Annuity Contract with Sentry Life Insurance Company Inc. Plan expenses were \$306,717. These expenses included \$2,575 in administrative expenses, and \$304,142 in benefits paid to participants and beneficiaries. A total of 12 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons may have earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$601,627 as of June 30, 2024, compared to \$754,641 as of July 1, 2023. During the plan year the plan experienced a decrease in its net assets of \$153,014. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$153,703, including employee contributions of \$21,903, and earnings from investments of \$131,800.
