Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audit of the financial statements of SHCMHC 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Notes to Financial Statements

For the Years Ended June 30, 2024 and 2023

1 – DESCRIPTION OF PLAN

The following description of the SHCMHC 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Southern Highlands Community Mental Health Center, Inc. (the "Company"). The Plan was established November 1, 2015, and was amended and restated effective November 15, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are immediately eligible to make pre-tax elective deferrals, with no age or service requirements. Employees must be 21 years of age to receive employer nonelective contributions and safe harbor contributions. Additionally, employer nonelective contributions and safe harbor contributions require 90 days of eligibility service.

Contributions

Contributions to the Plan include: (i) salary reduction contributions (pre-tax) authorized by participants not to exceed the amount prescribed by the Internal Revenue Code, (ii) a safe harbor matching contribution made by the Company (100% of each participant's salary reduction contribution up to 3% and 50% of that exceeding 3% up to 5%), (iii) discretionary non-elective contribution determined by employer from year to year. Participants direct the investment of their contributions into various investment options offered by the Plan. Rollovers into the Plan are allowed.

Effective November 15, 2021, the Plan was amended to allow separate deferral elections on bonuses.

Safe harbor matching contributions for the years ended June 30, 2024 and 2023 were \$176,845 and \$151,937, respectively. There were no non-elective contributions for the year ended June 30, 2024 and 2023.

Participant accounts

Each participant's account is credited with the participant's contribution, the Company contribution, and an allocation of earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals, safe harbor matching contributions, and rollover contributions plus earning thereon. Vesting in the Company's discretionary nonelective contributions is based on years of continuous service. A participant is fully vested after six years of credited service.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant with a vested balance in excess of \$5,000 may elect to receive a lump-sum distribution or partial payments. Vested benefits of \$5,000 or less will be paid in a lump-sum amount.

2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefit payments are recorded when paid.

3 – INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan's mutual funds are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 consists of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques bases on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used only when Level 1 inputs are not available.

4 – RELATED – PARTY TRANSACTIONS

Plan participants may choose to invest in funds managed by the Plan's service provider and these are considered related-party transactions. Certain Administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

5 – PLAN TERMINATION

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6 – TAX STATUS

The Plan is an adoption of a prototype plan sponsored by Ascensus. The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated January 1, 2018, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 20, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

7 – CERTIFIED INVESTMENTS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA for 2024.
