The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Shawnee Health Service and Development Corporation 401(k) and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A | DESCRIPTION OF THE PLAN

The following description provides only general information for Shawnee Health Service and Development Corporation (the Corporation or Plan Sponsor) 401(k) and Profit Sharing Plan (the Plan). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan, which became effective July 1, 1985, is a 401(k) and profit sharing retirement plan covering all eligible employees twenty one years or older. Eligible employees can participate in the nonelective profit sharing portion of the plan upon completing one year of service. This plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 (ERISA). The Plan was amended and restated effective June 15, 2020 for certain administrative changes.

2. Contributions

A separate contribution account is established for each employee eligible for participation in the Plan. Employees are automatically enrolled in salary deferrals at 3% upon obtaining eligibility unless a waiver is completed. Each year, participants may contribute up to the maximum dollar amount as determined by the Federal government of pretax annual compensation, as defined by the Plan. Effective July 1, 2006, this Plan is referred to as a safe harbor 401(k) plan. In order to maintain "safe harbor" the Company makes a contribution equal to 3% of pretax annual compensation. For the years ended June 30, 2024 and 2023, \$676,837 and \$603,460 of safe harbor contributions were contributed, respectively. A discretionary profit sharing contribution may be made at the Board of Directors' discretion. For the year ended June 30, 2024 and 2023, the Board of Directors did not elect to make a discretionary profit sharing contribution.

3. Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Corporation's contribution and plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A | DESCRIPTION OF THE PLAN

4. *Vesting*

Participants are immediately vested in their voluntary contributions and Company safe harbor contributions plus actual earnings thereon. Vesting in the Corporation's profit sharing contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service based on the following: vesting is 0% until a participant has two years of service and then after the second year a participant is 20% vested and 40%, 60%, 80%, and 100% each year thereafter. The Plan shall not recognize service with another employer for purposes of vesting.

5. *Payment of Benefits*

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump-sum. Partial withdrawals or installments are only permitted for participants or beneficiaries who must receive required minimum distributions under Internal Revenue Code section 401(a)(9).

6. *Forfeited Accounts*

Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions or pay Plan administrative expenses. In 2024 and 2023, employer contributions were not reduced by forfeitures. At June 30, 2024 and 2023, there were outstanding forfeited accounts of \$8,894 and \$3,716, respectively.

7. *Profit Sharing*

The Plan permits eligible employees to participate in profit sharing after the completion of one year of service and are twenty-one years of age. Entry date is the first day of the Plan year or the first day of the month coinciding with the date requirements are satisfied.

8. *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bears interest at the Prime Rate Plus 1%. Principal and interest are paid through a payroll deduction agreement with the Corporation.

NOTE B | SUMMARY OF ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

1. Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

2. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

3. Valuation of Investments and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The unallocated insurance contract is valued at contract value as estimated by Voya Financial. Contract value represents contributions made under the contract, plus interest at the contract rate, less withdrawals and administrative expenses. At June 30, 2024 and 2023 fair value approximated contract value and no adjustment was needed on the statements of net assets available for benefits.

4. Payment of Benefits

Benefits are recorded when paid.

5. Plan Expenses

Certain general plan expenses of maintaining the Plan are deducted from the forfeitures or paid directly by the Corporation. There are certain other basis points and flat fees which are charged directly to the participants' accounts.

NOTE B | SUMMARY OF ACCOUNTING POLICIES

6. *Notes Receivable from Participants*

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes to participants are recorded as distributions based upon the terms of the plan agreement.

7. *Subsequent Events*

The Plan's management has evaluated subsequent events for recognition and disclosure in the financial statements through April 10, 2025, which is the date the financial statements were available to be issued.

NOTE C | FAIR VALUE MEASUREMENTS

The Plan follows the fair value measurement guidance for financial assets and financial liabilities. The guidance defines fair value, establishes a framework for measuring value and expands disclosure about fair value measurements. In addition, the guidance permits an entity to measure eligible financial instruments and other items at fair value. The Plan has not made any fair value elections.

Fair value is defined to be the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A three-level hierarchy has been established for fair value measurements based upon the inputs to the valuation of an assets or liability as follows:

- Level 1 Valuation is based on quoted prices for identical assets and liabilities in active markets.
- Level 2 Valuation is derived from inputs, other than quoted prices included in Level 1, which are observable for the asset or liability either directly or indirectly. Investments classified as Level 2 are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. The significant inputs used in this approach include interest rates, prepayment timing, yield spreads, maturities, credit losses and credit ratings of the securities.
- Level 3 Valuation is derived from unobservable inputs that are not corroborated by market data.

Following is a description of the valuation methodology used for assets measured at fair value.

NOTE C | FAIR VALUE MEASUREMENTS

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE D | GUARANTEED INSURANCE CONTRACT WITH INSURANCE COMPANY

For purposes of investing Plan contributions, the Plan entered into a fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company. The contributions are maintained in an unallocated general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value which approximates fair value. Therefore, no adjustment is needed on the statement of net assets available for benefits to arrive at contract value. Contract value, as reported to the Plan by Voya Retirement Insurance and Annuity Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE D | GUARANTEED INSURANCE CONTRACT WITH INSURANCE COMPANY

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at June 30, 2024 and 2023 was \$811,735 and \$545,853, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with the contract issuers. Such events include the following: (a) amendments to the Plan's documents, (b) changes to the Plan's investment options, (c) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The investment contract may be terminated by either party with stipulations that the contract value be paid out using various options.

NOTE E | PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE F | TAX STATUS

The Company adopted a non-standardized pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating the pre-approved plan document was in compliance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

NOTE H | PARTY IN INTEREST TRANSACTIONS

The plan invests in mutual funds and a deposit administration stable asset insurance contract managed by Voya Institutional Trust Company, the trustee and provides third party administration and recordkeeping services to the plan. Voya Institutional Trust Company receives fees for these services. These transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules.

NOTE I | RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will continue to occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.
