**NOTE 1: DESCRIPTION OF PLAN**

The following description of Northeast PA Center for Independent Living Surplus Sharing Pension Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a profit sharing/403(b) plan covering all employees of Northeast PA Center for Independent Living (the "Plan Sponsor") who have attained the age of twenty-one. Employees are eligible to start elective deferrals on date of hire. Employees become eligible for profit sharing contributions on the first day of the month after completing six months of service. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Administrators are responsible for oversight of the Plan.

**Contributions**

Employees may elect to contribute, subject to defined limitations, any percentage of their base salary to the Plan pursuant to Section 403(b) of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Auto enrollment starts at 1% of compensation and increases by 1% per year up to a maximum of 6% of compensation. Contributions for auto enrolled participants are invested in a designated balanced fund until changed by the participant. For the years ended June 30, 2024 and 2023, the Plan Sponsor matched 1% for every 1% contributed by a participant up to 6%. Matching contributions for the years ended June 30, 2024 and 2023 were \$392,418 and \$370,711, respectively.

The Plan Sponsor may also make a discretionary profit sharing contribution to the Plan which is based on results of the fiscal year and paid in to the Plan for employees who are eligible as of June 30. There were no discretionary profit sharing contributions for the years ended June 30, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution as well as the Plan Sponsor's matching and profit sharing contributions, and plan earnings and charged with plan losses and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

For the years ended June 30, 2024 and 2023, cumulative forfeited nonvested accounts of \$5,293 and \$11,866, respectively, were used to reduce administrative expenses by \$6,816 and \$11,400, respectively.

Notes Receivable from Participants

The Plan does not permit participants to borrow from their accounts.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's profit sharing portion of their account is based on years of continuous service. A participant is 100% vested after three years of credited service, as follows:

Payment of Benefits

The Plan provides for separation from service, normal retirement, death and disability benefits. The beneficiary is entitled to the vested account balance upon death of the participant. If the participant becomes disabled while an employee, the participant becomes 100% vested in all of their accounts under the Plan. Benefits are payable in lump sums or installments.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting and are presented in the format prescribed by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Sponsor to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair-value. Fair-value is the amount that would be received from the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair-value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Administrative expenses of the Plan are offset by forfeitures or allocated among the participant's accounts.

**Subsequent Events**

Subsequent events were evaluated through April 1, 2025, which is the date the financial statements were available to be issued.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair-value of certain financial instruments could result in a different fair-value at the reporting date.

NOTE 4: FAIR-VALUE MEASUREMENTS (CONT'D)

The fair-value measurement accounting literature establishes a fair-value hierarchy that prioritizes the inputs to valuation techniques used to measure fair-value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair-value of its investments. When available, the Plan measures fair-value using Level 1 inputs because they generally provide the most reliable evidence of fair-value. Level 3 inputs are used only when Level 1 or Level 2 inputs were not available. As of June 30, 2024 and 2023, none of the Plan's investments are measured using Level 2 or Level 3 inputs.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended June 30, 2024 and 2023, are reported in net investment gain on registered investment company shares.

Following is a description of the valuation methodology used for assets measured at fair-value.

Mutual Funds

Share price reported for mutual funds are generally obtained from a file feed from the National Securities Clearing Corporation and/or directly from the issuer.

Insurance Company General Account

Share prices reported for the insurance company general account are obtained directly from the issuer.

NOTE 5: TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed the Plan Sponsor by a letter dated May 5, 2015, that the Plan and related trust are designed to qualify under section 403(b) of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits in progress for any tax periods.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, no further contributions will be made to the plan and all accounts will become 100% vested.

NOTE 7: RECONCILIATION OF FINANCIAL STATEMENTS TO IRS FORM 5500

No differences exist between the amounts reported in the accompanying financial statements and the IRS Form 5500.

**NOTE 8: PARTY-IN-INTEREST**

The Plan's investments include a stable value mutual fund managed by the Standard Insurance Company, the trustee as defined by the Plan, and a small cap index mutual fund managed by Charles Schwab, the custodian of the plan assets; therefore, these transactions qualify as party-in-interest. The stable value mutual fund charged administrative expenses to the Plan of \$11,904 and \$13,466, for the years ended June 30, 2024 and 2023, respectively, and the small cap index fund charged administrative expenses to the Plan of \$1,016 and \$628, for the years ended June 30, 2024 and 2023, respectively.

**NOTE 9: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10: SUBSEQUENT EVENT**

On July 1, 2024, the Plan changed the trustee to Lincoln Financial Trust Company and the custodian of the plan assets to Merrill Lynch.
