#### ***Opinion***

Employees Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

NOTE 1 Plan description

The following brief description of the Leeward Construction, Inc. Employees Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a profit-sharing plan established for substantially all employees of Leeward Construction, Inc. (the Company or employer). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees and administrator of the Plan are responsible for oversight of the Plan, determining the appropriateness of the Plan's investments and monitoring investment performance.

Eligibility

All employees who complete 30 days of employment and have attained age 20 are eligible to enter the Plan. However, employees who are subject to the Davis Bacon Act or similar federal, state, county or local acts, statutes or laws are eligible to enter the Plan upon an initial hour of employment.

A participant must have worked 500 hours from their hire date in order to receive a prevailing wage contribution, unless employment ended due to retirement, disability or death.

Non-prevailing wage employer retirement contributions are earned and allocated to Plan participants on the last day of the Plan year. A participant must have worked 1,000 hours during the Plan year and be employed on the last day of the Plan year in order to receive a contribution, unless employment ended due to retirement, disability, or death.

Contributions

The employer will contribute all amounts required under government contracts, whether federal, state, county or local, subject to the Davis Bacon Act or similar federal, state, county or local acts, statutes or laws. For Federal Davis Bacon Act and PA State Wage contracts, the employer contributes the total fringe required by each individual contract, net of allowable deductions for employer-paid health and welfare benefits for participants, as a retirement contribution.

Beginning in 2020, participants not covered under the Davis Bacon Act or similar acts, statutes or laws, the contribution for owners and project managers shall be set at \$4.00 per hour worked; the contribution for foremen shall be set at \$3.00 per hour worked; the contribution for supervisor, step II foremen, salaried office personnel, and technicians shall be set at \$2.00 per hour worked; \$1.00 per hour worked for truck driver and for all other office and maintenance personnel and \$1.00 per hour worked for all field workers.

Participant accounts

Each participant's account is credited with the participant's rollovers and the Company's contribution, as well as allocations of forfeitures of terminated participants' non-vested account balances, if available, and Plan earnings and charged with an allocation of Plan expenses paid by the Plan as reduced by forfeitures of terminated participants and Plan losses. Allocations are

based on participant account balances or earnings, as applicable.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100 percent vested in their rollovers plus earnings thereon. Vesting in the remainder of their account balances is based on the following:

Forfeitures

Forfeitures are retained in the Plan and may be used to reduce Plan administrative expenses. Any remaining forfeitures may be allocated to all participants eligible to share in the allocations

in the same proportion that each participant's compensation for the Plan year bears to the compensation of all participants for such year. At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$52,048 and \$50,852, respectively. Forfeitures used to reduce Plan administrative expenses totaled \$50,852 for 2024.

Payment of benefits

Generally, vested benefit payments are distributed following the participant retiring, disability, death, terminating employment with the Company, or at a participant's request upon attaining age 65 with 5 years of credited service. Benefit distributions are made in lump sums or annuities over the life of the participant or over the lives of the participant and spouse.

**NOTE 2** Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the custodian of the Plan. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on the trade-date basis. Dividends are recorded on the ex-dividend date and interest is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Nonparticipant-directed investments

All investment decisions are at the direction of the Plan Trustees and the Plan Investment Advisor.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Participant benefits

These benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Currently certain administration fees, including custodial and investment fees, investment advisory and management fees, professional fees for audit services, and third-party administrator fees are borne by the Plan. Investment related expenses are included in net appreciation of fair value of investments.

SECURE 2.0 Act

The Consolidated Appropriations Act (CAA), including the SECURE 2.0 Act, was signed into law on December 29, 2022. SECURE 2.0 builds on changes made by the SECURE Act of 2019 and the Plan document has been amended for the provisions required to be effective in the year ending June 30, 2024 and will be amended in accordance with the required timeline of the act to meet the applicable provisions effective after June 30, 2024.

NOTE 3 Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Gains and losses included in changes in net assets available for benefits for the year ended June 30, 2024, are reported in net appreciation in the fair value of investments.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023:

*Common stocks:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual and exchange traded funds (ETF):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and ETF's held by the Plan are deemed to be actively traded.

*U.S. government securities:* Valued using pricing models maximizing the use of observable inputs for similar securities.

*Certificates of Deposit:* Valued at amortized cost, which approximates fair value given the instruments' short duration.

*Interest bearing cash (money market):* Valued at principal value.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

the investment services amounted to \$96,775 for the year ended June 30, 2024. These transactions qualify as party-in-interest. The custodian provides certain administrative services to the Plan pursuant to a service agreement between the Company and the custodian. The

custodian receives revenue from service providers for services the custodian provides to the investments. This revenue is used to offset certain amounts that would be owed to the custodian from the Plan for its administrative services to the Plan had arrangements with the service providers not been in place. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 6**    Tax status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
