Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the 401(k) Profit-Sharing Plan for Employees of INcompass Healthcare (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of 401(k) Profit-Sharing Plan for Employees of INcompass Healthcare (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Community Mental Health Center, Inc. d/b/a INcompass Healthcare (the Plan Sponsor). Under the terms of the Plan, employees are eligible to participate in the Plan after completion of four months of employment, as defined by the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions and Funding Policy

The Plan Sponsor contributes a fixed percentage match of 100% of participant deferrals up to 4.5% of compensation.

Participants may authorize deferral contributions for a maximum allowed by regulations. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and insurance investment contracts as investment options for participants.

Participant contributions are permitted up to a percentage of the employees' gross wages with an annual limitation. Amounts forfeited by terminated participants are used immediately to reduce the total amount the Plan Sponsor contributes to the Plan. In the event a plan participant is re-employed prior to incurring five consecutive one-year breaks in service, the Plan Sponsor would be responsible for contributing back to the Plan the previously forfeited amount.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution, allocations of the Plan Sponsor's contribution and plan earnings (net of certain fund management expenses).

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts plus actual earnings thereon is based on years of continuous services.

A participant is 100 percent vested after three years of credited service. Once obtaining 55 years of age, the participant automatically becomes 100% vested in the Plan Sponsor's contribution portion of their accounts. The following represents the vesting schedule:

Less than 3 years	0%
3 or more years	100%

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance, whichever is less. Loan terms shall not exceed 5 years except in the case of the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined quarterly by the Plan administrator, which was between 4.25% and 9.25% as of June 30, 2024 and 2023. Principal and interest are paid ratably through monthly payroll deductions or as a lump sum. The individual loan balances range from approximately \$300 to \$9,300. The loans are due through 2028.

Payment of Benefits

In general, on termination of service a participant may elect to receive their vested interest in the form of a lump-sum amount, an account rollover, an annuity or leave the account in the Plan, subject to certain limitations and conditions as defined by the Plan.

Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or leave the remainder of the account in the Plan. Participants must take the lump-sum distribution if the account has less than \$1,000 upon the date of termination.

Compensation

Participant compensation is defined by the Plan as wages, tips and other compensation reported on the Federal Form W-2, Wage and Tax Statement, excluding reimbursements, expense allowances, fringe and welfare benefits, moving expenses and certain deferred compensation.

Forfeited Accounts

On termination of service, a participant who is not 100% vested will forfeit the portion of his or her account balance which is not vested. All forfeitures are used to reduce the Plan Sponsor's contribution. Forfeited nonvested accounts totaled approximately \$-0- and \$10,600 as of June 30, 2024 and 2023, respectively. During 2024, the Plan used forfeitures of approximately \$25,400 to offset Plan Sponsor contributions.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except the interest accumulation fund, which is recorded at contract value, which approximates fair value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Each individual investment offered to the participants has varying investment objectives. Participants should refer to the trustee for a more complete description of the investment objectives.

Concentration of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk are part of the holdings in the Plan's investments. Management believes that the trustee maintains the Plan's investments with high quality institutions and attempts to limit the credit exposure to any particular investment.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan Sponsor provides certain administrative and accounting services to the Plan at no cost. Most administrative expenses are paid directly by the Plan Sponsor and generally include audit fees and legal fees. Administrative expenses incurred by the Plan typically include fees charged directly to the participants' accounts.

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is April 9, 2025.

Reclassifications

Certain amounts in the 2022 financial statements have been reclassified to conform to the current year presentation. These reclassifications had no impact on the previously reported net assets available for benefits or the change in net assets available for benefits.

3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, the schedule of assets at June 30, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended June 30, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). However, in accordance with Subtopic 820-10, the pooled separate account investments that are measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

The description of the valuation methodologies used for assets measured at fair value are included in Note 2. There have been no changes in the methodologies used as of June 30, 2024 and 2023.

5. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Plan Sponsor and certain others.

Transactions with parties-in-interest include administrative fees paid to the Plan's trustee, Mutual of America Life Insurance Company. Additionally, the Plan held party-in-interest investments with the trustee as of June 30, 2024 and 2023. Blue & Co., LLC is the independent auditor for the Plan and receives payment for their services.

JUNE 30, 2024 AND 2023

The Plan Sponsor pays the majority of expenses of the Plan, including administrative and accounting fees. These expenses qualify as party-in-interest transactions. Notes receivable from participants are payable to the trustee and qualify as party-in interest transactions.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. INCOME TAX STATUS

The IRS has determined by a letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and that the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
