Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lake Shore Systems, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Notes to Financial Statements

1. Description of Plan

The following description of Lake Shore Systems, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC), sponsored by Lake Shore Systems, Inc. (the Employer or Company). The Plan covers all eligible employees who are at least 18 years of age. Employees must complete at least 250 hours of service during the first three months of employment or complete a year of service (at least 1,000 hours of service) to become eligible. An employee may become a participant in the Plan the day on which the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Merger

Effective July 15, 2024, the Plan merged into the Trident Maritime Systems Retirement Savings Plan (the Trident Maritime Plan). The net assets of the Plan totaling \$29,893,486 were transferred, which included \$535,773 of outstanding notes receivable from participants. Employees were able to begin contributing to the Trident Maritime Plan effective July 15, 2024.

Trustee and Administration of the Plan

The trustee of the Plan is Matrix Trust Company and the recordkeeper of the Plan is OneAmerica Retirement Services, LLC. The administrator of the Plan is the Company. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Plan Administrative Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Participants may elect to contribute up to 85% of their eligible compensation (participant contributions), not to exceed IRC limitations. Participants can change their elected contribution percentage at any time. The Plan permits eligible participants to make "catch-up" contributions each year starting the year the participant attains age 50. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

In addition, the Employer may make discretionary matching contributions. For the period ended July 15, 2024, the Employer authorized matching contributions of 50% of the first 6% of participants' contributions. Additional discretionary profit-sharing contributions may be contributed with the approval of the Company's Board of Directors. In order for an employee to receive the profit-sharing contributions, the employee must be employed by the Employer on the last day of the Plan year and complete at least 1,000 hours of service during the Plan year. There were no profit-sharing contributions made for the period ended July 15, 2024.

Eligible employees are automatically enrolled into the Plan unless the participant makes a contrary salary reduction agreement election. For those employees automatically enrolled, a salary reduction amount of 3% is made from their compensation, as defined in the Plan Document, and contributed to the Plan. This salary reduction amount is automatically increased by 1% each year until a maximum of 6% is reached. The accounts of participants who do not make specific elections are automatically invested in the Vanguard Target Retirement Fund that corresponds with the participant's retirement at age 65. The Plan's automatic enrollment provisions will not carry over to the Trident Maritime Plan.

Participants may elect to invest their account balances, consisting of participant contributions, rollover contributions, matching contributions, and profit-sharing contributions, into various fund options offered by the Plan. Participants have the opportunity to change their investments and contribution mix daily. Participants may also invest their account balances into self-directed brokerage accounts.

Each participant's account is credited with the participant's and Employer's contributions, as well as an allocation of profit-sharing and Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances or participant eligible compensation, as defined in the Plan Document. The maximum benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants who leave the Plan because of death, normal retirement, or disability, as defined in the Plan Document, are considered 100% vested.

Employer matching and profit-sharing contributions and earnings thereon vest in accordance with provisions of the Plan as follows:

Forfeitures

Forfeitures of terminated participants' non-vested accounts may be used to pay permissible Plan expenses in accordance with the rules under ERISA, and any excess may be allocated as additional Employer contributions or applied as a reduction to other Employer contributions under the Plan. Forfeitures occur in any Plan year in which a terminated participant receives the portion of the matching contributions credited to his or her account that has vested in accordance with the Plan's vesting schedule and forfeits the non-vested balance. If a terminated participant resumes employment with the Employer within five years subsequent to the termination date and repays the

total amount of the previous distribution back to the Plan, the forfeited amount will be restored to their account. Forfeited non-vested account balances as of July 15, 2024 and December 31, 2023 were \$0 and \$13,092, respectively. Forfeitures used to pay Plan expenses or reduce Employer matching contributions during the period ended July 15, 2024 were \$29,004.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to 15 years for the purchase of a primary residence. These loans are secured by the balance in the participant's account. The loans bear interest rates which are commensurate with local prevailing rates as determined regularly by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

Also, each participant may not have more than one loan outstanding at any time.

Payment of Benefits

Benefits paid to participants represent amounts paid to participants upon termination of employment during the year, or in prior years, and for qualified hardship cases. Participants may also elect to receive distributions upon reaching age 59½. If a terminating participant's account balance does not exceed \$5,000, the Plan will distribute the benefit in a lump sum as soon as administratively feasible following the event that entitles the participant to a distribution. Benefit payments exceeding \$5,000 are paid in lump sum at the participant's discretion, but at no date later than the April 1 following the end of the calendar year in which the participant attains age 70½.

Administrative Expenses

Expenses incurred in the administration of the Plan shall be paid from the Plan; however, the Employer may elect to pay expenses directly. In addition, the Employer may, on a uniform basis, charge certain reasonable Plan administrative expenses to the accounts of participants who utilize the service(s) attributable to the expense. Certain administrative functions are performed by officers or employees of the Employer; no such officer or employee receives compensation from the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP), except for benefits which are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts

of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuations and Income Recognition

Investments of the Plan are reported at fair value in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustees. See Note 4 for discussion of fair value measurements.

Net appreciation of investments included in the accompanying statement of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation in the fair value of investments. Net unrealized appreciation or depreciation in the fair value of investments represents the net change in the fair value of the investments held during the period. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value of the investment as of the beginning of the period, or the cost of investment if purchased during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus unpaid accrued interest. There were no notes receivable from participants as of July 15, 2024, as a result of the Plan's merger with the Trident Maritime Plan. No allowance for credit losses has been recorded as of July 15, 2024 or December 31, 2023. According to the Plan, notes receivable from participants are collectible upon termination and any portion of the notes receivable from participants that are not collected is deemed to have defaulted. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits. During the period ended July 15, 2024, there were \$7,675 of deemed distributions recorded.

Payment of Benefits

Benefits are recorded upon distribution to participants.

At the request of the Plan Administrator, the Plan's independent accountants did not perform auditing procedures on the above information, except for comparing such information included in the accompanying financial statements.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at July 15, 2024 or December 31, 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

The money market fund is valued using the amortized cost or penny-rounding method as permitted by Rule 2a-7 under the Investment Company Act of 1940, which approximates its fair value. While the majority of the underlying asset values are based on quoted prices, the net asset value (NAV) of the money market fund is not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices. The money market fund provides for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts primarily consist of publicly traded common stock. These investments are self-directed by the participant and are not offered through the Plan. The fair value of these investments is determined by reference to the fair value of the underlying security of the common stock. The fair value of the common stock shares is quoted on the exchange where the security is actively traded and therefore classified as Level 1 within the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value at December 31, 2023. There were no investments at July 15, 2024, as a result of the Plan's merger with the Trident Maritime Plan.

5. Income Tax Status

The Plan uses a pre-approved plan document sponsored by OneAmerica Retirement Services, LLC. OneAmerica Retirement Services, LLC received an opinion letter from the Internal Revenue Service (IRS), dated September 24, 2015, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of July 15, 2024 and December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

6. Parties-in-Interest

Fees incurred for recordkeeping services are paid by the Plan, which amounted to \$37,902 for the period ended July 15, 2024.

The Plan issues notes receivable from participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

7. Risk and Uncertainties

The Plan held various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

8. Subsequent Events

The Plan has evaluated subsequent events through April 1, 2025, the date the financial statements were available to be issued.
