As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from American United Life Insurance and Variable Annuity Life Insurance Organization as of June 30, 2024 and 2023, and for the years then ended, and Ascensus, LLC as of June 30, 2024, and for the period from May 1, 2024, through June 30, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

### Notes to Financial Statements

#### 1. Description of Plan:

The following description of the St. Joseph's Villa 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all eligible employees of St. Joseph's Villa (the "Organization"). Employees are eligible to participate upon hire and become eligible to receive employer matching contributions after completing one year of service, during which they have completed at least 1,000 hours of service and attaining age 21. Employees begin receiving matching contributions on the first of the quarter following the date they become eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** The Plan provides for participant contributions of pre-tax annual compensation, as defined in the Plan. The Organization provides a discretionary contribution based on the participant's compensation. The Organization matches 100% of participant contributions, subject to a limit of 5% of the participant's compensation. Participants of qualifying age may make additional "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations.

**Participant Accounts:** Each participant's account is credited with the participant's contributions and allocations of (a) the Organization's contributions and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Investment Options:** Participants may direct the custodians of the Plan as to the investment of their account balances in accordance with guidelines established by the Plan.

**Vesting:** Participants are immediately vested in their contributions and the Organization's contributions, plus actual earnings thereon.

### Notes to Financial Statements, Continued

#### 1. Description of Plan, Continued:

**Notes Receivable from Participants:** Participants may borrow from their Plan accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms cannot exceed five years, unless the proceeds are used to acquire a principal residence. The loans are secured by the balance in the participant's account and bear interest at 4.25%, which is commensurate with local prevailing rates as determined by the Variable Annuity Life Insurance Organization ("VALIC") and the American United Life Insurance Organization ("AUL"). Principal and interest on loans from VALIC were paid directly to VALIC by the participant. Principal and interest on loans from AUL were paid ratably through payroll deductions and remitted to AUL by the Organization. Subsequent to the change in custodians, principal and interest on loans were paid ratably through payroll deductions and remitted to Ascensus, LLC ("Ascensus") by the Organization. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants deemed to be in default by Plan administration are reclassified as distributions based upon the terms of the Plan document.

**Plan Administration:** Overall responsibility for administering the Plan rests with the Organization. Participants' accounts are administered by either VALIC, AUL, or Ascensus, the custodians. Effective May 1, 2024, most of those accounts administered by AUL were transitioned to Ascensus. Three Organization employees serve as the trustees and are not compensated for these services.

**Excess Contribution Liability:** Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions.

**Payment of Benefits:** Distribution of the portion of a participant's account will occur upon the participant's termination of service, death, disability, retirement, or hardship withdrawal, as defined in the Plan. Participants are entitled to receive a lump-sum, installment or annuity payments in amounts equal to the value of their account.

#### 2. Summary of Significant Accounting Policies:

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual method of accounting.

### Notes to Financial Statements, Continued

#### 2. Summary of Significant Accounting Policies, Continued:

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment gain (loss) includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits:** Benefits are recorded when paid.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent Events:** Management has evaluated subsequent events through April 9, 2025, the date the financial statements were available to be issued, and has determined that there are no subsequent events to be reported in the accompanying financial statements.

#### 3. Stable Value Fund:

The stable value fund (the "Fund") is sponsored by AUL. The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the Fund's NAV, which is based on the market value of its underlying investments. Distribution to the Fund's unit holders is declared daily from the net investment income and automatically reinvested in the Fund on a monthly basis, when paid.

Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the Fund, plus earnings, less participant withdrawals and administrative expenses. The Fund imposes certain restrictions on the Plan, and the Fund itself may be subject to circumstances that impact its ability to transact at contract value, as described in the following paragraphs. Plan management believes that the occurrence of events that would cause the Fund to transact at less than contract value is not probable.

### Notes to Financial Statements, Continued

#### 3. Stable Value Fund, Continued:

##### *Restrictions on the Plan*

Participant-initiated transactions are those transactions allowed by the Plan, including withdrawals for benefits, loans, or transfers to competing funds with a plan, but excluding withdrawals that are deemed to be caused by the actions of the Plan Sponsor. The following employer-initiated events may limit the ability of the Fund to transact at contract value:

- A failure of the Plan or its trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA.
- Any communication given to Plan participants designed to influence a participant not to invest in the Fund or to transfer assets out of the Fund.
- Any transfer of assets from the Fund directly into a competing investment option without meeting the equity wash provisions.
- Plan Sponsor withdrawals without the appropriate notice to the Fund and/or issuer.
- The establishment of a defined contribution plan that competes with the Plan for employee contributions.
- Complete or partial termination of the Plan or its merger with another plan.
- Implementation of an early retirement program.

##### *Circumstances that Impact the Fund*

The Fund invest in assets, typically fixed income securities or bond funds, and enters into “wrapper” contracts issued by third parties. A wrapper contract is an agreement by another party, such as a bank or insurance company to make payments to the Fund in certain circumstances. Wrapper contracts are designed to allow a stable value portfolio to maintain a constant NAV and protect a portfolio in extreme circumstances. In a typical wrapper contract, the wrapper issuer agrees to pay the difference between the contract value and the market value of the underlying assets if the market value falls below the contract value.

The wrapper contracts generally contain provisions that limit the ability of the Fund to transact at contract value upon the occurrence of certain events. These events include:

- Any substantive modifications of the Fund or the administration of the Fund that is not consented to by the wrapper issuer.
- Any change in law, regulation, or administrative ruling applicable to a plan that could have a material adverse effect on the Fund's cash flow.
- Employer-initiated transactions by participant plans as described above.

### Notes to Financial Statements, Continued

#### 3. **Stable Value Fund, Continued:**

In the event that wrapper contracts fail to perform as intended, the Fund's NAV may decline if the market value of its assets decline. The Fund's ability to receive amounts due pursuant to these wrapper contracts is dependent on the third-party issuer's ability to meet their financial obligations. The wrapper issuer's ability to meet its contractual obligations under the wrapper contracts may be affected by future economic and regulatory developments.

The Fund is unlikely to maintain a stable NAV if, for any reason, it cannot obtain or maintain wrapper contracts covering all of its underlying assets. This could result from the Fund's inability to promptly find a replacement wrapper contract following termination of a wrapper contract. Wrapper contracts are not transferable and have no trading market. There are a limited number of wrapper issuers. The Fund may lose the benefit of a wrapper contract on any portion of its assets in default in excess of a certain percentage of portfolio assets.

#### 4. **Fair Value Measurements:**

The Financial Accounting Standards Board ("FASB") has issued guidance for measurement and disclosure of fair value and established a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology are quoted prices for similar instruments in active and inactive markets; and model driven valuations with significant inputs and drivers derived from observable active markets.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Fixed income annuity contracts:** Unit value calculated based on the net assets or observable NAV of the underlying pool of securities or investments.

**4. Fair Value Measurements, Continued:**

**Stable value fund:** Valued at the NAV of shares held by the Plan at year-end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Related-Party Transactions:

The Plan invests in funds managed by the custodians. These are related-party transactions and are identified as a parties-in-interest in the accompanying schedule of assets held at end of year. The Plan paid administrative expenses to the custodians totaling \$2,245 during 2024 and \$912 during 2023.

#### 6. Plan Termination:

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

#### 7. Tax Status:

The IRS does not currently intend to establish a determination letter program for individually designed 403(b) plans. Therefore, the Plan has not received a determination letter from the IRS stating that the Plan is qualified under Section 403(b) of the Internal Revenue Code ("IRC"). The Plan administrator believes the plan is designed and operated in accordance with IRC Section 403(b) and ERISA.

#### 7. Tax Status, Continued:

Management has evaluated the effect of FASB guidance surrounding uncertain income tax positions and concluded that the Plan has no significant financial statement exposure to uncertain income tax positions at June 30, 2024 and 2023. The Plan is not currently under audit by any tax jurisdiction.

#### 8. Risk and Uncertainties:

Investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the financial statements.

#### 9. Financial Information Certified by the Custodians:

AUL and VALIC, custodians of the Plan, as of June 30, 2024 and 2023, and the years then ended, and Ascensus, custodian of the Plan, as of June 30, 2024 and for the period from May 1, 2024, through June 30, 2024, have certified that the following information is complete and accurate:

- Investments, at fair value;
- Investment income (loss);
- Schedule of assets (held at end of year);
- Notes receivable from participants; and
- Interest income on notes receivable from participants.
