Report of Independent Auditors

Opinion

We have audited the financial statements of IBEW Local 134-NECA Vacation Savings Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of IBEW Local 134-NECA Vacation Savings Fund as of June 30, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Notes to Financial Statements

June 30, 2024 and 2023

Note 1. Description of the Plan

IBEW Local 134-NECA Vacation Savings Fund (the Plan) was established in June 2016, as a result of a collective bargaining agreement between Electrical Contractors Association of the City of Chicago (the Contractors Association) and Local Union 134, International Brotherhood of Electrical Workers (the Local) to provide vacation savings benefits for eligible participants. The Plan is a multiemployer defined contribution welfare (vacation savings) plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by a joint board of trustees consisting of an equal number of representatives from the Contractors Association and the Local.

Contributions are credited to participants' accounts and are fully vested at all times once a participant opens an account at Great Lakes Credit Union (GLCU). Under the current provisions of the Plan, participants' accounts that remain unclaimed by not opening an account at GLCU for a length of two years are considered to be forfeited. Forfeitures may be used to pay the administrative expenses of the Plan. Participants' accounts may be re-credited at the Trustees' discretion as allowed by the Plan. For the years ended June 30, 2024 and 2023, forfeitures totaled \$55,095 and \$45,171 respectively. Amounts restored during the years ended June 30, 2024 and 2023 totaled \$1 and \$9,778 respectively. At June 30, 2024 and 2023, a total of \$78,157 and \$47,031 respectively, of forfeited accounts were available to pay administrative costs.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. No earnings are allocated to the participants' accounts.

Benefit payments to participants represent transfers to accounts held in the name of the participant at GLCU. Benefit distributions are therefore made without delay once contributions are received, provided that an account has been established at GLCU.

Participants should refer to the summary plan description for more complete information.

Note 2. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting.

New Accounting Pronouncement - In June 2016, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update (ASU) No. 2016-13 *Financial Instruments - Credit Losses* (Topic 326), which is effective for the Plan for the year ended June 30, 2024. This new standard provides financial statement users with more decision-useful information about the expected credit losses on financial instruments and other commitments to extend credit held by a reporting entity at each reporting date. The standard replaced the incurred loss impairment model with a methodology that reflects expected credit losses and requires consideration of a broader range of reasonable and supportable information to inform credit loss estimates. The standard had no material impact on the Plan's financial statements.

Contributions Receivable - Contributions due and not paid prior to year end are recorded as contributions receivable. Contributions due as determined by payroll compliance audits are recorded upon settlement with the employer. An allowance for uncollectable accounts is considered unnecessary and is not provided.

Revenue Recognition - Revenue derived from employer contributions is recognized in the period in which covered work is performed, based on the number of hours worked in covered employment and the contribution rate currently in effect, as set forth in the applicable collective bargaining agreement. Employers are required to remit contributions monthly. The Plan carries out its purpose described in Note 1 within a jurisdiction primarily located in Cook County, Illinois.

Payment of Benefits - Benefits made to or on behalf of participants are recorded upon transfer to the participant's individual account at GLCU. There were no participant distributions approved for payment that were not yet paid at either June 30, 2024 or 2023.

Administrative Expenses - Certain administrative expenses not paid by the Plan may be paid by the Local or IBEW 134/NECA Chicago Labor Management Cooperation Committee (LMCC).

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through March 7, 2025, which is the date the financial statements were available to be issued.

Note 3. Priorities upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, the right to discontinue the Plan is reserved to the Trustees. Termination shall not permit any part of the Plan assets to be used for or diverted to purposes other than the exclusive benefit of the participants. In the event of termination, the net assets of the Plan will be allocated to pay benefits in priorities as prescribed by ERISA and its related regulations. Whether or not a particular participant will receive full benefits should the Plan terminate at some future time will depend on the sufficiency of the Plan's net assets at that time and the priority of those benefits.

Note 4. Tax Status

The Plan's notice of exemption from the Internal Revenue Service dated March 16, 2018, stated that the trust established under the Plan meets the requirements under the provisions of Section 501(c)(9) of the Internal Revenue Code. The Plan's Trustees and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Funding Policy

The Plan is primarily funded by employer contributions as specified in the collective bargaining agreements. The hourly contribution rate for the majority of participants covered under the Plan ranged from \$1.25 to \$1.50 during the years ended June 30, 2024 and 2023.

Note 6. Related Organizations

The Plan is related to various organizations including the Local, the Electrical Insurance Trustees benefit plans, the Contractors Association, the LMCC and an apprenticeship training fund, all of which are tax-exempt. During the years ended June 30, 2024 and 2023, the LMCC paid approximately \$38,300 and \$37,000 respectively, in administrative expenses on behalf of the Plan. Additionally, the Local pays the salary for a shared employee without reimbursement.

Note 7. Concentration of Cash

Cash includes amounts on deposit at a financial institution deemed to be creditworthy. Balances are insured by the FDIC up to \$250,000. Balances may at times exceed federally insured limits. The Plan believes its credit risk to be minimal.

Note 8. Department of Labor Investigation

The Department of Labor (DOL) is currently conducting an investigation of the Plan for the general purpose of determining compliance with the provisions of Title I of ERISA. The Plan has provided the DOL all requested information. The Plan's Trustees and the Plan's legal counsel believe that the investigation is routine in nature and will not affect the operations or financial condition of the Plan.
