Opinion

We have audited the financial statements of Baker & McKenzie (New York) Profit Sharing and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes (collectively referred to as the “financial statements”).

Notes to Financial Statements

June 30, 2024

1. Description of the Plan

The following description of Baker & McKenzie (New York) Profit Sharing and 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Baker & McKenzie LLP (the Firm) and affiliated employers electing to participate in the Plan who have completed one hour of service. Employees must also be U.S. citizens or permanent residents or have an H1-B, E-2 or E-3 visa or an Employment Authorization Document obtained in connection with an application to adjust to permanent resident status and be employed in the Firm's New York office to be eligible. Employees with a TN or NAFTA visa are eligible to participate in the Plan. Participants are not eligible for the Firm's matching contributions and profit-sharing contributions until they have completed one year of service. Additionally, attorneys (other than principals) who have completed less than 12 years of practice following admission to practice law are not eligible for the Firm's matching and profit-sharing contributions. Those staff (employees with annual compensation less than \$330,000 and \$305,000 in plan years 2024 and 2023, respectively), whose last names begin with the letters A through L are not eligible for profit-sharing contributions under the Plan but are eligible under the profit-sharing feature of the Baker & McKenzie (New York) Profit Sharing Plan II. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Effective June 29, 2023, the Plan was amended to allow employees who are Deferred Action for Childhood Arrivals (DACA) program recipients, with a valid Employment Authorization Document, to participate in the Plan.

Contributions

Each year, participants may contribute up to 60% of pretax annual compensation, as defined in the Plan. Participants can also make Roth contributions. Participants may also contribute amounts representing eligible rollover distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. The Firm contributes 50% of the first 5% of compensation that an eligible participant contributes to the Plan, up to a maximum of \$8,250 and \$7,625 in plan years 2024 and 2023, respectively.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Profit-sharing contributions under the Plan are mandatory for principals who are U.S. citizens or principals who have permanent resident status in the U.S. For principals, senior staff and qualified non-principals, profit-sharing contributions are based on annual compensation in excess of \$330,000 and \$305,000 in plan years 2024 and 2023, respectively. For all other participants in the Plan, the profit-sharing contribution is based on annual compensation. Unless otherwise determined by the Firm, such profit-sharing contributions shall equal 5% of each participant's applicable participation or compensation, up to a maximum of \$16,500 and \$15,250 in plan years 2024 and 2023, respectively.

Upon enrollment, participants may direct their contributions, as well as the Firm's contributions, to various fund options, including a self-directed brokerage account.

Unless participants opt out of automatic enrollment, all newly hired and rehired employees are automatically enrolled with a 5% pretax 401(k) deduction beginning with their second paycheck from the Firm. For all participants except certain principals, if automatically enrolled or affirmatively elect to defer a portion of eligible earnings less than 15%, the participant's deferral percentage will automatically be increased by 1% each year, unless the participant opts out of such increases or the participant's deferral percentage has been increased to 15% of his or her compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Firm's matching contributions and allocations of (a) the Firm's profit-sharing contribution and (b) the participant's investment funds' earnings or losses and (c) is charged with an allocation of administrative expenses. Allocations of the Firm's profit-sharing contribution are based on the participant's participation or compensation. Plan earnings or losses are allocated based on the participant's share of net earnings or losses of his or her respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. An investment fund includes a participant's self-directed brokerage account.

Forfeitures

Unallocated forfeitures totaled \$38,248 and \$86,502 at June 30, 2024 and 2023, respectively, which were used to reduce the Firm's 2024 and 2023 profit-sharing contributions, respectively, funded after the Plan's year-end.

Vesting

Participants are immediately vested in their contributions and the Firm's matching contributions plus actual earnings thereon. Vesting in the Firm's profit-sharing contributions is as follows:

Participant Loans

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 reduced by the highest aggregate loan balance in the past 12 months or 50% of their vested account balance. Loan terms range from 1 month to 60 months. Participants can have no more than two loans outstanding at any point in time, and the second loan cannot be received within one year of when the first loan was received. The loans are secured by the balance of the respective participants' accounts and bear interest at a rate commensurate with local prevailing rates. If a participant ceases to make loan repayments and the Plan's administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

On termination of service, participants may receive a lump-sum amount equal to the vested value of their account or, if fully vested, may receive annual installments over a period no more than the lesser of ten years or the maximum period that will satisfy the minimum distribution benefit requirements, as applicable.

Plan Transfers

In addition to the Plan, the Firm also sponsors defined contribution plans for U.S. office employees not employed in the New York office. If employees transfer to or from the New York office, their account balances are transferred into the applicable plan.

Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their accounts.

Administrative Expenses

All administrative expenses are paid by the Plan. The total expense ratio for each fund includes a charge of 7 basis points used for payment of eligible plan expenses.

2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 or 2023.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

3. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active

- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation techniques and inputs used for each general type of asset measured at fair value by the Plan:

Mutual funds: Shares of mutual funds are valued based on quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

Self-directed brokerage accounts: Accounts primarily consist of equities and mutual funds. Equities are valued at the closing price reported in the active market in which the individual securities are traded. Mutual funds are valued at quoted market prices, which represent the NAV of shares held by the Plan at year-end.

Common collective trust funds: Valued at the NAV provided by the administrator of the fund.

4. Tax Status

The Plan has received a determination letter from the Internal Revenue Service (the IRS) dated June 15, 2018, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code) and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

4. Tax Status (continued)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

6. Related-Party and Party-in-Interest Transactions

The Plan holds units of common collective trust funds and shares of mutual funds managed by Frank Russell Trust Company, the trustee for the Plan, and held by Charles Schwab and State Street Bank and Trust Company, the custodians for the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.
