Scope and Nature of the ERISA Section 103(a)(3)(C) Audit Statements

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Harbor Homes, Inc. 401(k) Plan's ability to continue as a going concern for one year from the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.



- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion the effectiveness of Harbor Homes, Inc. 401(k) Plan’s internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Harbor Homes, Inc. 401(k) Plan’s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Supplemental Schedules Required by ERISA

The supplemental Schedules of Delinquent Participant Contributions for the year ended June 30, 2024 and Assets Held as of June 30, 2024 are presented for the purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and related directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.



For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The information in the supplemental schedule Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their accounts.

1. Description of the Plan

The following brief description of the Harbor Homes, Inc. 401(k) Plan (the Plan) provides general information about the Plan's provisions. Participants should refer to the plan document and adoption agreement for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined contribution plan sponsored by Harbor Homes, Inc. and certain affiliated entities: Greater Nashua Council on Alcoholism, Healthy at Home Inc., Welcoming Light Inc., and Southern New Hampshire HIV/Aids Task Force. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (ERISA). Hand Benefits and Trust Company is the trustee of the Plan. Benefit Plan Administrative services, LLC, (BPAS) the is recordkeeper.

Eligibility

The Plan is available to employees of Harbor Homes, Inc. and the identified affiliates (the "Organization") who are 21 years old. Union employees and non-resident aliens are excluded from the Plan.

Contributions

Each year, eligible participants may make contributions to the Plan through salary deferrals on a pre-tax basis and/or an after-tax Roth basis up to 100% of eligible compensation, as defined in the Plan. The maximum amount that a participant may contribute was limited by the provisions of the Internal Revenue Code (the Code).

The Organization makes a safe harbor matching contribution of 100% of employee deferrals up to 6% of eligible compensation, as defined in the Plan. At the option of the Board of Trustees, the Organization may also make an employer discretionary contribution to the Plan. For the year ended June 30, 2024, the Organization elected to make an additional discretionary matching contribution.

The additional discretionary matching contribution was tiered based on years of service. If greater than 5 years of service but less than 16 years of service, the total employer contribution including the safe harbor match is 100% of employee deferrals up to 12%. Highly compensated individuals, as defined by the Internal Revenue Service are not eligible for the additional employer discretionary match contribution.

1. Description of the Plan (continued)

Vesting

Participants are immediately vested in all contributions plus actual earnings or losses thereon.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's and employer's contributions and an allocation of investment income and charged with an allocation of the investment losses and certain administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. A participant's account shall be reduced by distributions, investment losses and expenses.

Notes Receivable from Participants

Participants are able to borrow up to the lesser of \$50,000 or 50% of the vested portion of their account balances, subject to certain restrictions specified by the Plan. Participant loans (notes receivable from participants) bear interest at a rate similar to those rates charged by commercial lenders, and are repayable within a period of five years, unless the loan is for the purchase of the principal residence of the borrower, in which case the term cannot exceed 10 years. Loans are secured by the respective participant's remaining account balance. Principal and interest are paid ratably through regular payroll deductions.

Interest rates on outstanding loans at June 30, 2024 ranged from 4.25% to 9.50% with various maturities through January of 2029. Interest rates on outstanding loans at June 30, 2023 ranged from 4.25% to 9.00% with various maturities through November of 2027.

Investments

Upon enrollment in the Plan, a participant may direct his or her account balance among the various investments offered by the Plan. The Plan offered investments in mutual funds and a common trust fund.

Payment of Benefits

Participants are eligible to receive their vested account balance upon retirement (normal retirement age is 65), death, disability, or termination. Participants still employed, are able to withdraw their account balances upon attaining age 65. Participants were able to receive their benefit payments in a single lump-sum payment, or installments. In addition, participants are able to withdraw their contributions upon demonstration to the plan administrator that they were suffering a hardship, as defined.

1. Description of the Plan (continued)

Administrative Expenses

The Plan's administrative expenses were paid by either the Plan or the Organization, as provided by the Plan's provisions. Expenses relating to purchases, sales or transfers of the Plan's investments were charged to the particular investment fund to which the expenses relate.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis in accordance with United States generally accepted accounting principles.

Use of Estimates

The preparation of financial statements in conformity with United States generally accepted accounting principles (GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). Investments in mutual funds are stated at fair market value based on the last quoted price as of the Plan year end. Investments in common trust funds are presented at net asset value (NAV) as a practical expedient. See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies (continued)

Notes Receivable from Participants

Notes receivable are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they were incurred. No allowance for credit losses has been recorded as of June 30, 2024. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits payments are recorded upon distribution.

Subsequent Events

Management has considered transactions and events occurring through April 9, 2025 the date these financial statements were available to be issued.

3. Investments

All investment information disclosed in the accompanying financial statements, including investments held and notes receivable from participants at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest on notes receivable from participants for the year ended June 30, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Hand Benefits & Trust Company, the Trustee of the Plan.

4. Fair Value Measurement

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based upon the lowest level of input that is significant to the fair value measurement in its entirety.

5. Income Tax Status

The underlying non-standardized pre-approved profit sharing plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Plan management has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions. The Plan is currently under audit by the Department of Labor.

6. Parties-in-interest

Fees incurred by the Plan for the investment management services and recordkeeping are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Notes receivable from participants are considered party-in-interest transactions. The Plan made a direct payment to the recordkeeper and adviser of \$43,808.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Late Remittance of Participant Contributions and Loan Repayments

During the years ended June 30, 2024, 2023 and 2022, the Organization was late in remitting certain participant contributions and loan repayments within the timeframe required by the United States Department of Labor. Late contributions totaled \$127,891, \$37,063 and \$77,042 for the years ended June 30, 2024, 2023 and 2022, respectively.
