## NOTES TO FINANCIAL STATEMENTS

### 1. Description of Plan:

The following description of the New York Medical College Prefunded Life and Health Insurance Benefit Plan (the "Plan") is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provision.

#### General

The Plan provides for a portion of the costs of the life and health insurance coverage for eligible retirees and dependents of the New York Medical College (the "College"). The participants are responsible for the remainder of the retiree health insurance cost that the College does not pay if they wish to remain in the health insurance plan. Participant premium amounts are determined separately for pre-age 65 and post-age 65 participants. Postretirement benefits for employees hired on or after July 1, 1994 are fully contributory. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### Benefits

The Plan was established to provide medical and life insurance benefits to all employees of the College who retire on or after July 1, 1995, who at the time of retirement has worked at New York Medical College as a regular, full-time member of the faculty or non-union staff for 10 continuous years or more and having attained at least age 60 as of their retirement date, and their eligible spouses and dependents. The College has a separate unfunded plan for those who retired prior to July 1, 1995. Effective July 1, 2002, dental benefits were added to the Plan and offered to all participants. Effective July 1, 2004 the Plan was amended to include key employees. The Plan will provide medical, dental, and life insurance benefits to all participants until deceased.

The Plan provides a non-contributory life insurance policy for all retirees equal to 10% of the last annual salary to a maximum of \$10,000 and a minimum of \$3,000.

*Retiree contribution rates are as follows for medical:*

Participants hired on or after July 1, 1994	Retirees pay 100% of estimated cost of providing their postretirement benefits
Participants hired prior to July 1, 1994 and retiring after July 1, 1994	Retirees pay 90% of estimated cost of providing their postretirement benefits

*Retiree contribution rates are as follows for life insurance:*

Participants hired on or after July 1, 1994	The Plan pays 100% of the full cost
Participants hired prior to July 1, 1994	The Plan pays 100% of the full cost

*Retiree contribution rates are as follows for dental:*

Participants hired on or after July 1, 1994	Retirees pay 100% of estimated cost of providing their postretirement benefits
Participants hired prior to July 1, 1994	Retirees pay 90% of estimated cost of providing their postretirement benefits

## 1. Description of Plan (continued):

### Plan Termination

Although it has not expressed any intent to do so, the College has the right under the Plan, in certain circumstances, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, the net assets then held shall be allocated among the participants and beneficiaries of the Plan in the order of priority determined in accordance with ERISA. To the extent unfunded vested benefits exist, ERISA provides that such benefits are payable by the Pension Benefit Guaranty Corporation to participants, up to specified limitations, as described by ERISA.

### Plan Administration

The College's Finance Committee and senior management oversees the administration of the Plan. The Trustee and Custodian of the Plan is the Bank of New York Mellon ("BNY Mellon").

## 2. Significant Accounting Policies:

### Basis of Accounting

The accompanying financial statements are prepared using the accrual basis of accounting in accordance with U.S. generally accepted accounting principles ("US GAAP"), which recognizes income when it is earned and expenses as they are incurred.

### Pervasiveness of Estimates

The preparation of financial statements in conformity with US GAAP requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for pension benefits at the date of the financial statements and the actuarial present value of accumulated plan benefits as of the valuation date, and the changes in net assets available for benefits during the reporting period. Actual results may differ from those estimates.

### Investment Valuation and Income Recognition

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion on fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Gains or losses on sales of securities are based on the average cost of investments sold. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains or losses on those investments bought and sold as well as held during the year.

### Participant Deposits

Payments received from participants as of June 30, that represent contributions for the following year, are shown as participant deposits. There were no participant deposits as of June 30, 2024 and 2023.

### Payment of Benefits

Benefit payments are recorded when paid.

### Administrative Expenses

The expenses of administering the Plan include: (i) the fees and expenses of the Plan's service providers for the performance of their duties, (ii) the expenses incurred by the members of the College's Benefit Plan Committee in the performance of their duties to the Plan (including reasonable compensation for any legal counsel, certified public accountants, actuary and any agents and cost of services rendered in respect of the Plan), and (iii) all other proper charges and disbursements of the Trustee (including settlements of claims or legal actions approved by counsel to the Plan). Such expenses may be paid by the Plan if the College does not pay such expenses as determined by the Benefit Plan Committee. Administrative expenses are recorded when incurred.

## 2. Significant Accounting Policies (continued):

### Income Taxes

The Plan is exempt from federal income taxes pursuant to applicable sections of the Internal Revenue Code ("IRC") Section 401(a). The current favorable determination letter relating to the Plan, dated June 27, 1996, stated that the Plan was in compliance with the applicable requirements of the IRC.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and concluded that, as of June 30, 2024, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Risks and Uncertainties

Contributions to the Plan and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, health care inflation rates, employee compensation and demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes would be material to the financial statements.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to the changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for plan benefits and the statements of changes in net assets available for plan benefits.

## 3. Benefit Obligations - Life and Health Postretirement Benefits:

The accumulated postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to the employee's service rendered to the valuation date, reduced by the actuarial present value of contributions expected to be received in the future from current participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees, their beneficiaries and dependents after retirement from service with the College. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an independent actuary and it is that amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims cost per participant and adjusted for such estimates as the time value of money and the probability of payment between the valuation date and the expected date of payment.

For measurement purposes, the following health care cost trend rates were assumed in the valuations as follows:

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation. The funding policy of the Plan is for the College to make a contribution based on the total annual expense for employees' accounting for postretirement benefits other than pensions. The College was not required to provide additional contributions to the Plan for the years ended June 30, 2024 and 2023.

On December 8, 2003, the Medicare Prescription Drug, Improvement and Modernization Act of 2003 (the "Act") for employers sponsoring postretirement health care plans that provide prescription drug benefits was signed into law. Under the Act, a federal subsidy is provided to sponsors of retiree health care benefit plans that provide a prescription drug benefit to retirees.

The Plan does not provide an actuarial equivalent prescription drug benefit due to the level of retiree contributions. Accordingly, the Plan is not entitled to any Medicare subsidy. The postretirement benefit obligation and the changes in the benefit obligation of the Plan have not been adjusted for any amount associated with the Medicare subsidy.

**4. Fair Value Measurements:**

U.S. GAAP provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and lowest priority to unobservable inputs (level 3 measurements). The three levels of the hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**4. Fair Value Measurements (continued):**

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Money Market Fund:* Valued at the amortized cost of shares held by the Plan at year end which approximates fair value.

*Global Equity Fund:* Valued at the quoted prices of shares held by the Plan at year end which are quoted monthly. Prices quoted are the Net Asset Value ("NAV") of the shares held which are based on the fair value of the underlying securities.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of the future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The table below presents the balances of assets and liabilities measured at fair value on a recurring basis by level within the hierarchy. For the fiscal years ended June 30, 2024 and 2023, the application of valuation techniques applied to similar assets and liabilities has been consistent.

**5. Related Party Transactions:**

Certain Plan investments are managed by affiliates of BNY Mellon, the Trustee and Custodian of the Plan and, therefore, those transactions qualify as party-in-interest transactions.

Fees paid by the Plan to BNY Mellon for investment management services amounted to \$54,242 and \$56,927 for the years ended June 30, 2024 and 2023, respectively.

**6. Subsequent Events:**

The date to which events occurring after June 30, 2024, the date of the most recent statement of net assets available for benefits, have been evaluated for possible adjustment to the financial statements or disclosure is April 4, 2025, which is the date on which the financial statements were available to be issued.
