## Independent Auditor's Report

Administrator and Trustees

### Opinion on the Financial Statements

I have audited the accompanying financial statements of Kenmore Teachers Association Welfare Trust Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In my opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of June 30, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion on the Financial Statements

I conducted my audit in accordance with auditing standards generally accepted in the United States of America. My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of my report. ## Notes to Financial Statements

---

### 1. Description of the Plan

The following description of the Kenmore Teachers Association Welfare Trust Fund (the “Plan”) provides only general information. Participants should refer to the Welfare Trust Fund agreement and the Welfare Trust Benefits Booklet for a complete description of the Plan’s provisions.

*General*—The Plan and related Trust were established August 1, 1983 pursuant to a collective bargaining agreement (“Contract”) between the Kenmore Teachers Association (the “Association”), Local 2768 of the American Federation of Teachers and the Kenmore-Town of Tonawanda Union Free School District (the “District”). The current Contract with the District extends through the 2028-29 school year. Eligible employees include all persons employed by the District in the negotiating unit of full and part-time teachers, retired persons who were in such unit and were participants in the Plan at the time of their retirement, officers and employees of the Association and the Plan on whose behalf the Association makes contributions, and others as agreed to between the Association and the District.

*Benefits*—The Plan and the related Trust were established to provide various welfare benefits to eligible employees. Presently, the Plan provides limited dental, vision, life and catastrophic medical coverage to its members along with membership in a legal services program and a financial counseling program.

Dental benefits are provided to eligible employees and their dependents, as defined, and are paid on eligible services up to \$1,500 per patient, per calendar year. Claims for this Plan are processed by Delta Dental New York, Inc., but the responsibility for payments to participants and providers is retained by the Plan.

Vision benefits are provided through a fully-insured agreement with Davis Vision (“Davis”) which allow participants to receive frames, lenses, contacts and exams on an annual basis as provided for in the agreement. Part-time teachers receive a pro-rated benefit.

The Catastrophic Major Medical (CMM) Plan is designed to provide coverage for eligible medical expenses, as defined, subject to the CMM Plan deductible.

Employees are also enrolled in a legal services program whereby members are guaranteed fixed fees and legal representation for a number of legal services. The Plan pays a fee based on total enrollment to the NYSUT Legal Service Plan for this service.

Life insurance is carried on all Association members. Each member is covered under a group term policy providing for a \$50,000 death benefit for full time members and \$25,000 for part time members, as defined.

The Plan has instituted a Financial Planning program whereby Association members can contact a financial professional and receive advice on a variety of financial planning tools and products.

*Contributions*—Pursuant to the Contract, the District contributes an amount per full-time teacher and full-time teaching assistant, with a prorated contribution for part-time teachers and part-time teaching assistants to provide for the benefits under the Plan. Contributions are made in semi-annual installments on July 1 and January 1. For the years ended June 30, 2024 and 2023, the District contribution amounted to \$1,700 and \$1,650, respectively per full-time teacher and full-time teaching assistant, with a prorated contribution for part-time teachers and part-time teaching assistants. Retired, or separated former employees may contribute amounts equal to premiums plus an allowance for administrative costs to continue in some programs.

## **2. Summary of Significant Accounting Policies**

*Basis of Presentation*—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

*Investment Valuation and Income Recognition*—The bank certificates of deposit are valued at their face amount, which approximates fair value. Interest is accrued on fixed-percentage investments. Interest-bearing cash consists of deposits with financial institutions.

*Cash* — Cash consists of non-interest bearing deposits with a financial institution.

*Payment of Benefits*—Benefits are recorded when paid.

*Administrative Expenses*—All expenses of maintaining the Plan are paid by the Plan.

*Use of Estimates*—The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

*Market Risk Factors*—The Plan’s investments consist of bank certificates of deposit with maturities of one year or less and deposits with financial institutions. The Plan’s investments in certificates of deposit are fully insured by the Federal Deposit Insurance Corporation (FDIC) and have been issued through the Certificate of Deposit Account Registry Service, or CDARS.

The Plan maintains operating cash balances with various financial institutions. The Federal Deposit Insurance Corporation insures these balances up to \$250,000. There were no uninsured deposits at June 30, 2024.

*Subsequent Events* — The Plan has evaluated subsequent events through April 7, 2025, the date the financial statements were available to be issued.

The certificates of deposit have been issued through CDARS by one or more FDIC-insured depository institutions. At June 30, 2024 and 2023, the CDARS were issued and held by Five Star Bank.

### 4. Tax Status

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c) 9 of the Internal Revenue Code, and, accordingly, the Trust's net investment income is exempt from income taxes. The Trustees believe that the Plan, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

As of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 5. Transactions With Parties In Interest

Certain administrative functions of the Plan are performed by employees of the Kenmore Teachers Association. These costs along with an allocation of shared overhead costs were \$78,972 and \$77,187 for the years ended June 30, 2024 and 2023, respectively and are included in administrative expenses. In addition, certain salary and benefit related cost reimbursements are paid to the District, which amounted to \$17,396 and \$32,182 for the years ended June 30, 2024 and 2023, respectively and are included in administrative expenses.

### 6. Plan Termination

The Plan's board of trustees has the right under the Plan to modify the benefits provided to the eligible employees. They may also terminate the Plan, with any remaining assets available after payment of Plan obligations limited to use for providing welfare benefits.
