INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the Catawba Valley
Healthcare Retirement Plan and the Management of Catawba

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Catawba Valley Healthcare Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Catawba Valley Healthcare Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Catawba Valley Healthcare Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. Description of the Plan

The following description of the Catawba Valley Healthcare ("Company") Retirement Plan ("Plan") is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of the Company, excluding transitional employment staff, who are age 18 or older. The Plan is a deferred compensation (401(k)) arrangement, whereby, electing eligible employees choose to contribute on a pretax basis or an after-tax basis as in a Roth 401(k) deferral, a portion of their annual compensation to the Plan in lieu of current payment thereof. The Company has elected to outsource administration of the Plan to an independent third party that specializes in benefit plan administration. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participant contributions are limited to the lesser of 100% of eligible compensation, or \$22,500, the maximum allowed by IRC Section 402(g)(1)(B). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may match the employees' contributions at a rate to be determined annually. For Plan year ended June 30, 2024 the Company matched 100% of employee's deferral up to \$500 and for Plan year ended June 30, 2023 the Company matched \$.50 on the \$1, up to \$200. Participants elect how to allocate their contribution (and related employer match) between the various funds offered by the Plan.

Participant Accounts - Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and allocations of the Company's matching contribution and Plan earnings and charged with benefit payments, if applicable, and allocations of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions, plus actual earnings, thereon, as well as their rollover contributions and the employer matching contribution.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, or 50%, of their account balance, whichever is less. The loans are secured by the balance in the participant's vested account and bears interest at prime rate as published in the Wall Street Journal on the first business day of the month the loan is originated plus 1% and is fixed for the life of the loan. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits - Upon retirement or termination, participants with vested accounts of more than \$1,000 may elect to receive either a single lump-sum payment of their entire account balance or a single-sum payment of a portion of their account balance. Vested account balances less than \$1,000 will be paid in lump-sum only. Vested account balances which exceed \$1,000 must consent

to the distribution before it is made. As of June 30, 2024 and 2023, no funds were allocated to participants who had requested distributions from the Plan but had not been paid.

Forfeitures - At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$33 and \$0 respectively. These accounts will be used to reduce future Plan expenses. Also, during the Plan year, Plan expenses were reduced by \$0 and \$21 at June 30, 2024 and 2023, respectively, from forfeited nonvested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. The Plan changed accounting policies in the current year by adopting AICPA Statement on Auditing Standards (SAS) No. 136.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. For Plan years ended June 30, 2024 and 2023, there were no excess contributions payable to report.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included

in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Company has evaluated subsequent events through February 17, 2025, the date which the financial statements were available to be issued.

At June 30, and , the Plan’s investments were held by the Trustee. 4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, and .

Pooled Separate Accounts: The fair values of pooled separate accounts (variable annuities) for initial pricing are based on the quoted price obtained for the underlying mutual fund which is then adjusted to apply for the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation: dividing the net assets by the number of units outstanding. Any discrepancies between the two unit values are resolved to ensure the recordkeeping system reflects the accurate value for the day.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended June 30, 2024, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

Investment Contract with Insurance Company

The Plan has several investment contracts with John Hancock. John Hancock maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at fair value as reported to the Plan by John Hancock. Interest rates are determined on the date the funds are deposited into the account and are guaranteed for three, five or seven years. All rates credited during the 12 month "deposit year" are averaged into a single composite rate.

5. Related-Party Transactions

Certain Plan investments are shares of pooled separate accounts and guaranteed investment contracts managed by Empower Retirement. Empower Retirement is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions; however, they are exempt from the ERISA prohibited transaction rules. Fees paid for investment management services amounted to \$18,395 and \$7,526 for the years ended June 30, 2024 and 2023.

Certain Plan investments are managed by John Hancock as shown on Table 1 of the financial statements. These transactions qualify as party-in-interest transactions; however, they are exempt from the ERISA prohibited transaction rules.

Personnel and facilities of Catawba Valley Healthcare have been used to perform administrative functions for the plan at no charge. Catawba Valley Healthcare pays Martin Starnes and Associates, CPAs, P.A. for the audit of Catawba Valley Healthcare Retirement Plan. All these related party and party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their employer contributions.

7. Federal Income Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

9. Change in Service Providers

The Plan terminated contracts with their service provider Empower Retirement and secured John Hancock as their new service provider effective June 30, 2023. Investments held in Empower Retirement were liquidated and transferred to John Hancock in the amount of \$1,082,060. Notes receivable from participants in the amount of \$40,911 were also transferred upon Empower Retirement's contract termination.
