### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of The Child Center of NY, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### 1. Description of Plan

The Child Center of NY, Inc. (the “Employer”) adopted The Child Center of NY, Inc. 401(k) Plan (the “Plan”) as of July 1, 2018. The Plan executed an updated adoption agreement effective July 1, 2022. The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution plan covering substantially all employees of the Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Participants over the age of 21 may elect to complete a salary reduction agreement and an enrollment form. Non-union participants who complete one year of service and 1,000 hours of service are also eligible to receive a discretionary profit sharing contribution and a discretionary matching contribution. Union employees are not eligible for contributions from the Employer.

#### ***Contributions***

Eligible participants may contribute up to 100% of their eligible compensation to the Plan on a pre-tax or Roth basis. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Employer. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code (“IRC”). Participants may also contribute amounts representing distributions (rollovers) from another qualified plan.

For the year ended June 30, 2024 the Employer safe-harbor contribution was calculated as 3% of a participant’s eligible compensation.

For the year ended June 30, 2024 the Employer discretionary profit sharing contribution was calculated as 7% of a participant’s eligible compensation.

#### ***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and Employer contributions, as well as an allocation of Plan earnings, and charged with an allocation of expenses. The benefit to which a participant is entitled is the amount accumulated in the participant’s vested account.

### 1. Description of Plan *(continued)*

#### ***Vesting***

A participant is 100% vested in their contributions and safe-harbor contributions plus allocated earnings thereon at all times. Participants vest in profit sharing contributions according to the schedule below.

#### ***Forfeitures***

Forfeitures result from a participant's termination of service prior to achieving full vesting in the Employer contributions. Such forfeitures are transferred out of the participant's account and are held in a separate account. Forfeitures are applied to reduce the Employer's contribution. Balances in the forfeiture account were \$228,009 and \$5,977 at June 30, 2024 and 2023. During the 2024 Plan year, \$14,384 in forfeitures was used to reduce Employer contributions.

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account in the form of a lump sum, installments or an annuity. In-service withdrawals may be taken by a participant upon reaching normal retirement age. Normal retirement age is 65 years for the Plan.

#### ***Notes Receivable from Participants***

Participants may borrow from their account a minimum amount of \$1,000 up to a maximum amount of \$50,000 or one-half of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of 1% above the published prime rate as of the first business day of the month the loan is originated. The maximum repayment term allowed is five years unless the loan qualifies as a residential mortgage loan. A participant can only have two loans outstanding at any time. Principal and interest is paid ratably through deductions from payroll.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At June 30, 2024 and 2023 all of the Plan’s investments that were valued at fair value, were valued using level 1 inputs.

#### ***Investment Valuation and Income Recognition***

All of the Plan’s investments are stated at fair value except for the stable value fund, which is reported at contract value. Contract value represents contributions made under the contract, plus interest credited, less benefits paid and expenses. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price. Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a deemed distribution upon a distributable event.

#### ***Payment of Benefits***

Benefits are recorded when paid.

### 2. Summary of Significant Accounting Policies (*continued*)

#### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from the financial statements. Investment related expenses are included in net appreciation in fair value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is April 10, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution.

### 4. Stable Value Fund

The Plan invested in a fully benefit-responsive investment contract called the Morley Stable Value Fund (the “Fund”). The Fund is a collective investment trust maintained by Principal Global Investors Trust Company who is also the investment manager of the Fund. The objective of the Fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile and liquidity for benefit responsive plan or participant payments. The Fund does not have a set interest rate since it owns several investment contracts with varying rates and maturity dates. Withdrawals from the Fund for benefit payments and participant transfers to noncompeting options may be made within 30 days after written notification has been received and are considered as made immediately after the next valuation date subsequent to the trustee’s approval. Were the Plan to initiate a full redemption of the Fund, the investment manager reserves the right to temporarily delay withdrawal from the Fund in order to ensure that securities liquidations will be carried out in an orderly business manner. The Fund represents approximately 2% and 4% of the Plan’s net assets available for benefits as of June 30, 2024 and 2023.

### 5. Parties-In-Interest

Certain transactions are processed by EPIC Retirement Plan Solutions (“EPIC”). EPIC is the third party administrator as defined by the Plan and therefore these transactions qualify as exempt party-in-interest transactions under ERISA.

### 5. Parties-In-Interest (*continued*)

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA and are reflected in the statements of net assets available for benefits.

### 6. Tax Status

The Plan's prototype plan document preparer has obtained an opinion letter dated June 30, 2020 from the Internal Revenue Service stating that the Plan is designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is no longer subject to examinations by the applicable taxing jurisdictions for periods prior to fiscal 2021; however, there are currently no examinations for any tax periods in progress.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participant accounts would become fully vested.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with the certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to June 30, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
