INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator
Miami Valley School DC Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Miami Valley School DC Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023 and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Miami Valley School DC Retirement Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Miami Valley School DC Retirement Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 10 to the financial statements, the Miami Valley School DC Retirement Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Miami Valley School DC Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Miami Valley School DC Retirement Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

We are required to be independent of the Miami Valley School DC Retirement Plan, and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Other Matters - Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of June 30, 2024 and the supplemental schedule of delinquent participant contributions for the year ended June 30, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer for Opinion section, it is inappropriate to and we do not express an opinion on the supplemental schedules referred to above.

1. DESCRIPTION OF THE PLAN:

The following description of the Miami Valley School DC Retirement Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution pension plan which covers all employees of Educational Resources, Inc. dba The Miami Valley School (the "Sponsor") except non-resident aliens and enrolled student employees. Participants may enter the Plan upon hire. Participants who have 1,000 hours of service and are age 21 or older are eligible for Sponsor matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The plan was restated effective April 1, 2024 to incorporate required statutory changes, permit participants to make Roth deferral contributions, and to modify the vesting schedule related to employer matching contributions for participants hired after April 1, 2024.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Sponsor makes matching contributions equal to 100% of the first 5% of eligible compensation that a participant contributes to the Plan. Matching contributions are calculated and remitted subsequent to the end of the plan year. Participants direct the investment of their contributions into various investment options offered by the Plan.

Prior to the April 1, 2024 plan restatement, participants who had 15 years of service were also eligible to make Qualified Organization catch-up contributions. Subsequent to the April 1, 2024 plan restatement, the ability to make Qualified Organization catch-up contributions was removed. Additionally, the aforementioned restatement added for the ability of participants to make Roth deferral contributions going forward.

Participant accounts

Each participant's account is credited with the participant's contributions and Sponsor matching contributions, as well as the allocation of Plan earnings. Participant accounts are charged with an allocation of any administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Prior to the April 1, 2024 plan restatement, all participants were also vested immediately in Sponsor contributions plus actual earnings thereon. Subsequent to the April 1, 2024 plan restatement, Sponsor contributions plus actual earnings thereon for participants hired after this restatement date are subject to a 5 year graded vesting schedule, which grants 20% vesting for each year of service earned.

Payment of benefits

Upon termination of service due to death, disability or retirement, distribution shall be made to the participant or beneficiary in a single lump sum payment, partial payments, installment payments or a single life annuity payment. For termination of service for other reasons, a participant may receive a lump sum distribution. Participants may also make withdrawals of vested account balances prior to termination, upon attainment of age 59 1/2, or in the event of financial hardship, as defined by the Plan.

Forfeited accounts

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$-0-, respectively. These accounts will be used to reduce future Company contributions. Also, in 2024, Sponsor contributions were reduced by \$-0- from forfeited nonvested accounts.

Loans collateralized by participant accounts

Participants may obtain loans from Teachers Insurance and Annuity Association of America ("TIAA") in amounts ranging from \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. Loan proceeds are disbursed by TIAA and loans are collateralized by a portion of the participant's account balance. Upon the execution of a loan agreement, a portion of the participant's account balance equal to the unpaid loan is transferred into the unallocated insurance contract offered by TIAA. Loan repayments are made by the participants directly to TIAA. As loan payments are received by TIAA, a portion of the funds held as collateral are released. Defaults are determined in accordance with the terms of the Plan loan agreements between TIAA and the participant. Upon default, the Plan loan becomes taxable to the participant; however, the collateral remains in the participant's account until the participant reaches a distributable event such as retirement or termination.

Plan loans outstanding at June 30, 2024 and 2023 were \$7,075 and \$19,289, respectively. As these loans are between TIAA and the participant, they do not appear on the statements of net assets available for benefits.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at a rate commensurate with local prevailing rates as determined by the administrator. Principal and interest are paid ratably through payroll deductions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. See Note 4 for further discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded on the basis of the terms of the Plan agreement.

Payment of benefits

Benefits are recorded upon distribution.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants or other participant directed transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through April 9, 2025, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS:

Plan management has elected the method of compliance permitted by 29 CFR2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and College Retirement Equities Fund ("CREF"), the custodians, have certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of June 30, 2024; the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended June 30, 2024.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Account: The TIAA Real Estate Pooled Separate Account is valued at the net asset value per accumulation unit of the investment. The underlying real estate holdings or other real estate related investments are valued principally utilizing external appraisals. Although the underlying assets of the account cannot be quickly sold and converted to liquid assets, the TIAA general account provides the Plan with a liquidity guarantee. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Unallocated insurance contracts: The TIAA Traditional Annuity is an unallocated fixed-dollar annuity and investment product that is fully and unconditionally guaranteed by TIAA, an insurance company. The TIAA Traditional Annuity is maintained in the TIAA general account. Contributions to the TIAA Traditional Annuity purchase a contractual or guaranteed amount of future benefits for the participants and are secured by the general assets of TIAA. A portion of the unallocated insurance contracts have surrender charges and other restrictions on withdrawals and are therefore, not considered to be fully benefit-responsive. The remaining portion of the unallocated insurance contracts do not have restrictions on withdrawals and are considered fully benefit-responsive. Unallocated insurance contracts considered to be fully benefit-responsive are presented at contract value, while unallocated insurance contracts that do not qualify as fully benefit-responsive are presented at fair value. Fair value is determined using a discounted cashflow analysis using projected future crediting rates.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The pooled separate account held by the Plan is a direct filing entity ("DFE"). The Plan is not required to disclose the investment strategies of DFEs that file a Form 5500 annual report directly with the U.S. Department of Labor.

Changes in Fair Value of Level 3 Assets

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to the total net assets available for benefits.

During 2024, the Plan purchased \$215,023 (including reinvested earnings) and sold \$992,951 of the unallocated insurance contracts.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS:

Certain funds invested in the TIAA Traditional Annuity totaling \$249,360 and \$461,478 at June 30, 2024 and 2023, respectively, are considered fully benefit-responsive.

TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. TIAA is contractually obligated to repay the principal and specified interest rates that are guaranteed to the Plan. The guaranteed investment contract does not permit TIAA to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all of a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s abilities to meet their financial obligations. The issuer’s abilities to meet their contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition or competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Sponsor or other Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow the issuers to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without consent of the issuer.

6. TAX STATUS:

The Company adopted a 403(b) volume submitter plan which received a favorable opinion letter from the IRS dated March 31, 2017. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. While the Company has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. RELATED PARTY TRANSACTIONS:

All plan investments are managed by TIAA and CREF, which are the custodians and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. The Sponsor pays directly any other fees related to the Plan's operations.

9. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. COMPLETENESS OF RECORDS:

The Plan has been in operation since 1969. As a result of regulatory changes, the Plan became subject to the requirement to file a full Form 5500 beginning in 2009 and to have an annual audit of its financial statements beginning in 2016. Due to the extensive length of time from the beginning of Plan operations until the requirement to file a full Form 5500, the Sponsor is unable to determine whether sufficient records were maintained to verify the completeness of the annuity and custodial accounts issued prior to January 1, 2009. Accordingly, the Plan elected to omit any unidentified contracts from financial activity of the Plan in its Form 5500 filings in accordance with the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements of 403(b) Plans*. However, accounting principles generally accepted in the United States of America require that all accounts and the related income and distributions be included in the accompanying financial statements. The financial statements and Form 5500 include all annuity and custodial accounts of which the Sponsor is aware. However, due to the inability to verify the completeness of the annuity and custodial accounts, the Sponsor is unable to determine the impact of this omission, if any, on the Plan's financial statements.

11. CONTINGENCY:

The Plan Sponsor has identified several instances in which the Plan was not operated in a manner consistent with the Plan Document, including determining eligibility for participation and the calculation of employer contributions. The Sponsor is utilizing the Voluntary Fiduciary Correction Program ("VFCP") provided by the U.S. Department of Labor Employee Benefits Security Administration to report and correct the identified operational errors. The Plan recorded corrective contributions receivable totaling \$27,137 at June 30, 2024 and 2023, respectively, from the Sponsor, which represents the estimated amount required to compensate for missed employee deferrals, related Sponsor matching contributions, and lost earnings on those contributions. In November 2021, the Internal Revenue Service approved the correction methods outlined in the Plan Sponsor's VFCP submission. The Plan Sponsor has sent communications to all affected participants. For those who have been located and responded to those communications, corrective contributions and lost earnings payments have been submitted. The Plan Sponsor is continuing its efforts to provide the necessary corrective contributions to a certain number of participants who have not responded to communications or cannot be located.

12. DELINQUENT PARTICIPANT CONTRIBUTIONS:

For the year ended June 30, 2024, the Sponsor did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Delinquent Participant Contributions Disclosure under ERISA. Untimely remittances identified on the Schedule H, Line 4(a) – Schedule of Delinquent Participant Contributions, which totaled \$18,403, and lost earnings, which are required to compensate participants for the delay in these contributions, were identified and corrected by the Sponsor subsequent to year end.
