## INDEPENDENT AUDITORS' REPORT

To the Trustees of  
Momentum Agencies Retirement Plan

We have performed audits of the financial statements of Momentum Agencies Retirement Plan (*Formerly United Cerebral Palsy of Los Angeles and Ventura Counties Retirement Plan*) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Momentum Agencies Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Momentum Agencies Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Momentum Agencies Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Momentum Agencies Retirement Plan (*Formerly United Cerebral Palsy of Los Angeles and Ventura Counties Retirement Plan*) (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan Sponsor changed its name to Momentum Agencies, and accordingly, effective July 1, 2022, the Plan’s name was changed to Momentum Agencies Retirement Plan.

**Plan Termination**

The Board of Directors of Momentum Agencies (the “Sponsor”) voted on January 18, 2015, to terminate the Plan. The vote of termination did not set a termination date but Plan management is working toward termination and therefore considered liquidation of the Plan to be imminent upon the decision to terminate the Plan. The intent of the termination is to merge the assets of the Plan into the Plan Sponsor’s 403(b) plan, and therefore, upon termination of the Plan, participants will be 100% vested in their account balances and will be provided the opportunity to transfer their account balances to the Sponsor’s 403(b) plan. Notes receivable from participants will be merged with the other assets at their outstanding balances.

In accordance with Generally Accepted Accounting Principles (“GAAP”), the Plan has changed its basis of accounting used to value Plan assets from the ongoing plan basis to the liquidation basis for the years ended June 30 2024, and 2023. However, contract value is the relevant measurement attribute for the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Therefore, contract value is an appropriate determination of fair value.

**Eligibility**

The Plan is a defined contribution plan that includes all employees who have one year of service, minimum of 1,000 hours of service, and are age 21 or older. The participant enters the Plan on the July 1 or January 1 following or coinciding with completion of requirements. Refer to the Plan documents for further detail and definitions.

The Plan was established and became effective July 1, 1996 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

Each year, at the option of the Plan Sponsor’s board of directors, the Sponsor may make a profit-sharing contribution to the Plan. Participants direct the contributions into various investment options offered by the Plan. If a participant does not direct contributions, the contributions are credited to the American Century One Choice Investments fund. There are no participant contributions in the Plan. For the years ended June 30, 2024 and 2023, the Plan Sponsor elected not to make a profit-sharing contribution.

Participant Accounts

Each participant's account is credited with allocations of the Plan Sponsor's profit-sharing contributions, as well as Plan earnings. Participants' accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting is based upon years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range up to 5 years, or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates range from 4.25% to 9.50% for notes existing as of June 30, 2024, and between 4.25% to 9.25% for notes existing as of June 30, 2023. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or monthly, quarterly, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited Accounts

At June 30, 2024 and 2023 forfeited non-vested accounts totaled \$1,555 and \$325, respectively. These accounts will be used to first pay Plan administrative expenses then to reduce future employer contributions. For the years ended June 30, 2024, and 2023 employer contributions were not reduced by using the forfeitures account. For the year ended June 30, 2024, there were administrative fees paid from the forfeitures account totaling \$4,884. The Sponsor of the Plan may absorb all other administrative costs of the Plan (e.g. audit fees and third-party administrator fees).

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the liquidation basis of accounting at June 30, 2024 and 2023 and for the years then ended. See Note 1 for further details.

Use of Estimates

The preparation of financial statements in conformity with Generally Accepted Accounting Principles (“GAAP”) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s assets are held in a fully benefit-responsive investment contract and the financial information is reported to the Plan at contract value. Contract value is an appropriate determination of fair value because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at June 30, 2024, and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. For the years ended June 30, 2024, and 2023, there were there were no excess contributions.

Payments of Benefits

Benefits are recorded when paid. At June 30, 2024, there was \$82,145 of participant-initiated benefits that were paid on July 2, 2024.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan and are included in the accompanying financial statements. Fees related to the administration of notes receivable and distributions from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation or (depreciation) of fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under GAAP are:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024, and 2023.

Pooled Separate Accounts: Valued at the daily closing price as described in the group annuity contract with American United Life Insurance Company (“AUL”) and is directly related to the net asset value (NAV) of the shares of the underlying investment adjusted for any dividends or distributions received by AUL and the daily equivalent of any fee charged by AUL pursuant to the contract.

The following table sets forth the Plan’s assets at contract value, which is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts (See Notes 2 and 9) as of June 30, 2024, and 2023.

NOTE 4 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by AUL which is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation or (depreciation) in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 1, for the year ended June 30, 2024, the Plan paid \$4,884 in administrative fees from the forfeitures account and for Plan audit and third-party administrator fees. The Plan Sponsor pays directly any other fees related to the Plan's operations.

NOTE 5 – PLAN TERMINATION

The Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

The board of directors of the Sponsor voted on January 18, 2015 to terminate the Plan. See Note 1 for details.

NOTE 6 – TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated February 6, 2003, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan was amended December 18, 2009, and again on April 29, 2015 to remain in compliance with applicable laws and regulations of the Department of Labor and Internal Revenue Service. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's annual tax return generally remains open for examination for the three preceding years.

NOTE 7 – ADMINISTRATION OF PLAN ASSETS

Certain administrative and accounting functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE 8 – PARTY-IN-INTEREST TRANSACTION

Certain Plan investments are managed by AUL. American United Life Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were netted in the return of each investment.

NOTE 9 – GROUP ANNUITY CONTRACT WITH AMERICAN UNITED LIFE INSURANCE COMPANY

In 2010 the Plan entered into a fully benefit-responsive investment contract with AUL. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the accompanying financial statements at contract value as reported to the Plan by AUL. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. As described in Note 2, contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletions of equity wash provisions, 3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exempt under ERISA, 5) premature termination of the contract. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with the participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include 1) an uncured violation of the Plan's investment guidelines, 2) a breach of a material obligation under the contract, 3) a material misrepresentation 4) a material amendment to the agreement without consent of the issuer.

NOTE 10 – ASSETS HELD BY AMERICAN UNITED LIFE INSURANCE COMPANY

On July 1, 2010, the Plan entered into a group annuity contract with AUL as investments in separate accounts which in turn invest in underlying funds. Plan participants own units of an AUL separate account, not shares of any underlying fund. The contract's investments are included in the accompanying financial statements at contract value which is the relevant measurement attribute. Asset values are certified by AUL in accordance with Section 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 11 – RISKS AND UNCERTAINTIES

The Plan invests, at the direction of the participants, in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with the investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

At June 30, 2024 and 2023, the Plan had assets of \$549,219 and \$537,424, respectively, held in AUL's Fixed Income Fund and Stable Value Fund, respectively. These accounts are interest bearing accounts that are backed by AUL's general account assets. All assets in these funds earn a guaranteed interest rate until AUL declares a new guaranteed interest rate that becomes effective January 1 of each calendar year. At June 30, 2024 and 2023, the Plan's assets in these funds represent 10% and 12%, respectively, of total Plan assets.

NOTE 12 – OTHER INCOME

For the year ended June 30, 2024, the Plan Sponsor deposited \$1,295 to the Plan for reimbursement of expenses.

NOTE 13 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

For the years ended June 30, 2024, and 2023 there was no difference between the accompanying financial statements and Form 5500.

NOTE 14 – SUBSEQUENT EVENTS

Subsequent events were evaluated through April 10, 2025, which is the date the financial statements were available to be issued.
