## Independent Auditor's Report

To the Plan Administrator of the

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Achievement First, Inc. 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

*Supplemental Schedule Required by ERISA*

The supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i) as of June 30, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### Note 1 - Description of Plan

The following description of Achievement First, Inc. 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

##### **General**

The Plan is an Internal Revenue Code (the "IRC") Section 403(b) defined contribution retirement plan covering all employees of Achievement First, Inc., Achievement First Bridgeport Academy, Inc., Achievement First Hartford Academy, Inc., Amistad Academy, Inc., Elm City College Preparatory Academy, Inc., Achievement First Brooklyn Charter Schools, and Achievement First Rhode Island, Inc. (collectively, the "Company"). Nonresident aliens and students performing services are excluded from participating in the Plan. Eligible employees are immediately eligible to make elective deferrals and are eligible to receive employer contributions with a minimum age of 21 and minimum service requirement of 1,000 hours in the applicable Plan year. Employment by the Company on the last day of the Plan year is required for a participant to receive an employer contribution. Employees who are part of a collective bargaining agreement are not eligible to receive employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

State Street Bank and Trust Company ("State Street") is the custodian, and Transamerica Financial Life Insurance Company, Inc. ("Transamerica") is the recordkeeper to the Plan. All contributions are remitted into assets held with State Street. Participants have the ability to transfer assets held with The Variable Annuity Life Insurance Company ("VALIC") to State Street.

##### **Contributions**

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 or who have completed at least 15 years of service before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company contributed 100 percent of the first 4 percent of base compensation that a participant contributes to the Plan up to a maximum matching contribution of \$2,500. Effective July 1, 2023, the Company removed the maximum matching contribution amount of \$2,500 and contributes 100% of the first 4 percent of base compensation. Additional discretionary nonelective contributions may be contributed at the option of the Company and are allocated to participants proportionately based on participant's compensation compared to total compensation. For the year ended June 30, 2024, the Company did not make a nonelective contribution. Contributions are subject to certain Internal Revenue Service (the "IRS") limitations.

Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The Plan currently offers various variable annuity contracts, mutual funds and two fixed annuity contracts as investment options for participants.

#### Participant accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Investment expenses are paid directly from the underlying assets of the respective investments and are included in net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. In the event of termination due to death, total and permanent disability, normal or early retirement, participants shall become 100% vested in the Company contribution portion of their account. For all other participants, vesting in the Company contribution portion of their account is based on credited years of service, as defined by the Plan, according to the following schedule:

<u>Years of service</u>	<u>Vested percentage</u>
Less than 3	0%
More than 3	100%

#### Payment of benefits

On termination of service, a participant may elect a lump-sum amount equal to the value of the participant's vested interest in his or her account, as defined in the Plan. The Plan includes an automatic cash out provision where participants with a vested account balance less than \$5,000 will receive a lump-sum distribution as soon as it is administratively practicable immediately following their separation from service with the Company.

Withdrawals from a participant's account balance may be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Additionally, in-service withdrawals are allowed in accordance with the provisions specified in the Plan for participants who have attained age 59-1/2.

#### Notes receivable from participants

Participants may borrow from the Transamerica portion of their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. The loan interest rate on borrowing is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions.

#### Forfeited accounts

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$326,777 and \$1,018,321, respectively. These amounts shall be used to reduce Company contributions or to pay Plan expenses. Employer contributions and Plan expenses were reduced by \$1,015,613 and \$0, respectively, during the year ended June 30, 2024.

#### Note 2 - Summary of accounting policies

##### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

##### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment valuation and income recognition**

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. For variable annuity contracts, dividends are included in the net appreciation in fair value of investments. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023.

##### **Payment of benefits**

Benefits are recorded when paid.

##### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Certain portfolio fees are paid by the Plan by reducing the balances of applicable participants.

##### **Subsequent events**

The Company has evaluated subsequent events through April 7, 2025, which is the date the financial statements were available to be issued.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Variable annuity contracts:* Investments are held in separate accounts that include mutual funds valued at the net asset value ("NAV") per share at the close of each business day as reported by each fund, which is then adjusted for dividends and separate account fees. This value is deemed equivalent to NAV, which is used as a practical expedient to estimate fair value. The accounts allow for daily redemptions and contributions.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### Note 4 - Investment contract with insurance company

The Plan holds fixed annuity contracts with VALIC, an insurance company, via investments in the VALIC Fixed Account Plus ("FAP") and the VALIC Short-Term Fixed Account ("STF"). Participants who choose to invest in these options make contributions that purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. VALIC maintains the contributions in a general account. These contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The investment contracts held by the Plan are guaranteed investment contracts. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting interest rates are based on formulas agreed upon with the issuer and ranged between 3.00 percent and 3.25 percent during the year ended June 30, 2024, and between 1.75 percent and 3.00 percent during the year ended June 30, 2023, and have the potential for additional interest if declared by VALIC. The minimum guaranteed interest rate varies by participant and depends on the date the participant established their account. These minimums apply to all VALIC fixed options under the contract. Such interest rates are reviewed on a monthly basis for resetting. The contracts cannot be terminated before the scheduled maturity date.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, premature termination of the contracts, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. VALIC currently permits transfers of up to 20 percent per year from the FAP during the accumulation period. Once a transfer has been made into the STF, no transfers from this account are permitted for 90 days during the accumulation period.

Although management has no intentions of terminating the group annuity investment contract, which provides for the benefit-responsive investment contract and the variable annuity contracts in which the Plan invests, certain provisions could impact the liquidity and the value of the contract upon termination.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

#### **Note 5 - Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in the Company contribution portion of their account.

#### **Note 6 - Plan loans**

In addition to the notes receivable from participants described in Note 1, participants invested in the VALIC portion of the Plan may borrow from VALIC a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance using the assets in the participant's tax deferred annuity portion of their account as collateral. Under this arrangement, VALIC has the right to collect the collateral in the event of default. At June 30, 2024 and 2023, Plan loans totaling \$168,905 and \$163,454, respectively, were outstanding under this arrangement, of which \$105,611 and \$106,675, respectively, were in default.

#### **Note 7 - Tax status**

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71 and the draft Listing of Required Modifications issued April 4, 2009. The volume submitter plan document, which the Plan has adopted in a nonstandardized adoption agreement, obtained its latest advisory letter on March 31, 2017, in which the IRS stated that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8 - Related party transactions and party-in-interest transactions**

The Plan's investments are fixed and variable annuity contracts managed by VALIC and mutual funds managed or held by State Street. VALIC and State Street are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions.

#### **Note 9 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 10 - Certified financial information**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at June 30, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended June 30, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by State Street Bank and Trust Company and Variable Annuity Insurance Life Company, the custodians, and Transamerica Financial Life Insurance Company, Inc., the recordkeeper of the Plan.
