We have performed audits of the financial statements of Illinois Action for Children Employee 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Basis for Opinion***

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Illinois Action for Children Employee 401(k) Plan ("Plan") is a defined contribution Plan sponsored by Illinois Action for Children ("the Organization") that covers all full-time employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Participation: Employees are eligible to participate in the Plan after they have completed 250 hours within three months of employment and attained the age of 21. Once the age and service requirements have been attained, participants may begin contributing to the Plan immediately.

Contributions: Participants in the Plan may contribute amounts up to the maximum allowed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Organization contributes a safe harbor match to the account of each participant 100% of the first 3% of employee contributions made plus 50% of the next 2%. Additional amounts may be contributed at the discretion of the Board of Directors. No profit sharing contributions were made for the plan year ended June 30, 2024.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Safe harbor matching contributions are 100% vested. Discretionary match and profit sharing contributions are subject to a five year graded schedule.

Participant Accounts: Each participant's account is credited with the participant's own contribution and an allocation of (a) the Organization's contribution, (b) Plan earnings/loss, and is charged with (c) his or her withdrawals and (d) an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The number of loans a participant may have outstanding at any one time is two. Loan terms range from 1 to 5 years or over a reasonable period of time for the purchase of a primary residence (30 years). The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates, prime rate plus 1%, as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Distributions: The balance in a participant's account is distributable upon termination of the participant's employment for any reason, including death, retirement, permanent disability, resignation, or dismissal. A participant who has not terminated employment may be entitled to distribution of his or her account upon the attainment of the age of 59½. The distribution will be made in the form of a single-sum payment, or partial withdrawal at the option of the participant.

Participants employed by the plan sponsor may make hardship withdrawals prior to attaining the age of 59½, but these withdrawals may be subject to additional taxes and certain penalties.

Expenses: Withdrawal charges are paid by the Plan and included in benefit payments reported by the Plan. Investment management fees are charged to the Plan as a reduction in the Plan's investment income and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Organization.

Investments: Participants can direct the investment of their accounts in 1% increments into a variety of investment options offered by the Plan. Participants may change their investment options at any time.

Forfeitures: At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$8,077 and \$5,584, respectively. These accounts will first be used to pay plan expenses, then to reduce future employer contributions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, and credit risks as well as the risks associated with global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefit Payments: Benefits are recorded when paid.

**NOTE 3 - RIGHTS UPON PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

**NOTE 4 - TAX STATUS OF THE PLAN**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

**NOTE 4 - TAX STATUS OF THE PLAN (Continued)**

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

**NOTE 5 – CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the trustee of the Plan).

**NOTE 6 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs when measuring fair value. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust Fund: The Plan holds units in a stable value collective trust. The fair values of interests in the stable value fund is based upon the net asset values of such funds reflecting all investments at fair value, including direct and indirect interest in fully benefit-responsive contracts as reported in the audited financial statements of the Fund. There are no significant restrictions or advance notification requirements in connection with this investment.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Organization.

As of June 30, 2024 and 2023, the Plan holds investments in a collective trust and mutual funds managed by JPMorgan, an affiliate of the plan record keeper. These investments qualify as party-in-interest investments. Notes receivable from participants, as well as any expenses paid directly or indirectly by the Plan, qualify as party-in-interest transactions.
