Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1 DESCRIPTION OF PLAN

The following description of the ACERO 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective September 1, 2007. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective January 1, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan administrator is responsible for oversight of the Plan.

Eligibility

Employees of ACERO Schools (the Company) are eligible to participate in the Plan on the first day of each quarter after reaching 21 years of age, except for employees of a related employer who have not adopted this Plan or interns of the Company.

In order to receive a Company matching contribution, participants must have worked at least 500 hours of service during the Plan year or be employed on the last day of the Plan year, must not be a part of the Chicago Teachers Pension Fund, and must meet all other eligibility requirements noted above.

Contributions

Participants may contribute up to 100% of annual compensation, as defined in the Plan, as pre-tax contributions, subject to certain Internal Revenue Service (IRS) limitations. Effective January 1, 2024, participants may elect to contribute through a Roth contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan allows for Company matching contributions for all participants who are a member of the Chicago ACTS union. The matching contribution for union participants is declared annually by the related collective bargaining agreement for each school year.

The Company may also declare a discretionary matching contribution for all participants who are not a member of the Chicago ACTS union or the Chicago Teachers Pension Fund. The Company's board of directors approved a benefit policy which provides for the Company's matching contributions to be consistent between union and nonunion participants.

During the Plan years ended June 30, 2024 and 2023, Company matching contributions for all eligible participants were based on 100% of a participant's elective deferral up to 8% and 7% of eligible compensation, respectively. In order to receive the Company matching contribution, a participant must be employed on the last day of the Plan year or work 500 hours of service during the Plan year.

Contributions (Continued)

The Company may, at its discretion, elect to make discretionary profit sharing contributions in an amount to be determined at Plan year-end by the Plan's management. Participants are considered eligible for the profit sharing contribution, if any, if they are employed by the Company on the last day of the Plan year. For the years ended June 30, 2024 and 2023, the Company made no discretionary profit sharing contributions.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and allocations of the Company's profit sharing contribution, if any, Plan earnings or losses and administrative expenses. Allocations are based on participant compensation, participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contribution portion of their accounts is based on years of continuous service. A participant becomes 20% vested after one year of completed service and 20% each year thereafter until fully vested after five years.

Vesting in the Company's matching contribution portion of their account is based on years of continuous service. Participants who are credited with at least one hour of service on or after March 1, 2017 will be vested in accordance with a two-year cliff vesting schedule for Company matching contributions. Participants will be 100% vested after two years of credited service. Participants that do not earn an hour of service after March 1, 2017 will remain subject to the prior vesting schedule for Company matching contributions. Previously participants became 25% vested after two years of completed service and 25% each year thereafter until fully vested after five years.

Participants become fully vested in the Company's contributions upon death, total disability, normal or early retirement of the participant, as defined, or the termination of the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes must be repaid in five years or less and are secured by the balance in the participant's account and bear interest at a reasonable rate as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions based upon an established amortization schedule.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Benefit Payments

Upon termination of service due to death, disability, retirement, or other reasons a participant with a vested balance of less than \$5,000 will receive a single lump-sum distribution. Participants or their beneficiaries who have a balance greater than \$5,000 may elect to receive the total vested balance in a lump-sum distribution or an annuity or may leave the balance in the Plan until minimum distribution is required. If the participant selects an annuity, the amount of the payments will depend on the age of the participant.

A participant becomes entitled to benefits under the Plan upon reaching the early retirement age, if no longer employed by the Company, permanent disability, death, or resignation from the Company. In-service withdrawals are allowed only from a participant's rollover portion of their account, at any time. Participants may withdraw voluntary contributions from their accounts by reason of financial hardship under specific guidelines set forth in the Plan.

Forfeited Accounts

Forfeited nonvested accounts are first used to pay administrative expenses and then are used to offset future Company contributions. Forfeited nonvested accounts as of June 30, 2024 and 2023 totaled \$1,081 and \$7,227, respectively. There were \$22,367 and \$34,858 of forfeitures used to pay administrative expenses and no forfeitures were used to offset Company contributions during the years ended June 30, 2024 and 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 or 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan agreement.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees incurred in connection with the general administration of the Plan and fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through April 7, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Matrix Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of June 30, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at June 30, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund: Valued at a stable \$1.00 NAV per unit, which is the value at which the fund is traded and approximates fair value of the underlying investments.

Collective Trust Funds: Valued at the NAV of units of the collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company contributions.

NOTE 6 PARTY-IN-INTEREST TRANSACTIONS

The Plan has several arrangements with service providers. The Plan made direct payments to these service providers totaling \$112,980 and \$157,127 for the years ended June 30, 2024 and 2023, respectively. These transactions are party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

NOTE 7 PLAN TAX STATUS

The Plan, through its adoption of a prototype plan from Correll Co., the recordkeeper, has obtained opinion letters issued to the recordkeeper from the IRS stating that the prototype plan is qualified under Section 401(a) of the Internal Revenue Code (IRC) and that any company adopting this plan will be considered to have a qualified plan under Section 401(a) of the IRC. The prototype plan opinion letter has been relied upon by this Plan. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
