Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have audited the financial statements of The Baldwin School Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Note 1- Description of the Plan

The following description of The Baldwin School Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by The Baldwin School of Puerto Rico, Inc. (the School or the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Puerto Rico Internal Revenue Code (the Code).

Eligibility

The Plan covers all employees of the School who reside in the Commonwealth of Puerto Rico. Employees become automatically eligible to participate in the Plan after completing one year of service, as defined, and have attained 21 years of age.

Contributions

Participants may contribute up to 10% of their compensation to the Plan, not exceeding the maximum deferral amount allowed by local law. Participants who have attained age fifty (50) before the end of the Plan year are also eligible to make catch-up contributions.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct all of the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and an open deposit account as investment options for participants.

Employees in full-time employment at the School with up to ten (10) years of service receive a matching contribution of 2%, if the employee makes a contribution of 2% or more. For employees in full-time employment with more than ten (10) years of service, the matching contribution is 4% of the annual employee's compensation, if the employee makes a contribution of 4% or more. The School will not make a contribution above 2% or 4% (depending of the years of service).

The School may also make additional discretionary contributions to the Plan out of its net earnings in such amounts as the School may determine. Profit sharing contributions, if any, are based on a percentage of employees' salaries.

Note 1- Description of the Plan – (continued)

Participant accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer matching and profit-sharing contributions, as well as the participant's share of the Plan's income and related administrative expenses, if any.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the School's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested in their profit sharing and matching contributions after three years of credited service, as defined.

Forfeited accounts

Upon termination from employment or withdrawal from the Plan for any reason other than death, retirement or disability, the School's contributions not then vested are forfeited and used to reduce future School contributions. There were no forfeited non-vested accounts as of June 30, 2024 and 2023.

Notes receivable from participants

Notes receivable from participants are not permitted.

Payment of benefits

On retirement, death, disability, or termination of service, a participant or its beneficiary may elect to receive a lump-sum distribution equal to the participant's vested account balance, or a direct rollover distribution to an individual retirement account or to another qualified plan. In addition, hardship withdrawals are permitted if certain criteria are met, however, hardship withdrawals from after-tax participant contributions and from the School's contributions are not allowed.

The Plan also provides for certain withdrawals during employment, as follows:

Normal retirement age - A participant will be fully vested and may retire after the latter of reaching age 65 or the fifth anniversary of the first day of the Plan year in which he or she commenced participating in the Plan. In addition, once the participant has reached 70 ½ years old, an automatic in-service lump-sum distribution is made, unless the participant submits a written rejection of the distribution.

Note 1- Description of the Plan – (continued)

Payment of benefits – (continued)

Disability retirement - A participant will be fully vested and may retire prior to normal retirement age upon becoming disabled.

Early retirement age - A participant will be fully vested and may retire prior to normal retirement age upon reaching age sixty (60) and completing five years of service.

If the participant terminates their employment before reaching the normal or early retirement age, the participant shall be allowed to apply for an early distribution of their vested account balance.

In addition, participants may be allowed to make financial hardship in-service withdrawals from their vested balances, as special disaster distributions, as determined by the Puerto Rico Treasury Department.

Administrative expenses

Certain administrative expenses are paid by the Plan, unless otherwise paid by the School. Expenses that are paid directly by the School are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Plan termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan's termination, participants will become fully vested in their account balances.

Note 2 - Summary of significant accounting policies

Basis of accounting

The accompanying financial statements have been prepared using the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Note 2 - Summary of significant accounting policies – (continued)

Investment valuation and income recognition

The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) in fair value of investments, includes the Plan's gains and losses on investments bought and sold as well as held during the year. During the year ended June 30, 2024, the Plan's investments appreciated in value by \$1,390,656.

Risks and uncertainties

Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of benefits

Benefits are recorded when paid.

Benefits payable

The Plan accounts for benefits payable in accordance with guidance provided by the American Institute of Certified Public Accountants (AICPA) *Audit and Accounting Guide, Audits of Employee Benefit Plans*. This guidance requires that benefits payable to persons who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as a liability of the Plan. Benefit payments are recorded when paid. There were no benefits payable as of June 30, 2024 and 2023.

Note 3 - Information certified by the Plan's Trustee (unaudited)

The Plan administrator has elected the method of compliance permitted by Section 103(a)(3)(C) of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of the Plan, Banco Popular de Puerto Rico (the Trustee), has certified as to the completeness and accuracy of all investment related information reflected in the accompanying financial statements as of June 30, 2024 and 2023, and for the year ended June 30, 2024, and the related notes to the financial statements, and the schedule H, Part IV, line 4i – schedule of assets (held at end of year) as of June 30, 2024. The Trustee maintains all records, executes investments transactions, and holds all the assets of the Plan. In addition, the Trustee, upon authorization from the Plan administrator, distributes benefit payments to the participants.

Note 4 - Fair value measurements

In accordance with the provisions of Financial Accounting Standards Board, Accounting Standards Codification (ASC) No. 820, *Fair Value Measurement*, the Plan uses valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs to the extent possible to estimate fair values. The Plan determines fair values based on assumptions that market participants would have used in pricing an asset or liability in the principal or most advantageous market.

ASC No. 820 provides a fair value hierarchy that prioritizes the use of observable inputs in the valuation techniques used to measure fair value, as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used by the Plan for investments measured at fair value at June 30, 2024 and 2023:

Mutual funds – Investments in mutual funds consist of shares of mutual funds that are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan consist of open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and were categorized as Level 1.

Money market funds - Money market funds are valued at cost, plus accrued interest, which approximates fair value. These investments are classified as Level 1.

Note 4 - Fair value measurements – (continued)

Deposit open accounts - Deposit open accounts are valued at cost, plus accrued interest, which approximates fair value. These investments are classified as Level 1.

The preceding methods described may have resulted in fair values that may have not been indicative of net realizable values. The use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in different fair value measurements at the reporting date. The Plan management believed its valuation methods were appropriate and consistent with other market participants.

Note 5 - Party-in-interest transactions

Certain Plan assets consist of cash deposits in accounts managed by the Trustee. Therefore, related transactions qualify as party-in-interest transactions.

Note 6 - Tax status

The Plan constitutes a qualified plan, exempt from income taxes under the provisions of the Code. The Plan obtained a favorable determination letter on July 19, 2012, in which the Commonwealth of Puerto Rico tax authorities stated that the Plan was in compliance with the applicable requirements of the Code.

The Plan has been amended since receiving its determination letter, however, the Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Code and the Plan and related trust continue to be tax exempt.

Management has evaluated the tax positions taken by the Plan and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that will require adjustment to the financial statements.

Note 7 - Subsequent events

The Plan has evaluated subsequent events through April 1, 2025, which is the date the financial statements were available to be issued. No events have occurred subsequent to the statement of net assets available for benefits date and through the date the financial statements were available to be issued, that would require additional adjustments to, or disclosure in, the financial statements.
