**NOTE 1 – DESCRIPTION OF PLAN**

Florence Crittenton Services 403(b) Plan (the Plan) is a defined contribution plan originally established by Florence Crittenton Services of Orange County, Inc. (a non-profit organization) (the “Organization”) on January 1, 2010 to encourage and assist eligible employees of the Organization to adopt a regular program of savings to provide additional security for retirement. The Plan was amended and restated effective July 1, 2023 is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The following description of the Plan provides only general information. Participants should refer to the legal plan document for a more complete description of the Plan’s provisions.

Eligibility: All employees of the Organization, with the exception of non-resident aliens, are eligible to make contributions to the Plan upon hire.

Contributions: Participants may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan on a pre-tax or Roth basis as a salary deferral, not to exceed the dollar limit set by law. If a participant is at least age 50 or will attain age 50 before the end of a calendar year, then the participant may defer additional amounts as catch-up contributions. The Plan also allows special 403(b) catch-up contributions for employees that have more than fifteen years of service. Special 403(b) catch-up contributions are not eligible to be matched.

If a participant does not submit a salary deferral agreement or does not specifically decline to make salary deferrals, the Company will automatically withhold 3% from their pay and contribute it to the Plan on the participant’s behalf in the form of an automatic elective deferral. The election will remain in effect until the participant modifies or terminates the election. Participants may revoke or make modifications to their salary deferral election at any time.

The Organization makes a matching contribution equal to 100% of each participant’s deferral, up to 4%. In order to receive a matching contribution, participants must have completed a year of service.

The Plan permits the Organization to make discretionary matching contributions to the participants’ accounts for those eligible participants who make elective deferrals, as defined by the Plan. If the employer makes the discretionary matching contribution, the percentage is allocated proportionately to the participants’ specific salary deferral accounts. For the years ended June 30, 2024 and 2023, the Organization made discretionary matching contributions of \$185,027 and \$-0-, respectively.

Participants are permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs as rollover contributions.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, employer contributions, rollovers, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are always 100% vested in all of their Plan accounts.

**NOTE 1 – DESCRIPTION OF PLAN (Continued)**

Forfeited Accounts: Forfeitures consist of excess employer match contributions removed from participant accounts and are used, at the discretion of the Organization, to reduce future Organization contributions. There were no forfeited balances used during the years ended June 30, 2024 and 2023 to fund discretionary matching contributions. At June 30, 2024 and 2023, there were \$-0- and \$3,992, respectively, of forfeited amounts available to offset future Company contributions or pay Plan expenses.

Payment of Benefits: Participants may receive a distribution of the vested portion of their accounts in the Plan due to termination of employment, normal retirement, disability, or death. These payments may be paid in a lump sum payment or paid in installments over time. Account balances less than \$5,000 but greater than \$1,000 may be distributed in a single lump-sum payment. Account balances less than \$1,000 are distributed in the form of a direct rollover to an individual retirement account if no election is made by the participant.

Participants may be entitled to receive an in-service distribution from the Plan from certain accounts prior to termination of employment provided they have attained age 59½. In addition, a hardship distribution may be made to satisfy certain immediate and heavy financial needs that a participant has.

Notes Receivable From Participants: Participants may borrow from their accounts up to 50% of their account balance up to a maximum of \$50,000 reduced by the participant's highest outstanding loan balance in the previous twelve months and the existing loan balance. The minimum loan amount is \$1,000 and participants may only have one promissory note outstanding at a time. The promissory notes are secured by the balance in the participant's account and must be repaid at a fixed interest rate, which is commensurate with local prevailing rates. Promissory notes must be repaid within five years, unless the promissory notes were for the purchase of a principal residence. In this case, the repayment period may be extended to ten years.

Plan Termination: Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through April 10, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)**

Investment Valuation and Income Recognition: The Plan's investments other than fully benefit responsive investment contracts are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan payments and the Organization deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the fiscal year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company ("MATC") and Empower Annuity Insurance Company of America ("Empower"). MATC held a certain amount of the Plan's investment assets and executed investment transactions for the period from November 1, 2023 to June 30, 2024. Empower held a certain amount of the Plan's investment assets and executed investment transactions from July 1, 2023 to June 30, 2024.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1* – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2* – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3* – Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

**NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan has a benefit-responsive guaranteed investment contract (the “Fixed Account”) with Empower. The Fixed Account is a stable value investment contract with a guaranteed rate of return and a guarantee of principal that is backed by the entire general account assets of Empower. The Fixed Account is provided through a group annuity contract issued by the Empower to the Plan. Contributions are maintained in a general account. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the Plan for the Fixed Account can be derived by averaging the quarterly gross interest rates for the fund over the year. The average yield for 2024 was 2.2% and for 2023 was 1.30%.

The Fixed Account meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. The contract value of the Fixed Account was \$23,287 and \$358,881 at June 30, 2024 and 2023, respectively. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the Fixed Account with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 6 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated November 30, 2020 indicating that the non-standardized profit-sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized profit-sharing plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain other third parties. Administrative fees paid to third-party providers are considered party-in-interest transactions. Certain professional fees for the administration and audit of the Plan are paid by the Organization. Various administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. The Plan holds mutual funds issued by Mutual of America and a contract issued by Empower. Mutual of America and Empower are service providers of the Plan, and, therefore, these transactions and the Plan's payment of fees to the service providers qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions.
