Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of VODEC 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Note 1 Description of Plan

The following description of the VODEC 403(b) (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Vocational Development Center, Inc. (the “Organization”). The Plan is subject to the provisions of ERISA. The Organization is the sponsor and administrator of the Plan. The Organization determines the appropriateness of investments and monitors investment performance. The Plan has adopted a master trust agreement with Ascensus as agent for Ascensus Trust Company (the “Service Company”). The Service Company provides trustee and recordkeeping services.

Contributions

Each year, participants may contribute up to the statutory limits, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing pre-tax eligible distributions from other qualified plans and IRAs (rollover distributions). Participants direct the investment of employee and employer contributions into various investment options offered by the Plan. The Organization may make discretionary matching contributions equal to a uniform percentage or dollar amount of elective deferrals each payroll period. Each year, the Organization determines the formula for the discretionary matching contribution. The Organization matches 100% of the first 5% of base compensation that a participant contributes to the Plan. No discretionary contributions were made for the year ended June 30, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Organization's matching contribution. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

After one year of service participants are 100% vested in their contributions and the Organization's matching contribution plus actual earnings thereon.

Participant Loans

Loans are not permitted from the Plan.

Note 1 Description of Plan - Continued

Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or monthly payments from an annuity. Participants with account balances under \$5,000 are required to take a total distribution of their account upon termination. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan Documents.

Note 2 Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Date of Management Review

Management has evaluated subsequent events through April 9, 2025, the date the financial statements were available to be issued.

Payment of Benefits

Benefits are recorded when paid.

Pre-2009 Accounts

Accounts established prior to the U.S. Department of Labor's Notice of Adoption of Revisions to Annual Return/Report Forms issued on November 16, 2007 issued to current or former employees before January 1, 2009 are not included in the plan's financial statements. The employer ceased to have any obligation to make contributions (including employee salary reduction contributions), and in fact ceased making contributions to those accounts as of January 1, 2009. All of the rights and benefits under the accounts are legally enforceable against the insurer or custodian by the individual owner of the accounts without any involvement by the employer. The individual owner is fully vested in those accounts. Starting on January 1, 2013 if employees want to participate in the VODEC 403(b) they are required to establish an account under the master trust.

Note 3 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 Related-Party Transactions and Party in Interest Transactions

The Plan's investments are managed by the Service Company and Merrill Lynch, Pierce, Fenner & Smith, a service provider, and therefore, the transactions qualify as party in interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of the investment. Fees for administrative services are charged pursuant to a Master Plan Services Agreement (MSA) between The Organization and the Service Company, and may be collected directly or indirectly, according to the MSA.

Note 5 Delinquent Participant Contributions

The Organization had no late contributions in the current year.

Note 6 Plan Termination

The Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 7 Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b). The Plan's administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
