Opinion

We have audited the accompanying financial statements of Professional Firefighters of Eastern Missouri, International Association of Firefighters Local 2665 Health and Welfare Trust Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of June 30, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

1. Description of the Plan

The following description of the Professional Firefighters of Eastern Missouri, International Association of Firefighters Local 2665 Health and Welfare Trust Fund (the "Plan") provides only general information. Participants of the Plan should refer to the plan document and the summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a multiemployer defined benefit health and welfare plan. The Plan was established and is maintained pursuant to a collective bargaining agreement ("CBA") between Professional Firefighters of Eastern Missouri IAFF Local 2665 (the "Union") and contributing districts (the "Employers") to provide health and other benefits to eligible participants and beneficiaries. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 ("ERISA"), as amended.

Administration of the Plan is the responsibility of the Board of Trustees (the "Trustees") and is governed by a joint board consisting of equal representation from the Employers and the Union.

Eligibility

Participants, and their beneficiaries, are eligible to receive health and other benefits based on the terms set forth in the CBA between their Employer and the Union.

Contributions

The Employers are required to make monthly contributions to the Plan as required by the applicable provisions of their respective CBAs for their Union employees. Participant contributions are allowed to provide Consolidated Omnibus Budget Reconciliation Act ("COBRA") benefits. Retired participants are also required to make contributions for their benefits.

Benefits

The Plan provides medical, dental, vision, prescription drug, and hearing benefits to eligible participants and beneficiaries. Medical, prescription drug, and hearing benefits are provided through an agreement with the Northwest Fire Fighters Benefit Trust (the "NWFF Benefits Trust") in which monthly payments are made to the NWFF Benefits Trust, allowing participants to receive medical benefits through their health and welfare fund. Dental, vision, short-term disability, long-term disability, and life benefits are provided under group insurance contracts. The premiums for these insured benefits are paid from the assets of the Plan.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan have been prepared in accordance with the provisions of the Financial Accounting Standards Board ("FASB"), Accounting Standards Codification (the "FASB ASC"), which is the source of authoritative, non-governmental accounting principles generally accepted in the United States of America ("GAAP"). All references to authoritative accounting guidance contained in our disclosures are based on the general accounting topics within the FASB ASC.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Fair Value Measurements

The Plan follows guidance issued by the FASB on fair value measurements, which establishes a framework for measuring fair value, clarifies the definition of fair value within that framework, and expands disclosures about the use of fair value measurements. This guidance applies whenever fair value is the applicable measurement. The three general valuation techniques used to measure fair value are the market approach, cost approach, and income approach.

Payment of Benefits

Premiums paid are recorded as insurance premiums in the accompanying statements of changes in net assets available for benefits. Payments made to the NWFF Benefits Trust for medical, prescription drug, and hearing benefits are recorded as medical contributions in the accompanying statements of changes in net assets available for benefits.

Administrative Expenses

The Plan permits the payment of Plan expenses from Plan assets. Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through April 07, 2025, the date on which the financial statements were available to be issued.

3. Change in Accounting Principle

Effective July 1, 2023, the Plan adopted ASU 2016-13, Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments, as amended. FASB ASC 326 replaces the incurred loss methodology with an expected loss methodology that is referred to as the current expected credit loss ("CECL") methodology. CECL Requires and estimate of future credit losses for the remaining estimated lives of financial assets based on relevant information about historical experience, current conditions, and reasonable and supportable financial forecasts that affect the collectibility of the reported amounts. The measurement of expected credit losses under CECL is applicable to financial assets measured at amortized cost. Such assets are presented at the net amount expected to be collected over their remaining contractual lives using an allowance for credit losses. The adoption of FASB ASC 326 resulted in no change in the allowance from credit losses.

4. Fair Value Measurements

The framework for measuring fair value establishes a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value into Levels 1, 2, and 3. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical instruments in active markets.
Level 2	Inputs to the valuation methodology to include quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in inactive markets, inputs other than quoted prices that are observable for the instrument, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The instruments' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value.

Level 1 investments consist of a money market fund and a certificate of deposit. The money market fund and certificate of deposit are valued at cost plus accrued interest which approximates fair value.

5. Related Party Transactions

During the years ended June 30, 2024 and 2023., the Plan leased office space from the Union under a one year lease agreement expiring September 30, 2024 and September 30, 2023, respectively. During both years ended June 30, 2024 and 2023, the Plan paid rent to the Union amounting to \$24,840.

6. Plan Termination

Although they have not expressed any intent to do so, the Trustees have the right under the Plan to modify the benefits provided to eligible active employees. The Plan may be terminated only by joint agreement between the Employers and the Union, subject to the provisions set forth in ERISA.

Should the Plan terminate, any assets remaining shall be used solely for purposes of providing benefits and defraying the reasonable cost of administering the Plan. No assets shall revert to the Employers.

7. Tax Status of Plan

In accordance with GAAP, management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. Management has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2024 and 2023, there were no uncertain positions taken, or expected to be taken, that would require the recognition of a liability or disclosure in the financial statements. The Plan is also subject to routine audits by the Department of Labor generally for six years after the statutory due date of the annual information return. There are currently no audits in progress for any tax periods.

8. Risks and Uncertainties

Concentration of Credit Risk

Financial instruments that subject the Plan to concentrations of credit and market risk consist of cash, investments, and receivables. The Plan maintains its cash primarily with one financial institution. Deposits at this bank are insured by the Federal Deposit Insurance Corporation ("FDIC") up to \$250,000. At June 30, 2024, there were cash balances of \$5,558 in excess of FDIC limits.

Contributions

The majority of contributions are from firefighting districts located in Eastern Missouri. The Plan generally does not require collateral, but in some cases can require a performance bond.


