Opinion

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Employee Stock Ownership Plan for the Employees of Humphrey & Assoc., Inc. (the Plan) provides only general information. Participants should refer to the *Plan Document* for a more complete description of the Plan's provisions, which is available from Plan management.

General

The Plan is a defined contribution benefit plan. It was established in 1980 for the purposes of rewarding employees for their loyal and faithful service, to share with employees a portion of the profits of the employer, and to enable employees to accumulate funds for their later years. A determination letter has been received by the Internal Revenue Service qualifying the Plan under the Internal Revenue Code of 1986 and the Employee Retirement Income Security Act of 1974, as amended. Employees become participants in the Plan, at the next available enrollment date, after they have attained the age of 21 and after completion of 1,000 hours or more of service with the employer during the preceding 12 months.

Contributions

Employer contributions and dividends are discretionary and are determined annually by the board of directors but are limited to the maximum amounts defined by Federal regulations for individual participants. The Plan does not allow for voluntary contributions by employees. For the 2024 and 2023 plan year, the board of directors committed contributions of \$700,000 and \$500,000, respectively. For the 2024 and 2023 plan year, the board of directors declared and paid a dividend of \$25,000 and \$20,000, respectively, which are recorded when declared as reflected in the accompanying statements of net assets available for benefits and statements of changes in net assets available for benefits.

Participant Accounts

Each participant's account is credited with an allocation of (a) the sponsor's contribution, (b) plan earnings, and (c) eligible forfeitures of terminated participants. Allocations are based on the proportion of each participant's compensation to the total compensation of all participants.

Vesting

Full vesting in the Plan will occur upon completing 3 years of service, retirement (after the participant attains the normal retirement age of the Plan of 55), suffering permanent and total disability, or upon death. If termination with the employer occurs for any reason other than the above circumstances and the participant has less than 3 consecutive 1,000-hour periods, the employee has no vested interest.

Payment of Benefits

Upon separation of service due to death, disability, retirement or termination of employment, mandatory distributions are made for any vested account balances less than \$1,000. Distributions of any vested account balances greater than \$1,000 but less than \$25,000 are made in accordance with the participant election as defined in the plan document either in lump sum payment or in equal installments over a five-year period. Distributions of \$25,000 or greater are paid in equal installments over a five-year period.

Notes to Financial Statements

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Employer Securities acquired by the Trust on or before December 31, 1986 shall not be considered as part of an account balance eligible for diversification. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify may have an option to receive a cash distribution or to transfer the elected amount to another qualified employee benefit plan. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

Forfeited Accounts

Forfeitures arising from participants with less than fully vested interests in the Plan are considered interfund transfers. Forfeitures are allocated in the same manner as employer contributions. There were \$1,603 and \$273 allocated forfeitures within the Plan at June 30, 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. If available, quoted market prices are utilized to value investments. For financial reporting purposes, the fair value of the Company's common stock, which is not a publicly traded security, is determined by the most recent annual independent appraisal available at June 30, 2024 and 2023 as derived by a third party valuation expert based upon management data and assumptions provided.

Due to the common stock appraisal process, it is possible that changes in the value of the common stock will occur and that such changes could affect the amounts reported in the statement of net assets available for plan benefits. All investments are non-participant directed.

Dividends are recorded when declared and interest income is recorded when earned. Purchases and sales of securities are recorded on the settlement date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Notes to Financial Statements

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest either in a lump sum or over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Administrative Expenses

As provided by the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses for the Plan.

Management's Review of Subsequent Events

The Plan has evaluated subsequent events through April 11, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been changes in the methodologies used at June 30, 2024 and 2023.

Money market funds: Valued using the NAV of the fund shares.

Company common stock: Valued at estimated fair value based upon an independent appraisal. This appraisal was based upon the discounted cash flow capitalization and the merger and acquisition methods at June 30, 2024 and 2023.

Plan management accumulates the data for the appraiser from audited financial statements of the Company. The appraiser prepares a report of estimated per share value that a participant will receive upon distribution. Plan management, along with the ESOP trustee, reviews in detail, discusses and approves the report. The results of the process are documented in the minutes of the Plan fiduciary.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of common stock of Humphrey & Assoc., Inc. Humphrey & Assoc., Inc. is the sponsor for the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

Note 6. Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Humphrey & Associates ESOP Committee directs the Trustee to pay all liabilities and expenses of the ESOP. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

Note 7. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated September 13, 2013, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Plan management believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rates, market and credit risks. Market values of investments may decline for a number of reasons, including changes in prevailing market and interest rates, increases in defaults and credit rating downgrades. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
