## INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of  
U.A. Local 38 Childcare Plan:

### Opinion

We have audited the financial statements of U.A. Local 38 Childcare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, which comprise the statements of net assets available for benefits and of benefit obligations as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of U.A. Local 38 Childcare Plan as of June 30, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of U.A. Local 38 Childcare Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

**1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of U.A. Local 38 Childcare Plan (the “Plan”) are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation, Transactions and Income Recognition**

*General*

Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs are those that reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

*Level 1* - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

*Level 2* - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

*Level 3* - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations or some other pricing method using unobservable inputs.

*Inputs and Valuations Methods*

In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for each of the Plan’s investment classes are presented below.

*Money Market Deposit Account:* The fair value of money market deposit account is based on the total value of all the securities held using the amortized cost method. Generally, the amortized cost approximates the current fair value. The funds seek to maintain a net asset value of \$1.00 (Level 2).

*Valuation Methods, Consistency*

The valuation techniques used in the accompanying financial statements have been consistently applied.

*Transactions and Income Recognition*

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis.

**Contributions Receivable**

Employer contributions due but not paid at year-end are recorded as employer contributions receivable. Allowance for credit losses is considered unnecessary and is not provided. Contributions due as a result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received.

**Benefit Obligations**

Claims payable and incurred but not reported represent amounts paid after year-end to participants who incurred reimbursable childcare expenses on or prior to June 30. The Plan does not provide benefits to retirees. Due to the nature of the benefits provided, no post-retirement benefit obligations are presented on these financial statements.

**One Employee in Contributions**

Includes charges to an outside U.A. Local 38 employer, resulting from the difference in employer contribution rates made on behalf of the members of unrelated local unions who work on construction projects within U.A. Local 38's jurisdictions, and the collectively bargained employers' contribution rates for U.A. Local 38.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Administrative Expenses**

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in money market funds. Such investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**Accounting Pronouncements Currently Adopted**

In June 2016, the FASB issued an Accounting Standards Update ("ASU") 2016-13, *Financial Instruments - Credit Losses* (Topic 326) amending the accounting for credit losses on financial statements. This methodology replaced the incurred loss methodology with the expected credit losses using a wide range of reasonable and supportable information. The amendment affects loans, debt securities, trade receivables, net investments in leases, off-balance-sheet credit exposure and other financial instruments recorded at amortized cost.

The Plan adopted the new standard effective July 1, 2023, using the modified retrospective approach. Comparative prior periods were not adjusted upon adoption. Upon adoption, there was no cumulative-effect adjustment to the opening fund balance.

**2. DESCRIPTION OF THE PLAN**

The Plan was established by the terms of a trust agreement dated July 1, 2020, for the primary purpose of providing childcare reimbursement benefits to eligible Plan participants who perform work covered by collective bargaining agreements between the United Association of Journeymen and Apprentices of the Plumbing and Pipefitting Industry, Local Union 38, and various employer associations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Participants who are active members in good standing with U.A. Local 38 are eligible to receive reimbursement for certain childcare expenses, limited in duration to the date the child completes kindergarten, upon meeting certain eligibility requirements. If the participant is married, the spouse must also have earned income to be eligible for childcare reimbursement under the Plan. Reimbursements are subject to Internal Revenue Service ("IRS") limits of \$5,000 each year (or \$416.66 per month) for married participants filing jointly, unmarried participants, and single participants; and \$2,500 (or \$208.33 per month) if the participant is married but filing separately. Effective January 1, 2025, the Plan will offer a supplemental taxable childcare benefit that will provide the option of receiving up to \$5,000 in additional taxable childcare reimbursements. (refer to Note 9).

Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**3. PRIORITIES UPON TERMINATION**

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

**4. TAX STATUS**

The Plan submitted an application for exemption with the Internal Revenue Service. The Plan obtained its determination letter, dated November 11, 2022, in which the Internal Revenue Service stated that the Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of June 30, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. FUNDING POLICY**

The Plan is financed by employer contributions and one employee in contributions. The monthly employer contribution rate and one employee in contribution charges are agreed to by the parties signatory to the collective bargaining agreements. The Board of Trustees approved allocating a portion of one employee in contributions to the Plan. The Plan uses the one employee in contributions to offset allocable administrative expenses paid by the Joint Administration on behalf of the Plan (refer to Note 6).

**6. RELATED-PARTY TRANSACTIONS**

The Plan and affiliated U.A. Local 38 Trust Funds (the “Trust Funds”) utilize the facilities of the U.A. Local 38 Trust Fund Administration (the “Joint Administration”) office for the collection of contributions, recordkeeping, and disbursements. Common administration expenses are paid by the Joint Administration and then allocated to each of the participating Trust Funds based on the level of administrative services provided. Management estimates the level of administrative services provided based on the time spent by the Joint Administration office staff working on the various Trust Funds. The Plan reimburses the Joint Administration for administrative and professional expenses incurred on behalf of the Plan. The amounts allocated to the Plan as administrative and professional expenses totaled \$44,096 and \$42,452 for the years ended June 30, 2024 and 2023, respectively. Contributions related to one employee in contributions totaling \$5,142 and \$1,804 were used to offset allocable administrative and professional expenses to the fund for the years ended June 30, 2024 and 2023, respectively.

Amounts due to the Joint Administration totaled \$6,283 and \$2,852 as of June 30, 2024 and 2023, respectively.

**7. CONCENTRATION OF CREDIT RISK**

The Plan places its cash with financial institutions. The balances are insured by the Federal Deposit Insurance Corporation for up to \$250,000 per institution. Cash balances regularly exceeded the insured deposit limits. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Plan’s financial condition, results of operations, and cash flows.
