INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of
U.A. Local 38 Holiday and Vacation Fund:

Opinion

We have audited the financial statements of U.A. Local 38 Holiday and Vacation Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, which comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of U.A. Local 38 Holiday and Vacation Fund as of June 30, 2024 and 2023, and the changes in net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of U.A. Local 38 Holiday and Vacation Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the U.A. Local 38 Holiday and Vacation Fund's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of U.A. Local 38 Holiday and Vacation Fund (the “Plan”) are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Contributions Receivable

Employer contributions due but not paid at year-end are recorded as employer contributions receivable. Allowance for credit losses is considered unnecessary and is not provided. Contributions due as a result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received.

Benefit Obligations

The Plan does not provide benefits to retirees and does not have any benefit obligations at year-end. Therefore, there are no benefit obligations presented on these financial statements.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

One Employee in Contributions

One employee in contributions include charges to an outside U.A. Local 38 employer, resulting from the difference in employer contribution rates made on behalf of the members of unrelated local unions who work on construction projects within U.A. Local 38’s jurisdictions, and the collectively bargained employers’ contribution rates for U.A. Local 38.

Administrative Expenses

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Accounting Pronouncements Currently Adopted

In June 2016, the FASB issued an Accounting Standards Update (“ASU”) 2016-13, *Financial Instruments – Credit Losses* (Topic 326) amending the accounting for credit losses on financial statements. This methodology replaced the incurred loss methodology with the expected credit losses using a wide range of reasonable and supportable information. The amendment affects loans, debt securities, trade receivables, net investments in leases, off-balance-sheet credit exposure and other financial instruments recorded at amortized cost.

The Plan adopted the new standard effective July 1, 2023, using the modified retrospective approach. Comparative prior periods were not adjusted upon adoption. Upon adoption, there was no cumulative-effect adjustment to the opening fund balance.

2. DESCRIPTION OF THE PLAN

The Plan was established by the terms of a trust agreement, dated December 31, 1974, for the purpose of providing vacation and holiday benefits to eligible employees performing work covered by collective bargaining agreements between United Association of Journeymen and Apprentices of the Plumbing and Pipefitting Industry, Local Union 38, and various employer associations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Benefits paid to the Plan participants are based on the amounts contributed by employers on behalf of participants, along with allocable interest earned, net of expenses. Participant account balances are 100% vested at all times and are paid out semiannually. Contributions for vacation benefits applicable to the 12 months ended March 31 are disbursed as vacation payments in the following June. Contributions for holiday benefits applicable to the 12 months ended September 30 are disbursed as holiday payments in the following December.

Participants should refer to the summary Plan description and Eligibility Rules and Requirements for a more complete description of the Plan's provisions.

3. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

4. TAX STATUS

The Plan obtained its latest determination letter, dated January 29, 1970, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax exempt as of the financial statements date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of June 30, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. FUNDING POLICY

The Plan is financed by employer contributions and one employee in contributions. The monthly employer contribution rate and one employee in contribution charges are agreed to by the party's signatory to the collective bargaining agreements. The Plan uses the one employee in contributions to offset allocable administrative expenses paid by U.A. Local 38 Trust Fund Administration (the "Joint Administration") on behalf of the Plan as well as administrative expenses paid directly by the Plan (refer to Note 6).

6. UNCLAIMED VACATION AND HOLIDAY BENEFITS

If the amount in a participant’s vacation and holiday account cannot be distributed to a participant within twenty four months after the issuance of the check, due to the lack of a correct address or for any other reasons, or if the participant fails to cash the check within such period, that participant shall be deemed to have elected to contribute such amount to the Plan. The amount shall be used for the purpose of defraying the cost of maintaining the Plan in effect. For the years ended June 30, 2024 and 2023, reverted unclaimed benefits totaled \$4,711 and \$0, respectively.

7. RELATED-PARTY TRANSACTIONS

The Plan and affiliated U.A. Local 38 Trust Funds (the “Trust Funds”) utilize the facilities of the Joint Administration office for the collection of contributions, recordkeeping, and disbursements. Common administration expenses are paid by the Joint Administration and then allocated to each of the participating Trust Funds based on the level of administrative services provided. Management estimates the level of administrative services provided based on the time spent by the Joint Administration office staff working on the various Trust Funds. The Plan reimburses the Joint Administration for administrative expenses incurred on behalf of the Fund. The amounts allocated to the Plan as administrative expenses totaled \$322,388 and \$309,455 for the years ended June 30, 2024 and 2023, respectively. Contributions related to one employee in contributions totaling \$349,020 and \$349,716 were used to offset allocable administrative expenses to the Plan as well as administrative expenses paid directly by the Plan for the years ended June 30, 2024 and 2023, respectively.

As of June 30, 2024 and 2023, \$212,117 and \$279,461, respectively, were due from the Joint Administration.

8. CONCENTRATION OF CREDIT RISK

The Plan places its cash with financial institutions. The balances are insured by the Federal Deposit Insurance Corporation for up to \$250,000 per institution. Cash balances regularly exceeded the insured deposit limits. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Plan’s financial condition, results of operations, and cash flows. As of June 30, 2024 and 2023, cash in excess of the FDIC limit consisted of the following:

9. SUBSEQUENT EVENTS

These events and transactions were evaluated through April 7, 2025, the date that the financial statements were available to be issued, and no items have come to the attention of management that require recognition or disclosure.
