INDEPENDENT AUDITOR'S REPORT

Opinion

We have audited the financial statements of U.A. Local 38 Scholarship Trust Fund of San Francisco, Marin, Sonoma, Mendocino and Lake Counties, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, which comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Basis for Opinion

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of U.A. Local 38 Scholarship Trust Fund of San Francisco, Marin, Sonoma, Mendocino, and Lake Counties (the "Plan") are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Contributions Receivable

Employer contributions due but not paid at year-end are recorded as employer contributions receivable. Allowance for credit losses is considered unnecessary and is not provided. Contributions due as a result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received.

Donations Received

Donations received are recognized as revenue when the donation is received or when the Plan has an unconditional right to receive the donation. Donations are classified as either unrestricted or restricted based on the donor's stipulations. Unrestricted donations are available for use at the discretion of the Plan's management. Restricted donations are subject to specific conditions imposed by the donor and are recognized as revenue when the conditions are met. Donations received for the year ended June 30, 2024, are classified as unrestricted.

Benefit Obligations

The Plan does not provide benefits to retirees and does not have any benefit obligations at year-end. Therefore, there are no benefit obligations presented in these financial statements.

One Employee in Contributions

One employee in contributions include charges to an outside U.A. Local 38 employer, resulting from the difference in employer contribution rates made on behalf of the members of unrelated local unions who work on construction projects within U.A. Local 38's jurisdictions, and the collectively bargained employers' contribution rates for U.A. Local 38.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Accounting Pronouncements Currently Adopted

In June 2016, the FASB issued an Accounting Standards Update ("ASU") 2016-13, *Financial Instruments – Credit Losses* (Topic 326) amending the accounting for credit losses on financial statements. This methodology replaced the incurred loss methodology with the expected credit losses using a wide range of reasonable and supportable information. The amendment affects loans, debt securities, trade receivables, net investments in leases, off-balance-sheet credit exposure and other financial instruments recorded at amortized cost.

The Plan adopted the new standard effective July 1, 2023, using the modified retrospective approach. Comparative prior periods were not adjusted upon adoption. Upon adoption, there was no cumulative-effect adjustment to the opening fund balance.

2. DESCRIPTION OF THE PLAN

The Plan was established by the terms of a trust agreement, dated December 31, 1974, for the purpose of providing scholarship benefits to dependents of eligible employees performing work covered by collective bargaining agreements between United Association of Journeymen and Apprentices of the Plumbing and Pipefitting Industry, Local Union 38, and various employer associations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Scholarships are awarded to dependents of U.A. Local 38 members who meet the eligibility criteria prescribed by the Board of Trustees and who are approved by an Academic Committee. The eligibility criteria include, but are not limited to, the following:

- The applicant must be a dependent son or daughter of an active or retired member of U.A. Local 38;
- The member must have been employed for at least 1200 hours, in total, within the previous four years prior to the application; and
- For the initial award, the applicant must be eligible to enter college and provide high school transcripts and Scholastic Aptitude Test ("SAT") scores.

Participants should refer to the Plan document for a more complete description of the Plan's provisions.

3. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

4. TAX STATUS

The Plan obtained its latest determination letter, dated July 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of June 30, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. FUNDING POLICY

The Plan is financed by employer contributions and one employee in contributions. The monthly employer contribution rate and one employee in contribution charges are agreed to by the party's signatory to the collective bargaining agreements. The Plan uses the one employee in contributions to offset allocable administrative expenses paid by the Joint Administration on behalf of the Plan (refer to Note 6).

6. RELATED-PARTY TRANSACTIONS

The Plan and affiliated U.A. Local 38 Trust Funds (the "Trust Funds") utilize the facilities of the U.A. Local 38 Trust Fund Administration (the "Joint Administration") office for the collection of contributions, recordkeeping, and disbursements. Common administration expenses are paid by the Joint Administration and then allocated to each of the participating Trust Funds based on the level of administrative services provided. Management estimates the level of administrative services provided based on the time spent by the Joint Administration office staff working on the various Trust Funds. The Plan reimburses the Joint Administration for administrative and professional expenses incurred on behalf of the Plan. The amounts allocated to the Plan as administrative and professional expenses totaled \$45,040 and \$43,259 for the years ended June 30, 2024 and 2023, respectively. Contributions related to one employee in contributions totaling \$5,142 and \$1,804 were used to offset allocable administrative and professional expenses to the Plan for the years ended June 30, 2024 and 2023, respectively.

As of June 30, 2024 and 2023, \$37,661 and \$42,343, respectively, was due from the Joint Administration.

7. CONCENTRATION OF CREDIT RISK

The Plan places its cash with financial institutions. The balances are insured by the Federal Deposit Insurance Corporation for up to \$250,000 per institution. Cash balances regularly exceeded the insured deposit limits. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Plan's financial condition, results of operations, and cash flows. As of June 30, 2024 and 2023, cash in excess of the FDIC limit consisted of the following:

8. SUBSEQUENT EVENTS

In preparing these financial statements, management of the Plan has evaluated events and transactions that occurred after June 30, 2024, for potential recognition or disclosure in the financial statements. These events and transactions were evaluated through April 7, 2025, the date that the financial statements were available to be issued, and no items have come to the attention of management that require recognition or disclosure.
