INDEPENDENT AUDITORS' REPORT

To the Plan Trustee
Profit Sharing and Savings Plan for Employees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Profit Sharing and Savings Plan for Employees of Cranesville Block Co., Inc., and Affiliated Companies, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTE 1 – DESCRIPTION OF PLAN

The following description of the Profit Sharing and Savings Plan for Employees of Cranesville Block Co., Inc., and Affiliated Companies (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering full time employees of participating employers who have one year of service, 1,000 hours worked and are age 18 or older, excluding employees covered by any collective bargaining agreements and non-resident aliens with no U.S. income. The Plan is subject to the provisions of ERISA. The Trustees are responsible for the oversight of the Plan.

The Plan was amended effective August 1, 2017, to allow ROTH elective deferral contributions. The most recent Plan amendment was approved June 30, 2020.

As of June 30, 2024 and 2023, participating employers (affiliated companies) in the Plan include:

Contributions

Contributions are subject to Internal Revenue Service (IRS) limitations. The following contributions are allowed by the Plan:

1. Employee Contributions

The Plan allows pre-tax and Roth elective deferrals. Each year, participants may make contributions of up to 100% of pretax annual compensation, as defined in the Plan. Participants who have obtained age 50 before the end of the Plan year are eligible to make catch-up “contributions.” Eligible employees may also contribute amounts representing rollovers or transfers from other qualified plans. Participants may also contribute amounts representing distributions from other qualified plans.

2. Employer Discretionary Contributions

The amount of the annual contribution to the Plan by the employer is determined by the Companies’ Board of Directors. The contribution is not to exceed the maximum amount allowable as a deduction under Section 404 of the Internal Revenue Code. For the years ended June 30, 2024 and 2023, the Companies made gross discretionary profit-sharing contributions of \$344,925 and \$304,927, respectively. For the years ended June 30, 2024 and 2023, forfeitures of \$15,854 and \$23,558, respectively, were used to offset the gross discretionary profit-sharing contributions as per the Plan document.

3. Qualified Nonelective Contributions

The amount of the annual contribution to the Plan by the employer is determined by the Companies' Board of Directors. The Companies did not make a qualified non-elective contribution for years ending June 30, 2024 and 2023.

Investment Options – Participant-Directed

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who do not select an investment option(s) have their contributions invested in the applicable Principal Lifetime Target-Date Fund based on the definition of normal retirement date under the Plan, until such time that the participant makes an investment direction election.

Participants may change their investment options daily.

Participant Accounts

Each participant's account is credited with the participant's contributions, as well as allocations of the Companies' discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation or account balances, as defined in the Plan document. Participants in the Plan pay a maintenance fee which is deducted annually from their account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals plus actual earnings thereon. Vesting in the remainder of their accounts is determined using the elapsed time method, which determines vesting by using the total of an employee's countable periods of service without regard to hours of service and according to the following vesting schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must bear a reasonable interest rate and repayment may not exceed a period of more than five years, unless the purpose of the loan is for the purchase of a participant's principal residence, then up to a ten year repayment period may be permitted. The loans are secured by the balance in the participant's account and a participant can only have one loan outstanding at any time. Principal and interest are paid ratably through payroll deductions. Loan interest rates are set at prime plus 2% at the time the loan request is submitted. A fee is paid by each participant who borrows from the Plan.

Payment of Benefits

At a time when payment of benefits is to begin, the administrator may direct the Trustee to distribute the participant's vested account balance either in a lump-sum amount, a fixed period installment or a fixed payment installment option. If applicable, the installment option payments must meet the minimum distribution requirements. Certain hardship distributions of a participant's deferred contributions are allowable in accordance with the Plan documents. A participant may withdraw rollover contributions at any time. In addition, when participants attain age 59½ and are still working, they may withdraw any part of their vesting account from all contribution sources. Normal retirement age is 65.

Operating Expense

All expenses of maintaining the Plan are paid by the Plan.

Forfeited Accounts

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$15,589 and \$20,433, respectively. These accounts will be used to reduce the current year employer contribution. Forfeitures may be used to offset plan expenses or offset employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No reserve for credit losses have been recorded as of June 30, 2024 and 2023.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determines the Plan's valuation policies utilizing information provided by the Custodian. See Note 4 for discussion of fair market value measurements. Other investments are valued at prices determined by the custodian to represent the fair valuation thereof on the annual valuation date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributes in the subsequent plan year excess contributions to the applicable participant. For plan years ended June 30, 2024 and 2023, there were no excess contributions payable.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 – CERTIFIED INVESTMENTS

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520,103-8 of the Department of Labor's Rule and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, (the Custodian of the Plan) and Principal Life Insurance Company have certified that the following data included in the financial statements and accompanying supplemental schedule is complete and accurate as of June 30, 2024 and 2023, and for the years then ended:

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at net asset value (NAV) per share based on quoted market prices of underlying investments except as otherwise noted.

Collective Investment Trusts: These investments are valued at the NAV of units of the collective trust fund. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective investment trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5 – PLAN TERMINATION

Although they have not expressed any intent to do so, the employers have the right under the Plan to discontinue its contributions and at any time to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, complete or partial, participants would become 100% vested in their employer contributions.

NOTE 6 – TAX STATUS

The Plan is a Principal Financial Group prototype plan and relies on the IRS Opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code and constitutes a qualified plan under Section 401(a). Although the Plan has been amended since receiving the determination letter, the Plan administrator and Plan custodian believe the plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – DUE TO PAST PARTICIPANTS

At June 30, 2024 and 2023, \$1,285,687 and \$1,279,073, respectively, was allocated to accounts of persons who had terminated employment but had not yet been paid their Plan balances. At June 30, 2024, this balance consisted of \$59,167 in participant accounts who had terminated employment in the current plan year and \$1,226,520 in participant accounts who terminated employment in Plan years ending June 30, 2023 and earlier.

NOTE 8 – HISTORICAL COSTS

Department of Labor Regulation 2520.103-11(d) allows the exclusion of historical cost data for participant-directed investments on Schedule H, Line 4i.

NOTE 9 – RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of common collective trusts and pooled separate accounts which are owned and managed by the Principal Life Insurance Company. The Principal Life Insurance Company was appointed the record keeper and custodian effective January 1, 2014. Fees paid to the Principal Life Insurance Company by the Plan amounted to \$56,372 and \$48,336 for the years ended June 30, 2024 and 2023, respectively.

NOTE 10 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

NOTE 11 – SUBSEQUENT EVENTS

The Plan's management has evaluated subsequent events through the issuance date of the report. There were no events to report that would have a material effect on the issued financial statements.
