## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the  
Newspaper Guild of New York -  
The New York Times Benefits Fund

### Opinion

We have audited the financial statements of the Newspaper Guild of New York - The New York Times Benefits Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Newspaper Guild of New York - The New York Times Benefits Fund as of June 30, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Newspaper Guild of New York - The New York Times Benefits Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Newspaper Guild of New York - The New York Times Benefits Fund's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Report on Supplemental Information**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The Schedules of Cost of Benefits, Schedules of Administrative Expenses, Schedule of Assets Held at End of Year and Schedule of Reportable Transactions together referred to as “supplemental information,” are presented for the purpose of additional analysis and are not a required part of the financial statements. The supplemental Schedule of Assets Held at End of Year and Schedule of Reportable Transactions represent supplemental information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Supplemental information is the responsibility of the Plan’s management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTES TO FINANCIAL STATEMENTS**

JUNE 30, 2024 AND 2023

**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Newspaper Guild of New York - The New York Times Benefits Fund (the Plan) provides only general information about the Plan's provisions. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General** - The Plan is a single employer defined benefit welfare plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is maintained under the terms of the Agreement and Declaration of Trust entered into as of July 1, 1981, as amended, by and between the Newspaper Guild of New York, Local 3, TNG, AFL-CIO, CLC and the New York Times Company (the New York Times).

**Benefits** - The Plan provides health benefits, including hospital, major medical, prescription drug, dental, life insurance, and optical coverage to eligible participants and their covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The Plan provides coverage during retirement if the retired employee meets the criteria stipulated in the Summary Plan Description. The Plan does not provide dental, optical or life insurance coverage for retirees age 65 or over. Effective January 1, 2019, no new participants are eligible to participate in the Medicare retiree benefit program. However, participants approved for the 2017 buyout prior to January 1, 2019 are still eligible. Additionally, participants who were accepted for, and are terminated pursuant to a group buyout program that was offered in calendar year 2015, 2016, or 2017 will be permitted to reenroll in the plan if they were covered by the plan as of May 10, 2019, have satisfied the eligibility requirements for both Pre-Medicare coverage and Medicare Retiree coverage under the Plan, and they drop Pre-Medicare Retiree Plan coverage.

**Insured Benefits** - The Plan offers a preferred provider organization (PPO) Plan, an exclusive provider organization (EPO) plan and three health maintenance organization (HMO) plans from which participants can choose. The Plan offers life insurance to the participant only. Life insurance coverage is not provided to a dependent, retiree or a dependent of a retiree.

**Self-insured Benefits** - All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party administrator and claims processor under an administrative service only (ASO) arrangement.

## **NOTE 1. DESCRIPTION OF THE PLAN (continued)**

**Stop-Loss Coverage** - The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

**Contributions** - Participants who enrolled in the EPO or any of the HMOs through the Plan are required to pay additional contributions if their EPO or HMO charges a higher premium than the cost of the PPO coverage as determined by the Trustees.

## **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of Accounting** - The accompanying financial statements have been prepared using the accrual basis of accounting.

**Investment Valuation and Income Recognition** - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The investment contract with insurance company is stated at estimated fair value as reported by the insurance company.

Purchase and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Employer and Employee Contributions Receivable** - Employer and employee contributions due and not paid prior to year end are recorded as contributions receivable. The Plan believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded.

**Payment of Benefits** - Benefit payments are recorded when paid.

**Refunds** - Refunds due from the Plan's Pharmacy Benefit Manager (PBM) are recorded when earned and are netted against prescription drugs claims paid. PBM rebates totaling \$1,602,209 and \$1,301,955 have been netted with prescription drugs claims paid in the accompanying statements of changes in net assets available for benefits for the years ended June 30, 2024 and 2023, respectively.

**Stop Loss** - Premiums for stop loss insurance are included in cost of benefits in the accompanying statement of changes in net assets available for benefits. Stop loss refunds have been netted with cost of benefits in the accompanying statement of changes in net assets.

**Claims Incurred but not Reported** - Plan obligations at year end for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

## **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

**Benefit Obligation** - As allowed by Accounting and Reporting by Health and Welfare Benefit Plans, the Plan is presenting the benefit obligations and the changes in benefit obligation in the notes to financial statements.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Reclassifications** - Certain reclassifications have been made to prior year amounts to conform to the current year presentation.

**New Accounting Standard** - In June 2016, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update (ASU) No. 2016-13, Financial Instruments - Credit Losses (Topic 326), which is effective for the year ended June 30, 2024. This new standard provides financial statement users with more decision-useful information about the expected credit losses on financial instruments and other commitments to extend credit held by a reporting entity at each reporting date. The standard replaced the incurred loss impairment model with a methodology that reflects expected credit losses and requires consideration of a broader range of reasonable and supportable information to inform credit loss estimates. The standard had no material impact on the Plan's financial statements.

## **NOTE 3. FUNDING POLICY**

The Plan is funded through employer contributions, as well as contributions from participants electing post retirement benefits and COBRA coverage. Contribution rates vary and are set forth in the collective bargaining agreements. Contributions are accounted for as exchange transactions.

The New York Times is required to contribute 7.6% of straight-time payroll. During the years ending June 30, 2024 and 2023, the New York Times contributed an additional \$1,858.74 per participant, totaling \$1,882,904 and \$1,788,108 in accordance with collective bargaining.

The weekly employee contribution rates for active participants were 3.5% to 8.5% of the top minimum scale for the salary group of the participant. Active participants may also elect HMO coverage at an additional cost to the participant.

The retired employees' contribution rates for continued health care coverage ranged from \$276.08 to \$1,368.11 per month for the period of January 1, 2024 to June 30, 2024, \$305.41 to \$1,322.23 per month for the period of January 1, 2023 to December 31, 2023, and \$364.89 to \$1,134.60 per month for the period of July 1, 2022 to December 31, 2022.

#### **NOTE 4. PRIORITIES UPON TERMINATION**

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

#### **NOTE 5. TAX STATUS**

The Plan obtained its latest determination letter in 1981, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of Section 501(c)(9) of the Internal Revenue Code and was, therefore, exempt from Federal income taxes. The Plan has been amended since receiving the determination letter. The Plan's Administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

#### **NOTE 6. CONCENTRATION OF CASH**

The Plan places its cash with financial institutions deemed to be creditworthy. The balance is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. Cash balances may at times exceed the insured deposit limits. As of June 30, 2024, the Plan's cash in excess of FDIC coverage totaled \$412,350.

#### **NOTE 7. RISKS AND UNCERTAINTIES**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, sector, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

## **NOTE 8. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

### **Basis of Fair Value Measurement:**

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

For the years ended June 30, 2024 and 2023, there were no transfers in or out of levels 1, 2, or 3.

The insurance contract with Prudential Retirement Insurance and Annuity Company (Prudential) deposits all contributions from the Prudential Fixed Rate Fund into the general assets of Prudential. Prudential invests those general assets predominantly in privately placed securities and mortgages. The remaining portion of assets is invested in publicly traded bonds, real estate, common and preferred stock, and other types of equity investments, as well as short-term investments. Its market value represents contributions to the Fixed Rate Fund plus accumulated interest, less withdrawals adjusted to reflect market conditions as determined by Prudential. Prudential provides that the Plan can withdraw from the Fixed Rate Fund its contract’s share of the amount necessary to pay participants benefits under the Plan up to the value of amounts held in the Fixed Rate Fund. Withdrawals will be made following the date of the withdrawal request or on the date specified in the withdrawal request.

## NOTE 9. RELATED PARTY TRANSACTIONS

### Identification of Related Organizations

The Plan has the following related entity with which it has transactions:

- The Newspaper Guild of New York - The New York Times College Scholarship Fund (the Scholarship Fund)

The above entity qualifies as a tax-exempt organization. The entity above shares common Trustees with this Plan.

The Plan shares payroll audit fees with the Scholarship Fund. The payroll audit fees are allocated on a basis approved by the Plan's Trustees.

Changes in assumptions for 2024 included a decrease of \$290,950 due to an increase in the discount rate from 5.00% to 5.25%.

Changes in assumptions for 2023 included a decrease of \$646,755 due to an increase in the discount rate from 4.50% to 5.00%.

**NOTE 11. POSTRETIREMENT BENEFIT OBLIGATIONS**

The Plan provides lifetime health care coverage to certain retirees and their dependents.

Accounting principles generally accepted in the United States of America require that the Plan include the actuarial present value of postretirement benefit obligations in the benefit obligations of the Plan.

The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants.

The following were significant assumptions used to determine the postretirement benefit obligation valuations as of June 30, 2024 and 2023:

Discount rate:	5.25% for 2024, 5.00% for 2023
Mortality:	Healthy: PRI-2012 Mortality Tables (separate sex-distinct tables for employees, retirees and surviving spouses), projected generationally with Scale MP-2021.
	Disabled: PRI-2012 Disabled Mortality Tables for males and females, projected generationally with Scale MP-2021.

The forgoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

The health care cost-trend rate assumption has a significant effect on the amounts reported. If the assumed rate increased by one percentage point, that would increase the obligations as of June 30, 2024 and 2023, by \$1,036,246 and \$1,126,373, respectively.

**NOTE 13. FEES MANDATED BY THE PATIENT PROTECTION AND AFFORDABLE CARE ACT**

The Plan is subject to certain fees mandated by the Patient Protection and Affordable Care Act. Fees payable to the Patient-Centered Outcomes Research Institute (PCORI) are equal to \$3.00 per covered life for the 2024 fiscal year and \$2.79 for 2023. For the years ended June 30, 2024 and 2023, the Plan paid \$8,250 and \$7,553 in PCORI fees, respectively.

**NOTE 14. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through April 9, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
