I am writing to respectfully request the abatement of any penalties associated with the late filing of Form 5500 for the tax year ending 2023. I acknowledge the importance of timely filing and deeply regret this oversight.

The delay in filing was due to an unintentional administrative error where it was believed that the Final Form 5500 had been filed in 2023. Since the business closed in 2022 and all employees were terminated, including myself, the assumption was that the 2023 filing was the final filing. I have since learned that the actual account didn't close until sometime later as one of the employees did not cash their check and I am now therefore required to file an additional Form 5500.

Please accept this letter as a reasonable cause explanation for my tardiness as I now make every effort to comply as soon as possible. I respectfully request that any penalties be waived under these circumstances as I had no malintent in my lack of filings.
