Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 403(b) Thrift Plan for The Hagedorn Little Village School (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

1. Description of Plan

The following description of the 403(b) Thrift Plan for The Hagedorn Little Village School (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers all employees, other than any temporary or leased employees, students employed by an educational institution, employees who have taken a vow of poverty, and nonresident aliens with no U.S. source income and employees who are eligible to make Salary Reduction Contributions to another plan of The Hagedorn Little Village School (the Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On June 16, 2023, the Little Village House, Inc. (LVH) corporation, an affiliate of the Organization, was dissolved by the State of New York, and the previous employees of LVH would no longer participate in the Plan. During 2024, \$290,871 was transferred out of the Plan and annuities were purchased for the participants of LVH organization.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year, as well as participants who have worked for the Organization for at least 15 years, are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants who have satisfied the age and service requirement shall be entitled to a pro rata share of any employer matching contribution during the plan year. The Plan requires a participant to be employed as of year end to be eligible to receive employer matching contributions. The employer match contribution shall be an amount equal to a percentage of the participant's salary reduction contributions deferred during the plan year. The employer shall have the sole right to determine the amount allocated for each plan year, provided that the same percentage of salary reduction contributions shall be allocated on behalf of every eligible participant. There were no matching contributions made during the year ended June 30, 2024.

The Plan provides an annual base retirement contribution to participants who have satisfied the age and service requirement and shall be entitled to a pro rata share of any employer base contribution during the plan year, whether or not the participant made salary reduction contributions. The Plan requires a participant to be employed as of year end to be eligible to receive an annual base retirement contribution. The employer base contribution is calculated by taking the participant's eligible compensation and dividing it by the total eligible compensation paid during the plan year. The employer shall have sole discretion for determining the amount of the employer base contribution. During the year ended June 30, 2024, the Organization authorized a base retirement contribution of \$462,202 which is recorded as a contribution receivable at June 30, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Organization's contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their contributions and rollover contributions. Participants are 100% vested in employer matching and base retirement contributions after three years of service.

Plan Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are made with other funds of Mutual of America and collateralized by the balances in the participants accounts and bear a variable rate of interest determined at the time the loan is issued, which is reevaluated each calendar quarter. Interest rates on plan loans ranged from 4.60% to 5.85% as of June 30, 2024 and ranged from 3.25% to 4.60% as of June 30, 2023. Terms range from one to five years or greater for the purchase of a primary residence. As of June 30, 2024 and 2023, \$64,959 and \$103,885, respectively, of participant account balances were collateral for outstanding plan loans.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$44,809 and \$27,602, respectively. These accounts will be used to reduce future employer contributions. During 2024, no amounts were applied to plan activities from forfeited nonvested accounts.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated through April 10, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Pooled separate accounts: Valued based upon the unit values of such pooled accounts held by the Plan at year-end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

Insurance company fixed accounts: Insurance company fixed accounts are valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. The credited interest rate, when declared, is applied on a daily basis to all funds accumulated in the interest accumulation account. A portfolio approach is utilized for determining credited interest rate. Any market value adjustment or surrender charge is based on formulas and schedules in the contract. See Note 11.

4. Related-Party and Party in Interest Transactions

Certain plan investments are managed by Mutual of America Life Insurance Company, the Custodian, and therefore, these transactions qualify as party in interest transactions.

Additionally, the one of the Custodians issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

5. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants' accounts would become fully vested and distributed in accordance with the provisions of the Plan. In the event of Plan termination, participants would become 100% vested in their employer contributions.

6. Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The Plan Administrator believes the Plan is operating in accordance with the applicable requirements of Section 403(b) of the IRC and therefore believe the Plan is qualified and the related custodial accounts are tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

8. Concentrations

As of June 30, 2024 and 2023, the Plan had investments of \$6,549,007 and \$ 5,971,517, respectively, which were concentrated in one interest accumulation account at one institution. In addition, as of June 30, 2024 and 2023, the Plan had investments of \$4,813,358 and \$4,070,373, respectively, which were concentrated in one fund.

11. Guaranteed Investment Contract

The Plan entered into a guaranteed investment contract held in an interest accumulation account with Mutual of America Life Insurance Company (Mutual), the custodian of the Plan. Mutual maintains contributions in an unallocated fund to which it adds interest at a fixed rate or rates of interest determined by Mutual. At the direction of the Plan Administrator, a single premium to buy an annuity for a retiring employee is withdrawn by Mutual from the unallocated fund. Purchased annuities are contracts under which Mutual is obligated to pay benefits to named employees or their beneficiaries. The premium rates for such annuities to be purchased in the future and maximum administration expense charges against the fund are also guaranteed by Mutual.

Funds under the guaranteed investment contract that have been allocated and applied to purchase annuities (that is, Mutual is obligated to pay the related benefits) are excluded from the Plan's assets.
