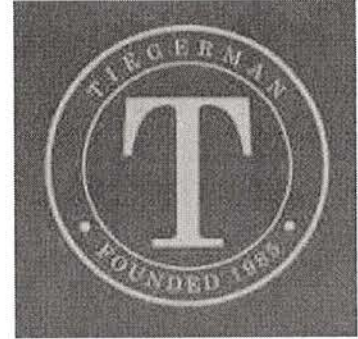

## INDEPENDENT AUDITORS' REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Tiegerman School 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. ### **NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

This summary of significant accounting policies of the Tiegerman School 403(b) Retirement Plan (the "Plan") is presented to assist in understanding the Plan's financial statements and supplemental information. These financial statements, supplemental information, and notes are representations of Tiegerman School and Affiliates' (hereinafter, the "Plan Sponsor") management, which is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements and supplemental schedules.

Basis of Accounting: The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for a further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year. During the year ended June 30, 2024, the Plan's investment gains (including gains and losses on investments bought and sold, as well as held during the year) were \$5,442,397.

Participant Notes Receivable: Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

Excess Contributions Payable: Amounts payable to participants in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability.

Payment of Benefits: Benefits are recorded when paid to the Plan's participants.

Plan Expenses: Certain administrative, accounting and audit expenses for the Plan were paid directly by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and fees related to the distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Events Occurring After Report Date: The Plan Sponsor evaluated events and transactions that occurred between July 1, 2024 and April 10, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

#### **NOTE 2 - DESCRIPTION OF THE PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and Eligibility: The Plan was originally established July 1, 1986, by the School for Language and Communication Development (the "School") as a contributory defined contribution plan for the benefit of its employees. In 2015, the Plan was amended to include Able Community Services, Inc. ("Able"), as a participating employer. On June 20, 2017, Able changed its name to Tiegerman Community Services, Inc. ("Community Services"). Effective October 17, 2017, the School for Language and Communication Development changed its name to Tiegerman School and the Plan was amended to change its name from School for Language and Communication Development Tax Deferred Annuity Retirement Plan to Tiegerman School 403(b) Retirement Plan. Collectively, the School and Community Services will be referred to as the "Employers."

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is a combination custodial account and annuity contract. The Plan assets are held by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal Trust"), the Trustee or Custodian, and Principal Life Insurance Company ("Principal"), is the recordkeeper. The Plan Sponsor uses Loren D. Stark Company (formerly SBC Benefit Consultants, Inc.) as third-party administrators of the Plan. Eligible employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Employers. Participants are required to have two years of service to qualify for employer matching contributions.

Plan Amendments: The Plan Sponsor has the right under the Plan to amend the Plan at any time. The Plan was last amended on April 20, 2020 to allow for Coronavirus-related distributions, Coronavirus-related loans, and temporarily waiving required minimum distributions. These amendments were in response to the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act").

Contributions: The Plan permits eligible employees through a salary deferral election to have the Employers make contributions of up to the maximum allowed by the Internal Revenue Code. Roth contributions and employee rollovers are permitted by the Plan. Participants who have attained age 50 are eligible to make catch-up contributions.

The School makes matching contributions of 100 percent of eligible participants' contributions on the first 6 percent of compensation for School employees and Community Services makes matching contributions of 100 percent of eligible participants' contributions on the first 2 percent of compensation for Community Services employees.

Contributions are subject to certain limitations.

Participant Accounts: Participants have the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation at any time. Each participant's account is credited with the participant's contributions, the Employers' contributions, and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled, is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their (employee) contributions as well as any contributions made by the Employers plus actual earnings thereon.

Investment Options: Upon enrollment in the Plan, participants may direct the Custodian to invest contributions in various investment options managed by the Custodian, its affiliates, and other large investment management companies. Participants may change their contribution investment options, transfer part or all of past investments to other funds and change their deferral percentages at any time during the Plan year.

Notes Receivable from Participants: The plan document includes provisions authorizing loans from the Plan to active eligible participants. There is no limit on the number of loans a participant may have outstanding at any one time.

**NOTE 2 - DESCRIPTION OF THE PLAN (continued)**

The minimum amount of a loan shall be \$1,000. The maximum loan amount is the lesser of \$50,000 or 50 percent of the participant's vested account balance. All loans are secured by the balances in the participant's accounts and are repayable over a period not to exceed five years, unless the loan is for the purchase of a principal residence. The effective interest rates for loans shall be based upon the aggregate loan rate for a loan granted under similar circumstances by banks and other professional lenders, as determined by the Plan administrator. Outstanding loans at June 30, 2024 bore interest between 5.25% and 10.50%. Principal and interest are paid ratably through payroll deductions.

Deemed Distributions: When a participant fails to make loan repayments under the terms of the loan agreement, the loan is considered to be in default. A loan in default is considered a distribution from the Plan (deemed distribution) that could result in taxable income to the participant. During the year ended June 30, 2024, there were no deemed distributions.

In-Service Withdrawals: In-service or hardship withdrawals are permitted by the Plan.

Payment of Benefits: Upon termination of service, a participant may elect to receive the vested value of the participant's account in the form of a single lump sum, a partial lump sum, installments, or to purchase an annuity. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become one hundred percent vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Plan Sponsor may determine.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The Plan Sponsor utilizes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the value hierarchy are described below:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset and liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024 and 2023.

Mutual Funds (Registered Investment Companies): Valued at the net asset value of shares held by the Plan at year-end. The net asset value is based upon quoted market prices.

**NOTE 5 - GUARANTEED INTEREST ACCOUNT**

The Principal Guaranteed Investment Contract ("GIC") is considered a fully benefit responsive investment contract ("FBRIC") and is reflected at contract value within net assets available for benefits which is \$2,740,843 and \$3,666,583 as of June 30, 2024 and 2023, respectively. Accounting Standards Update ("ASU") 2015-12 states that FBRICs should be measured, presented, and disclosed only at contract value and fair value information is not required. All GICs that are deemed benefit responsive investment contracts should no longer be included in Accounting Standards Codification ("ASC") 820 fair value disclosures. A plan should continue to provide disclosures that help users understand the nature and risks of fully benefit-responsive investment contracts. The GIC will provide information about redemption frequency and notice periods if applicable. This contract does have surrender charges if it is terminated by the contract holder or a plan terminates its interest in such contract within certain time periods. If a contract is terminating and a surrender charge applies, the plan may no longer be deemed benefit-responsive. This could require the GIC to be reported at fair value and thus included in the ASC 820 fair value disclosures. Fair value is the amount plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to maturity for an event other than death, disability termination or retirement.

Most participant transactions are executed using contract value without adjustment. If the contract holder is considering terminating the contract or a plan is considering terminating its interest in such contract in the near future, contract value less surrender charges may be a better proxy for fair value.

The GIC issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1 percent. The average yield credited to participants was 2% as of June 30, 2024.

**NOTE 6 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

Certain Plan investments are managed by the Trustee, as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions.

Fees paid directly by the Plan for contract administration totaled \$93,974 for the year ended June 30, 2024. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

For the year ended June 30, 2024, there were instances where the employer did not timely remit employee contributions to Principal. Failure to timely remit employee contributions constitutes nonexempt transactions between the Plan and the Plan Sponsor. The Plan Sponsor estimated \$105 in lost investment earnings on these contributions and loan repayments. The lost earnings were remitted to the participants during the fiscal 2025 Plan year.

**NOTE 7 - TAX STATUS**

The Plan operates under a volume submitter 403(b) Plan document sponsored by Principal. This volume submitter plan document has been filed with the appropriate agency and has obtained an opinion letter dated March 31, 2017 from the IRS stating that the volume submitter plan document is acceptable under Section 403(b) of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America requires the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and IRS.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.
