Opinion



1. DESCRIPTION OF PLAN

The following description of the Wayne J. Griffin Electric, Inc. Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a contributory defined benefit health and welfare plan established by Wayne J. Griffin Electric, Inc. (the Plan Sponsor or the Company) effective January 1, 1995. On June 10, 2019, the Plan Sponsor established a voluntary employees' benefit association (VEBA) trust (VEBA Trust) to serve as a funding vehicle for the Plan for certain Plan benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility and benefits - The Plan provides medical, dental, prescription drug, life insurance, short-term disability, long-term disability and other fringe benefits to all employees of the Company. Employees who are regularly scheduled to work at least 30 hours per week are eligible to participate in the Plan immediately following 90 calendar days of employment. Benefits are generally reserved for employee coverage, but employees may purchase additional coverage for their spouse and dependents through pre-tax and after-tax deductions as allowable under Internal Revenue Service (IRS) and ERISA rules and regulations. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured benefits - The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic), short and long-term disability benefits, voluntary critical illness, and employee assistance program. The Company purchases annual insurance contracts for these insured benefits. Premiums for basic life insurance, basic accidental death, disability, voluntary critical illness, and employee assistance program benefits are paid to insurance companies and/or benefit providers from the general assets of the Company.

Contributions - The Plan is funded by employer, employee and COBRA contributions. In addition to deductibles and copayments, participants contribute specified amounts, determined annually, for coverage of themselves and their dependents. This determination is based on a review of the Plan's payment trends and an estimation of expected costs for the following year, as recommended by an independent third-party specialist.

Employee contributions are made via payroll deductions. The plan administrator provides a schedule of applicable premiums during the annual open enrollment period.

Employer contribution rates are established annually by the Company.

Stop-loss coverage - The Plan has entered into a stop-loss insurance arrangement to limit its exposure for self-insured benefits (individual participant claims over a specified dollar amount). For the years ended June 30, 2024 and 2023, the Plan's self-insurance retention is \$250,000 for individual losses on a per-person basis.

Self-insured benefits - The Plan's medical, dental and prescription drug benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's VEBA Trust or the general assets of the Plan Sponsor. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Plan administration and expenses - The Plan is designed as a VEBA. The Plan is managed by trustees, who are primarily representatives of the Company. The Plan's administrative expenses are paid by either the Plan or Plan Sponsor, as provided by the plan document.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates - The preparation of financial statements in accordance with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for plan benefits and benefit obligations at the dates of the financial statements and changes in net assets available for plan benefits and benefit obligations during the year, particularly the estimate of the liability for claims incurred but not yet reported to the Plan. Accordingly, actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year such adjustments are determined.

Investment valuation and income recognition - The Plan's investments are held by Bank of America in an interest-bearing checking account. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the financial institution.

Interest income is recorded on an accrual basis.

Payment of benefits - Premiums paid by either the Company or the VEBA Trust are recorded as insurance premium payments in the accompanying statement of changes in net assets available for plan benefits.

Claim payments are recorded when paid by the third-party claims processors. Amounts due to the claims processors that have not been reimbursed by the Plan, if any, are recorded as payables to claims administrators in the accompanying statements of net assets available for plan benefits.

Stop-loss coverage - Premiums for stop-loss insurance are included in "Insurance premiums" in the accompanying statement of changes in net assets available for plan benefits. The Plan received stop-loss refunds totaling approximately \$1,255,000, which are netted against self-insured claims during the year ended June 30, 2024.

Benefit obligations - Claims incurred but not yet reported are estimated by the Plan's benefit consultant based on claims data provided by the Plan's self-insured claims administrator. This analysis and estimate is determined using a historical analysis of claims paid subsequent to year end as well as subsequent benefit payments actually made, classified according to the date that the related services were provided.

Subsequent events - Subsequent events were evaluated through April 8, 2025, the date the financial statements were available to be issued. The Plan sponsor has determined that there are no subsequent events that require recognition or disclosure under Financial Accounting Standards Board Accounting Standards Codification 855, *Subsequent Events*.

3. TAX STATUS

A VEBA Trust was established under the Plan to hold the Plan's assets. The Plan Sponsor has submitted the Plan's trust agreement to the IRS for a determination of its status as a qualified voluntary employee's beneficiary association as described in Section 501(c)(9) of the Internal Revenue Code (IRC). The trust received its tax exemption status in October 30, 2020, effective back to June 10, 2019. Plan management and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan will be exempt from income taxes, and as such, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain tax positions taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at June 30, 2024 and 2023.

Interest-bearing cash: These investments are stated at cost, which approximates fair value.

The Plan holds cash in a bank deposit account with a financial institution, which at times may exceed federally insured limits. Plan management periodically evaluates the balance and believes this account does not pose a financial risk to the Plan.

6. PRIORITIES UPON TERMINATION

Although it has not expressed any intention to do so, the Plan sponsor has the right under the Plan to discontinue any terms, conditions, or benefits of the Plan at any time and terminate the Plan subject to the provisions of ERISA, the insurer's contract, and the contract administration agreement. Expenses incurred prior to a termination, modification, or amendment of the Plan would be paid as provided under the terms of the Plan prior to its termination, modification, or amendment. In the event of termination, the Plan Sponsor shall first satisfy or make provisions to satisfy the obligations of the Plan.

7. ADMINISTRATION OF PLAN ASSETS

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officers or employees receive compensation from the Plan. Certain administrative expenses are paid by the Plan, with the remainder paid by the Plan Sponsor.
