COST METHOD

In accordance with PPA, the annual cost is equal to the target normal cost plus the shortfall amortization charge minus any prefunding and carryover balances.

Unit Credit method. The normal cost is the sum of the individual normal costs for active participants. The normal cost for an individual is the present value, as of the valuation date, of the participant's retirement, death, and withdrawal benefits which he is expected to accrue during the current plan year.

The actuarial accrued liability is the sum of the individual present values, for all participants, of the benefits accrued, based on service to the valuation date.

The actuarial liabilities shown in this report are determined using software purchased from an outside vendor which was developed for this purpose. Certain information is entered into this model in order to generate the liabilities specific to your pension plan. SUMMARY OF PLAN PROVISIONS

<u>Effective Date:</u>	The Effective Date of the amended Plan is January 1, 1989.
<u>Plan Year Beginning:</u>	07/01/2023
<u>Eligibility:</u>	Every employee who is age 21 with 1 year of service. The Plan was frozen effective June 30, 1994. No additional benefit accruals will be earned and no new entrants will be allowed after June 30, 1994.
<u>Vesting:</u>	Participants are 100% vested upon completing 5 years of service.
<u>Normal Retirement:</u>	First of the month coincident with or next following attainment of age 65, or 5 th anniversary of joining the Plan, if later.
<u>Normal Form of Benefit:</u>	The normal form of benefit is a Life Annuity. The normal form of benefit for married participants is a Joint and 50% Survivor benefit, the amount of which is actuarially equivalent to a Life Annuity.
<u>Normal Retirement Benefit:</u>	A monthly benefit equal to the sum of a) the Participants' Accrued Benefit determined under Prior Plan as of June 30, 1989 and b) 1/3% of the Participants' Compensation in effect as of the July 1 st for such year, plus 1/3% of the Participants' Compensation in effect as of the July 1 st for such year that exceeds \$9,000, if any. However, Participants are not credited with a benefit for Years of Service after June 30, 1994. If a participant has ten or more Years of Service the amount of monthly retirement benefit shall not be less than \$100.
<u>Early Retirement:</u>	Age 55 with 10 years of service, actuarially reduced.
<u>Late Retirement:</u>	Participants who retire after Normal Retirement age receive the benefits accrued to their date of actual retirement.
<u>Disability:</u>	No disability benefits, other than those payable upon termination of employment, are provided in this Plan.
<u>Death Benefit:</u>	If the participant is unmarried or is not vested, no death benefits are payable. If a married participant is vested, then the death benefit to the surviving spouse is 50% of the amount that would have been payable to the Participant under the 50% Joint and Survivor option.

SUMMARY OF ACTUARIAL METHODS AND ASSUMPTIONS

COST METHOD

In accordance with PPA, the annual cost is equal to the target normal cost plus the shortfall amortization charge minus any prefunding and carryover balances.

Unit Credit method. The normal cost is the sum of the individual normal costs for active participants. The normal cost for an individual is the present value, as of the valuation date, of the participant's retirement, death, and withdrawal benefits which he is expected to accrue during the current plan year.

The actuarial accrued liability is the sum of the individual present values, for all participants, of the benefits accrued, based on service to the valuation date.

The actuarial liabilities shown in this report are determined using software purchased from an outside vendor which was developed for this purpose. Certain information is entered into this model in order to generate the liabilities specific to your pension plan. These inputs include economic and non-economic assumptions, plan provisions and census information. We rely on the coding within the software to value the liabilities using the actuarial methods and assumptions selected. Both the input to and the output from the model is checked for accuracy and reviewed for reasonableness.

ACTUARIAL ASSUMPTIONS

Interest Rate (as prescribed by PPA and modified by MAP-21, HATFA, BBA, ARPA and IJJA)

Without Adjusted Interest Rates:

Liabilities are valued using the three segment rates based on the 24-month average of the corporate bond yield curve published by the Secretary of the Treasury for the applicable month of July 2023.

With Adjusted Interest Rates under Funding Relief:

The interest rates are the adjusted 24-month segment rates using 25-year average segment rate corridors of 95% to 105% per Funding Relief.

PBGC Premiums and LDROM:

The Plan Sponsor is using the Alternative Method to determine the Variable Rate Premium.
