## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees  
North Jersey Elks Developmental Disabilities Agency

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of North Jersey Elks Developmental Disabilities Agency Employees' Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from the qualified institutions as of June 30, 2024 and 2023 and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements referred to above, related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of North Jersey Elks Developmental Disabilities Agency Employees' Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**NOTE 1. DESCRIPTION OF PLAN**

The following description of North Jersey Elks Developmental Disabilities Agency Employees' Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of North Jersey Elks Developmental Disabilities Agency (the "Agency") who have four months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for oversight of the Plan. The Agency determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Trustees and participants.

**Contributions**

The Agency makes a discretionary contribution each Plan year that is allocated pro rata to all eligible participants based on compensation. A participant is eligible to receive a contribution upon completion of 700 hours of service during the plan year. The Agency's contribution was 11.0% of compensation for the Plan year ended June 30, 2024. The Agency's contribution is invested directly in participant directed accounts or a designated balanced fund until changed by the participant. Contributions are subject to certain limitations. Participants may only contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of the contributions into various investment options offered by the Plan. Participants may not make deferrals into the Plan.

**Participant Accounts**

Each participant's account is credited with an allocation of (a) the Agency's contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested accounts and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Allocations are based on participant earnings or account balances, as defined. The Plan currently offers a common collective trust, group annuity contracts and mutual accounts administered by Mid Atlantic Trust Company ("MATC") and The Variable Annuity Life Insurance Company ("VALIC"), as investment options for participants.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Agency's contribution portion of their accounts is based on years of continuous service. Beginning after two years of service, participants vest 20% each year in the Agency's contributions. A participant is 100% vested after 6 years of credited service.

**Notes Receivable from Participants**

Participants may borrow from the vested portion of their accounts a minimum of \$1,000 up to a maximum of \$50,000 or fifty percent of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account. The loan interest rate as determined by the Plan administrator, ranges from 1.00% to 9.50% at June 30, 2024 and 2.5% to 8.75% at June 30, 2023. Principal and interest is paid ratably on a semi-monthly, monthly, or quarterly basis.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or installment payments over a specified period of time, not exceeding their life expectancy or the joint life expectancy of the participant and their designated beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeitures**

At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$278,587 and \$265,402, respectively. In accordance with the Plan document, forfeitures shall be reallocated to participants in the same manner as employer contributions. During the year ended June 30, 2024, there were no reallocations of forfeitures to the participants.

**NOTE 2. SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of Estimates**

The process of preparing financial statements in conformity with accounting principles generally accepted in the United States of America requires the use of estimates and assumptions regarding certain types of assets, liabilities, additions to net assets, and deductions from net assets. Accordingly, actual results may differ from estimated amounts.

**Investment Valuation and Income Recognition**

Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. As of June 30, 2024 and 2023, the investment contract is reported at surrender value, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance from credit losses has been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution. Amounts allocated to participants who have chosen to withdraw from the Plan but who have not yet been paid are not recorded as a liability, but are disclosed.

**Expenses**

It is expected that the Agency will provide direct payment for most administrative expenses and all professional fees of the Plan. Expenses that are paid by the Agency are excluded from these financial statements. Investment related expenses are included in investment income. Loan origination fees, distribution fees, and annual maintenance fees are shown as administrative expenses on the statement of changes in net assets available for benefits and are deducted from participant account balances.

**Subsequent Events**

The Plan has evaluated all events and transactions that occurred after June 30, 2024, for potential recognition or disclosure through April 11, 2025, which is the date the financial statements were available to be issued.

**NOTE 3. CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended June 30, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company ("MATC") (the qualified institution of the Plan).

Variable Annuity Life Insurance Company ("VALIC"), the former qualified institution of the Plan has certified to the completeness and accuracy of some investments reflected in the accompanying statement of net assets available for benefits as of June 30, 2024 and 2023, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended June 30, 2024.

**NOTE 4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023. The following methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Trust Funds**

Valued at the NAV of units of the collective trust funds. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Fixed Income Annuity Investment Contracts**

The fair value of the fixed interest annuity investment contracts is based on the principal invested and earnings at the contractual interest rate. The fair value of the fixed interest annuity investment contracts is the amount participants would receive if they were to withdraw or transfer funds within the Plan prior to their maturity. At June 30, 2024 and 2023, the fair value of the fixed interest annuity investment contracts approximates surrender value.

There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

**NOTE 5. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are funds managed by VALIC and MATC. VALIC and MATC are the qualified institutions as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

**NOTE 6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their employer contributions.

**NOTE 7. TAX STATUS**

The Plan has adopted a prototype non-standardized profit sharing plan sponsored by Mutual of America which has received an opinion letter from the Internal Revenue Service ("IRS") dated November 30, 2020, in which the opinion letter states that the form of the plan identified above is acceptable under section 401 of the Internal Revenue Code ("IRC"). The Plan has not requested its own determination letter from the IRS and is relying on the opinion letter issued to Mutual of America. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
