Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Parkview Medical Center, Inc. Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 24, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits for the period January 1, 2024 through July 24, 2024 and the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 24, 2024 and December 31, 2023 and for the period January 1, 2024 through July 24, 2024 and the year ended December 31, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an Auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following brief description of the Parkview Medical Center, Inc. Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General — The Plan is a defined contribution plan covering eligible employees of Parkview Medical Center, Inc. and affiliates (the Medical Center), including Parkview Medical Center, Inc., Parkview Foundation, Inc., Pueblo Health Care, Inc., and Parkview Ancillary Services, Inc. Employees are eligible to participate in the Plan immediately after their date of hire, but are not eligible to receive employer contributions until completion of one year of at least 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Termination — Parkview Medical Center merged with UC Health in December 2023. As a result the Plan's management elected to terminate the plan on April 1, 2024. All assets were distributed from the Plan as of July 24, 2024.

Contributions — A participant may elect to have a percentage of their compensation withheld by the employer (not less than 1%) and contributed to the Plan on their behalf as an elective contribution in lieu of receiving such amount as compensation. The Plan provides for an automatic election to have elective deferral contributions after 30 days of service. The automatic elective deferral contribution is 5% of the employee's compensation. The participant may affirmatively elect a different percentage or elect not to make deferral contributions. The amounts contributed may not exceed the limits established in the Internal Revenue Code (IRC).

The Plan provides that a participant who has an automatic elective deferral contribution of less than 10% of compensation shall automatically have their elective deferral contribution increased annually on or after the first pay period ending after January 1 by 1%, up to a maximum elective deferral contribution of 10%. The Medical Center makes discretionary contributions. During period from January 1, 2024 through April 1, 2024 (the date of Plan Termination) and the year ended December 31, 2023, the Medical Center made discretionary contributions equal to 50% of deferral contributions up to 4%, not to exceed 2% of compensation.

Participant Accounts — Each participant's account is credited with an allocation of the Medical Center's contributions, the participant's contributions, and an allocation of the Plan's earnings and losses. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan's earnings or losses, excluding that related to participants' loans, are allocated to the participant's account based upon the proportion that each participant's account bears to the total participant account balances at the previous allocation date. Earnings resulting from loans to participants are credited to the respective participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants — Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 or (b) 50% of their vested account balance. Loan terms range up to five years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates. Principal and interest is paid ratably through regular payroll deductions.

Vesting — Participants are 100% vested in the amounts they contribute. Participants vest in the Medical Center's contributions and allocation of the Plan's earnings or losses over a three-year period. Prior to the Plan's termination effective April 1, 2024, participants vest in the Medical Center's contributions and an allocation of the Plan's earnings or losses as follows:

Years of Service	Vested %
Less than 1	0%
1	33%
2	66%
3 or more	100%

If a participant dies, attains the normal retirement age or becomes totally or permanently disabled, the participant becomes 100% vested in the Medical Center's contributions. Participants have become fully vested in their accounts after the Plan was terminated.

Payment of Benefits — Upon separation of service, the Plan will distribute vested account balances not exceeding \$5,000 in a lump-sum as soon as administratively practicable. A participant with a vested account balance greater than \$5,000 may elect to receive a lump-sum payment or maintain the vested balance in the Plan. Upon retirement or attainment of age 59½ the participant's account may be distributed to the participant or, in the event of death, to the participant's beneficiary, either in a lump-sum or on an installment basis over a period not to exceed the life expectancy of the Participant. Distribution of the participant's vested account balance must commence by April 1 of the calendar year following the later of the calendar year in which the participant attains age 70½ or the calendar year in which the participant retires. Participants may also elect a hardship distribution in accordance with Plan provisions.

Forfeitures — Forfeitures are first applied to pay administrative expenses of the Plan which otherwise would be paid by the Medical Center. Forfeitures not used to pay administrative expenses are applied to reduce the earliest employer contribution made after the forfeitures are determined. As of July 24, 2024 and December 31, 2023, there were no forfeited, non-vested account balances. During the year ended December 31, 2023, administrative expenses of \$9 were paid from forfeited non-vested accounts. During the period from January 1, 2024 through July 24, 2024, no administrative expenses were paid from forfeited non-vested accounts. Also, during the period from January 1, 2024 through July 24, 2024 and the year ended December 31, 2023 employer contributions were reduced by \$40,013 and \$31,705, respectively, from forfeited non-vested accounts.

Plan Tax Status — The Plan is a non-standardized plan of Principal Life Insurance Company. Principal Life Insurance Company obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the non-standardized plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the

Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has concluded that as of July 24, 2024, the Plan has no material uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates — The preparation of financial statements in conformity with the accrual basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition — Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The Plan's 401(k) Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by investment advisors and the asset custodian. See Note 3 for information on fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation of investments includes income on pooled separate accounts, common collective trusts and mutual funds, and gains and losses on investments bought and sold as well as held during the year consistent with the presentation provided by the custodian.

Contributions — Contributions from participants are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of July 24, 2024 or December 31, 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments — Benefits are recorded when paid.

Subsequent Events — The Plan has evaluated subsequent events for recognition or disclosure through the date of the Independent Auditors' Report, which is the date the financial statements were available for issuance.

3. INVESTMENTS

Fair Value Measurements — Generally accepted accounting principles require the Plan to use a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1: Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2: Prices determined using significant other observable inputs. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Prices determined using significant unobservable inputs.

The investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at July 24, 2024 and December 31, 2023.

Mutual Funds: Valued at the value of the shares held by the Plan at year-end, which are quoted in active markets.

Pooled Separate Accounts and Collective Investment Trusts: Valued at the net asset value of shares held by the Plan at year-end. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the investment will be sold for an amount different from the reported net asset value. These investments have no significant redemption restrictions.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of

different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. Investments for which fair value is measured using the net asset value per share practical expedient, are not categorized in the fair value hierarchy.

Plan investments include pooled separate accounts of Principal Life Insurance Company and collective investment trusts of its affiliate, Principal Global Investors Trust Company, who are the custodians of the investments, and therefore, these transactions qualify as party-in-interest transactions. The Plan also has notes receivable from participants which qualify as party-in-interest transactions.
