### NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

This summary of significant accounting policies of the Tiegerman School Employees' Retirement Plan (the "Plan") is presented to assist in understanding the Plan's financial statements and supplemental information. These financial statements, supplemental information, and notes are representations of Tiegerman School Inc. (hereinafter, the "Plan Sponsor") management, which is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements and supplemental schedule.

Basis of Accounting: The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for a further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year. During the year ended June 30, 2024, the Plan's investment gains (including gains and losses on investments bought and sold, as well as held during the year) were \$4,817,082.

Payment of Benefits: Benefits are recorded when paid to the Plan's participants.

Plan Expenses: Certain administrative, accounting and audit expenses for the Plan were paid directly by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the distributions to participants are charged directly to the participant's account and are included in administrative expenses. Accounting and audit expenses may be paid from the forfeiture account, and if so, are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Events Occurring After Report Date: The Plan Sponsor evaluated events and transactions that occurred between July 1, 2024 and April 7, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

**NOTE 2 - DESCRIPTION OF THE PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and Eligibility: The Plan was originally established July 1, 2002, by the School for Language and Communication Development (the "School") as a noncontributory defined contribution plan for the benefit of its eligible employees. Effective October 17, 2017, the School for Language and Communication Development changed its name to the Tiegerman School and the Plan was amended to change its name from School for Language and Communication Development Employees' Retirement Plan to Tiegerman School Employees' Retirement Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is a combination custodial account and annuity contract. The Plan assets are held by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal Trust"), the Trustee or Custodian, and Principal Life Insurance Company ("Principal"), is the recordkeeper. The Plan Sponsor uses Loren D. Stark Company (formerly SBC Benefit Consultants, Inc.) as third-party administrators of the Plan. Employees are eligible for employer contributions if they complete one year of service, work 1,000 hours during the Plan year, and were employed on the last day of the Plan year. The Plan excludes the following employees from participating in the plan (1) employees covered under a collective bargaining agreement, (2) non-resident aliens who do not receive any compensation from U.S. sources, (3) employees working in programs funded by the Office for People with Developmental Disabilities ("OPWDD"), and (4) employees on a leave of absence.

Contributions: The School's profit-sharing contributions are discretionary and are determined by the School's Board of Directors annually. Employer contributions, if any, are allocated to eligible employees based on certain designated groups under the Plan.

For the years ended June 30, 2024 and 2023, the School provided discretionary profit-sharing contributions of \$2,250,000 and \$2,700,000, respectively. For the 2024 Plan year, the employer contribution rate for employees with less than 10 years of service received an employer contribution equal to 6.830% of compensation and employees with 10 years of service or more received an employer contribution equal to 13.680% of compensation.

Contributions are subject to certain limitations.

Participant Accounts: Participants have the option of directing their employer contributions into any of the various investment options offered by the Plan and may change the allocation at any time.

Vesting: Participants who leave the Plan because of death, early or normal retirement (normal retirement date is the later of attaining age 65 or the participant's fifth anniversary in the Plan) or disability retirement, as defined by the plan document, are considered 100 percent vested. Participants that leave the Plan due to reasons not mentioned above will have their employer's contributions and earnings thereon vested in accordance with the following schedule:

Payment of Benefits: Upon termination of service, a participant may elect to receive the vested value of the participant's account in the form of a single lump sum, a partial lump sum, installments, or to purchase an annuity. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

Notes Receivable from Participants: Participants may not borrow from their plan accounts.

Forfeited Accounts: As of June 30, 2024 and 2023, forfeited nonvested accounts totaled \$484,253 and \$331,271, respectively. These accounts are reallocated to participants in the same manner as employer contributions. For the year ended June 30, 2024, there were \$187,787 of new forfeitures and \$84,148 of forfeitures were used to pay Plan expenses. Forfeitures will be reallocated to the participant during the 2025 Plan year.

Plan Amendments: The Plan Sponsor has the right under the Plan to amend the Plan at any time. The Plan was last amended on April 20, 2020 to allow for Coronavirus-related distributions and temporarily waiving required minimum distributions. These amendments were in response to the CARES Act.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become one hundred percent vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Plan Sponsor may determine.

### NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE

Investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust.

### NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan Sponsor utilizes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset and liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Accounting Standards Update ("ASU") 2015-12 states that FBRICs should be measured, presented, and disclosed only at contract value and fair value information is not required. All GICs that are deemed benefit responsive investment contracts should no longer be included in Accounting Standard Codification ("ASC") 820 fair value disclosures.

A plan should continue to provide disclosures that help users understand the nature and risks of fully benefit-responsive investment contracts. The GIC will provide information about redemption frequency and notice periods if applicable.

This contract does have surrender charges if it is terminated by the contract holder or a plan terminates its interest in such contract within certain time periods. If a contract is terminating and a surrender charge applies, the plan may no longer be deemed benefit-responsive.

This could require the GIC to be reported at fair value and thus included in the ASC 820 fair value disclosures. Fair value is the amount plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to maturity for an event other than death, disability termination or retirement. Most participant transactions are executed using contract value without adjustment. If the contract holder is considering terminating the contract or a plan is considering terminating its interest in such contract in the near future, contract value less surrender charges may be a better proxy for fair value.

The GIC issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.0 percent. The interest rate credited to participants for the year ended June 30, 2024 was 2.0 percent for the first six months and 1.9 percent for the last six months.

**NOTE 6 - FORFEITURES**

If employment is terminated at a time when an employee is only partially-vested (or totally non-vested), how the Plan treats an employees' non-vested portion of their employee account depends on whether or not an employee takes a distribution when they terminate employment. Based upon timing of distributions, forfeitures are treated as follows:

- Forfeiture upon distribution - if a distribution is taken upon termination, the entire non-vested balance will be forfeited in accordance with the terms of the Plan.
  - If a distribution is taken upon termination and results in a non-vested balance being forfeited, re-hired employees have the right to repay the distributed amount to the Plan if the re-hired employee repays the amount distributed prior to reaching five consecutive years of a break in service. If the entire distribution amount is repaid, the employer will restore the entire non-vested benefit which was forfeited as a result of the original distribution.

- In order to restore forfeited benefits, repayment must be made to the Plan no later than five years following the re-hired employees reemployment date. If the employee received a "deemed" distribution because they were totally non-vested, the non-vested benefit will automatically be restored within a reasonable time following their reemployment, provided they have not incurred five consecutive years of a break in service prior to their reemployment.
- Forfeiture upon five consecutive years of a break in service - depending on the value of an employee's vested benefits, they may be able to keep their benefits in the Plan when they terminate employment. If they do not take a distribution of their entire vested benefit when they terminate employment, their non-vested benefit will remain in their account until they have incurred five consecutive years of a break in service, at which time their non-vested benefit will be forfeited in accordance with the terms of the Plan. For this purpose, a participant will have a Break in Service for each year in which a participant works less than 501 hours. A participant's vested benefits will not be forfeited under this forfeiture rule.

**NOTE 7 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

Certain Plan investments are managed by the Trustee, as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions.

Fees paid directly by the Plan for contract administration totaled \$87,241 for the year ended June 30, 2024. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

**NOTE 8 - TAX STATUS**

The Plan operates under a volume submitter profit sharing plan document sponsored by Principal. This volume submitter plan document has been filed with the appropriate agency and has obtained an opinion letter dated June 30, 2020, from the Internal Revenue Service stating that the volume submitter plan document is acceptable under Section 401 of the Internal Revenue Code. While the volume submitter plan document has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America requires the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and Internal Revenue Service.

**NOTE 8 - TAX STATUS (continued)**

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**NOTE 10 - SECURE ACT**

In January 2020, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE Act"). Many of the provisions of the SECURE Act will require significant changes to plan administration and recordkeeping. When it becomes necessary to do so, the Plan will be amended as required to comply with the SECURE Act.



