NOTE 1: DESCRIPTION OF PLAN

The following description of the Stairways 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan Document of Summary Plan Description for a more complete description of the Plan's provisions.

A. General

The Plan is a 403(b) tax-sheltered annuity retirement plan covering substantially all employees of Stairways Behavioral Health (the Agency). Employees of the Agency are eligible to participate in elective salary reduction deferral (employee) contributions immediately upon hire by the Agency, and are eligible to receive matching (employer) contributions when they have achieved 6 months . Employees who work less than 20 hours per week are not eligible to participate in the plan, unless they complete one year of service. Independent contractors and part-time bargaining unit employees are not eligible to receive non-elective employer contributions. Effective July 1, 2023, employees must have attained a minimum age of 18 years in order to receive matching contributions.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective November 22, 2013, the Plan was amended and restated to comply with final regulations under section 403(b) of the Internal Revenue Code of 1986, as amended, and to make certain other changes. The amendments did not have a significant effect on benefits or net assets.

B. Contributions

The Agency may make a discretionary employer contributions governed by Agency policy and approved annually.

The Plan had a discretionary employer match. For non-bargaining employees eligible for and electing to participate in the Plan as of August 31, 2018, the Agency would contribute 2% of the employee's gross earnings for the period beginning with the effective date of the amendment. If the employee elects to participate in and defer a portion of the employee's eligible gross earnings to the plan, the Agency would, in addition to its 2% contribution, contribute an amount equal to 50% of the employee's deferred eligible gross earnings, up to a maximum amount equal to 3% of the employees gross earnings, yielding a maximum possible combined employer contribution of 5%.

Effective July 1, 2023 the employer matching contribution for non-bargaining unit employees was amended to be equal to 50% of the employee elected deferrals that do not exceed 6% of eligible compensation for the period.

For eligible bargaining unit employees that enroll in the Plan, who become eligible to participate in the Plan, and who start working on or after September 1, 2018, starting with the first anniversary of the employee's date of hire, upon participation, the Agency, starting with the 13th month of eligibility, will contribute 2% of the employee's gross earnings. After 60 months of employment, if the employee elects to defer a portion of the employee's eligible gross earnings to the plan, the Agency will, in addition to its 2% contribution, contribute an amount equal to 50% of the employee's deferred eligible gross earnings, up to a maximum amount equal to 2% of the employees gross earnings, yielding a maximum possible combined employer contribution of 4%.

B. Contributions (Continued)

Employee contributions are elected as a deferral of eligible compensation. A participant's includible compensation means a participant's total compensation that is subject to income tax withholding and paid by the Agency for the plan year.

Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers various mutual fund options for participants. Annual contributions are subject to certain limitations under the Internal Revenue Code.

C. Participant Accounts

Each participant's account is credited with their allocations of the employee's and the Agency's contribution and Plan earnings, and charged with an allocation of investment and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting

Participants are vested immediately in all employee contributions plus actual earnings thereon. Effective July 1, 2023, participants are 100% vested in employer contributions and earnings thereon upon the completion of two years of service. Prior to July 1, 2023, participants were immediately vested in all employer contributions.

E. Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 less the highest outstanding loan balance during the one year period prior to the new loan application date, or 50% of their account balance less any current outstanding loan balances. The loans are secured by the balance in the participant's account and bear interest rates that are commensurate with rates charged by other lenders on similar loans. Loan repayments are made ratably through payroll deductions over a period not to exceed 5 years, unless the loans were used to purchase a primary residence, in which case the loan terms may be up to 10 years. Effective October 1, 2023 a participant may not borrow less than \$1,000 in any single loan. Also, effective October 1, 2023 loans bear interest at the Prime rate plus 1%.

F. Payment of Benefits

Plan benefits begin at the normal retirement age of 65, however, in service distributions can commence upon age 59 ½. Participants who have attained their retirement age shall have a 100% non-forfeitable right in the value of their account. Upon termination of employment due to death, disability, retirement, or other separation participants or their beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum payment or in annual installments over a period of not more than the participants assumed life expectancy. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

G. Plan Termination

Although it has not expressed any intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting and in conformity with generally accepted accounting principles.

B. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of June 30, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the loan to be in default, the loan balance is reduced, and the delinquent participant loan receivable is recorded as a benefit payment based on the terms of the Plan Document.

E. Payment of Benefits

Benefits are recorded when paid.

F. Subsequent Events

Subsequent events have been evaluated through April 11, 2025 which is the date the financial statements were available to be issued.

NOTE 3: PLAN ADMINISTRATION

The Plan is administered by the Agency. The Plan is responsible for payment of all administrative expenses. For the years ended June 30, 2024 and 2023, such expenses totaled \$69,369 and \$63,943, respectively. All other administrative costs (i.e. payroll costs related to administration of the Plan) are paid by the Agency and not a deduction from Plan net assets.

NOTE 4: TAX STATUS

The Internal Revenue Service does not currently have a process for this type of plan to be submitted for a determination letter. However, the Plan's tax counsel believes that the Plan is designed, and the Plan administrator believes that the Plan is currently operating, in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained up examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5: INVESTMENTS AND FAIR VALUE MEASUREMENTS

During 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated/(depreciated) in value by \$1,232,410 and \$1,701,830, respectively. Interest and dividend income on investments was \$785,932 and \$214,072 during 2024 and 2023, respectively.

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 or 2023.

Registered Investment Companies: Mutual funds are valued at the net asset value (NAV) of shares held by the plan at year end, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
