Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Centauri 401(k) Savings Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of February 12, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period ended February 12, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Newport Trust Company, LLC, the custodian of the Plan, a qualified institution, as of February 12, 2024 and December 31, 2023, and for the period ended February 12, 2024, stating that the certified investment information, as identified in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Merger

As further discussed in Note A, the Plan was merged into the Aon Pooled Employer Plan effective January 1, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE A - DESCRIPTION OF PLAN

The following description of Centauri 401(k) Savings Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Centauri Health Solutions, Inc. (the Company, Plan Administrator, and Plan Sponsor) who have completed one year of service and attained the age of twenty-one. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective January 1, 2024, the Company became a participating employer of Aon Pooled Employer Plan (the PEP Plan). In addition, on January 19, 2024, Plan contributions began being remitted to the PEP Plan. On January 4, 2024, the Plan merged the majority of its assets into the PEP Plan and completed this process on February 12, 2024. Transferred assets consisted of investment balances totaling \$36,975,781 and notes receivable from participants totaling \$605,373. Transfers of net assets to the PEP Plan also include participant contributions receivable totaling \$158,573, employer contributions receivable totaling \$28,385, and excess contributions payable totaling \$33,074.

Contributions

Each year, participants may elect to defer up to 100% of compensation as defined by the Plan on either a pre-tax or after-tax (Roth) basis. Employees who have not declined participation in writing or completed a salary deferral agreement as of the date of their eligibility to participate in the Plan will be automatically enrolled in the Plan with a pre-tax deferral rate of 3% and their contributions are invested in a designated fund until changed by the participant. The automatic deferral will increase by 1% up to a maximum of 6% of compensation on the first day of May of each year. The Plan provides for a discretionary employer matching contribution, which was 25% of the first 6% of annual compensation. There were no discretionary employer matching contributions made to the Plan during the period ended February 12, 2024.

The Plan also provides for a discretionary employer profit sharing contribution. There was no discretionary employer profit sharing contribution during the period ended February 12, 2024. The Plan provides for the acceptance of rollover contributions from other plans qualified under the Internal Revenue Code (the Code). The Plan also provides for catch-up contributions for participants who reach the age of 50 by the end of the calendar year. Participants direct the investment of their contributions into various options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as an allocation of the Company's profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, compensation, specific participant transactions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer contributions plus actual earnings thereon is based on years of continuous service at a rate of 25% per year. A participant is fully vested after four years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the participant's highest outstanding loan balance during the previous twelve months or 50% of their vested account balances. Notes receivable terms range from one to five years or longer for the purchase of a primary residence. Notes receivable are secured by the balances in the participants' accounts and bear interest at the prime rate plus 1.00%. The interest rates on notes receivable range from 8.00% to 9.50% at February 12, 2024. Interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Upon retirement, termination, attainment of age 59½, or disability, a participant or a participant's beneficiary upon the participant's death may elect to receive a lump-sum amount equal to the value of the participant's account or annual installments not extending beyond the life expectancy of the participant. If the value of the vested benefits credited to a participant's account is \$1,000 or less at the time of the termination, the entire amount will be distributed to a participant without the participant's consent. In the event of a mandatory distribution of amounts greater than \$1,000 but not exceeding \$5,000, the entire amount will be distributed in the form of a direct rollover to an individual retirement account as designated by the Plan Sponsor.

Active participants may request hardship withdrawals from their pre-tax elective deferral account balances, subject to Plan provisions.

Forfeited Accounts

Forfeited nonvested amounts may be used to pay administrative expenses of the Plan or reduce future employer contributions. Unallocated forfeiture balances as of February 12, 2024 and 2023 were \$-0- and \$911, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by Newport Trust Company, LLC (the Custodian). See Note D for discussion of fair value measurements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of February 12, 2024 and 2023. If a participant ceases to make repayments on a note receivable and the Plan Administrator deems the note receivable to be uncollectible, the balance on the note receivable from the participant is reclassified to benefits paid to participants.

Investment Income Recognition

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and Contributions Receivable

Contributions from Plan participants and related discretionary employer matching and profit sharing contributions are recorded in the year in which the employees' participant contributions are withheld from compensation. Any contributions attributable to the Plan year but not received by the trust by the last day of the Plan year are recorded as a receivable.

The carrying amounts of contributions receivable are assessed for the need to record valuation allowances. The valuation allowances are estimates derived from the Plan's historical losses of contributions receivable, adjusted for the Plan Administrator's assessment of current conditions, reasonable and supportable forecasts regarding future events, and any other factors deemed relevant by the Plan. Based on the Plan Administrator's assessment as of February 12, 2024 and December 31, 2023, no allowances for contributions receivable were recorded as of February 12, 2024 and December 31, 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Code are recorded as a liability with a corresponding reduction to contributions. The Plan accrued \$-0- and \$33,074 in excess contributions payable at February 12, 2024 and December 31, 2023, respectively.

Payment of Benefits

Benefits are recorded when paid.

Income Taxes

The Company adopted a non-standardized pre-approved profit sharing, money purchase plan with a cash or deferred arrangement which received an opinion letter from the IRS dated November 30, 2020 stating that the Plan was designed in accordance with the applicable sections of the Code. Although the Plan has been amended since receiving the opinion letter, the Plan Sponsor believes that the Plan is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the payment of benefits and administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Participants' accounts are also charged a quarterly flat fee that is included in administrative expenses. Investment related expenses are included in investment income on the accompanying statement of changes in net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through April 7, 2025, the date which the financial statements were available to be issued.

NOTE C - CERTIFICATION

Investment information and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2023, and net depreciation in fair value of investments, interest, and interest income on notes receivable from participants for the period ended February 12, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian.

NOTE D - FAIR VALUE MEASUREMENTS

The three levels of the fair value hierarchy, which are based upon the inputs used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets or liabilities (for example, exchange quoted prices).

Level 2 - Inputs to the valuation methodology are observable inputs, other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets, quoted prices in markets that are not sufficiently active to qualify as Level 1, other observable inputs, or inputs that can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs to the valuation methodology are significant to the fair value measurement and unobservable (for example, supported by little or no market activity).

Financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

At February 12, 2024 and December 31, 2023, the fair value of mutual funds included in Level 1 of the fair value hierarchy was \$-0- and \$35,592,105, respectively.

NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodology used for assets measured at fair value. There has been no changes in the methodology used as of February 12, 2024 and December 31, 2023.

Mutual funds are valued at the net asset value of shares held by the Plan at year end, as reported on the active markets in which the investments are traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement as of the reporting date.

NOTE E - GUARANTEED INVESTMENT CONTRACT

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Standard Insurance Company (The Standard) with balances of \$-0- and \$1,620,148 at February 12, 2024 and December 31, 2023, respectively. Contributions from the Plan and credited interest are maintained in The Standard's general account. Crediting interest rates are set for the coming quarter by The Standard taking into account yield forecasts from The Standard's asset advisory group and margin considerations. The minimum annual crediting rate under the contract cannot be less than 1% annually. Contract value is guaranteed by The Standard.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by The Standard, represents contributions made under the contract, plus interest credited, less participant withdrawals and administrative expenses. Participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balances at contract value.

The repayment of principal and interest credited to participants in the Plan is a financial obligation of The Standard. The Plan's ability to receive amounts due is dependent on The Standard's ability to meet its financial obligations. The Standard's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of The Standard or otherwise.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and liberalization of Plan withdrawal or transfer rules. Upon the occurrence of these events, a market value adjustment or other withdrawal restriction may apply.

NOTE E - GUARANTEED INVESTMENT CONTRACT (CONTINUED)

The Standard may terminate the contract with 30 days advance written notice for reasonable cause, which includes a failure of the Plan to abide by state or federal law, to render performance necessary to comply with the terms of the contract, to maintain assets of at least \$25,000, or Plan disqualification. Upon termination of the contract by The Standard, a market value adjustment may apply. The contract was transferred to the PEP Plan.

NOTE F - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE H - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include the payment of fees to the Plan's recordkeeper, custodian, and investment advisor. Such transactions are exempt from being prohibited transactions.

The Newport Group provides certain administrative services to the Plan. The Newport Group receives revenues for these services from the Plan directly from investment fund service providers. This revenue is used to offset the administrative costs of the Plan.

NOTE I - PRIOR PERIOD ADJUSTMENT

Net assets available for benefits at January 1, 2024 has been adjusted to reduce employer contributions receivable by \$22,650 for a true up amount that was not required per an amendment to the Plan document.
