NOTE 1 - DESCRIPTION OF PLAN

The following description of the Upper Manhattan Mental Health Center, Inc. (the "Organization") Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The plan was effective June 1, 1975.

A. General

The Plan is a defined contribution 401 (a) profit-sharing plan covering all full-time non-union employees of the Organization who are at least 21 years of age, completed one year of service, and worked 1,000 hours for the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

B. Eligibility and Service Rules for Participation

Employees must be at least 21 years of age and complete at least 1,000 hours of service to receive employer base contributions under the plan.

C. Contributions

Each Plan year, the Organization may make a discretionary contribution for all eligible participants based on a declared percentage of the participant's compensation. The percentage contributed is determined at the discretion of the Organization's Board of Trustees. For the years ended June 30, 2024 and 2023, no contributions were declared by management. However, rollover contributions of \$0 and \$99,257, respectively were received into the plan.

D. Participant Accounts

Each participant's account is credited with allocations of: (a) the Organization's contribution, (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

E. Vesting

Vesting in the Organization's contributions is based on years of continuous service. Participants are vested based on the following schedule: 20% after 2 years, 40% after three years, 60% after four years, 80% after five years, and 100% vested after six years of service. In addition, a participant is considered to be 100% vested upon attainment of early retirement.

F. Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures are applied first to paying fees. Forfeitures remaining after such payments are retained in the plan for future expenses or are reallocated as contributions and applied on a pro-rata basis to all eligible participants in accordance with the Plan. As of June 30, 2024, and 2023, no forfeitures were reallocated. Unallocated forfeitures as of June 30, 2024 and 2023, totaled \$60,862 and \$48,066, respectively.

G. Loans to Participants

A participant may elect to take out a loan subject to the rules and limitations of the Plan and the terms of the applicable contract. The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum of \$1,000 up to a maximum of 50% of his/her vested balance or \$50,000 (whichever is less). Loans to the participant are made directly from Mutual of America Life Insurance Company. The loan must be repaid to Mutual of America Life Insurance Company within a five-year period in substantially equal payments (not less frequently than quarterly). The five-year repayment period will not apply to a loan that is used to acquire a principal residence of the borrower.

The loans are secured by the balance in the participant's account. If the borrower does not repay the loan and related interest due in accordance with the schedule set forth in the promissory note or other writing permitted by applicable law representing the loan, their loan will be in default. Defaults in loans are treated as a distribution at the time of the default against the participant's account. Delinquent participants' loans are reclassified as distributions based on the terms of the plan document. The loan interest rates are from 4.25% to 9.50% with maturities through 2026. As of June 30, 2024 and 2023, we had no delinquent loans. Participants' notes receivable as of June 30, 2024 and 2023 were \$19,034 and \$8,305, respectively.

H. Distributions

Participants are entitled to distributions of their vested benefits upon retirement, death, disability or termination of employment in either a lump-sum amount or in installment payments.

I. Administrative Expenses

Expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Fees incurred by the plan for investment management services are reflected as administrative expenses in the accompanying financial statement.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

B. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

E. Payments of Benefits

Benefits are recorded when paid.

NOTE 3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 4. TAX STATUS

On August 8, 1990, The Internal Revenue Service (IRS) stated that the prototype adopted by the Plan, as then designed, qualifies under the Internal Revenue Code ("IRC") Section 401 (a). The Plan has not received a determination letter specific to the Plan itself and has been amended since the prototype adoption.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service ("IRS"). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6. FAIR VALUE MEASUREMENTS

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liabilities; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

If the asset or liability has a specified (contractual) term, the Level 2 Input must be observable for substantially the full term of the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

General Account Fund:

The General Account is an Interest Accumulation Account in which amounts placed in the account are credited with interest at a rate determined by Mutual. Mutual reserves the right to change the interest rates applicable to amounts held in the interest Accumulation Account at their discretion. The General Account is valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

Pool Separate Account Funds:

Pooled Separate Account Funds are valued at the net asset value of shares held by Mutual at year end as determined by the issuer of the fund. Variable annuity considerations and certain variable life insurance premium may be allocated at participants' discretion among investment funds in Separate Accounts. Separate Account Funds invest in mutual funds, including funds managed by Mutual, and other funds managed by outside investment advisors. All net realized and unrealized capital gains in the Separate Accounts, which reflect investment performance of the mutual funds in which they invest, accrued directly to participants. The Pooled Separate Accounts are direct filing entities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are in a general account and pooled separate account funds managed by Mutual. Mutual is the Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are reflected as administrative expenses in the accompanying financial statements and amounted to \$557 and \$461 for the fiscal years ended June 30, 2024 and 2023, respectively.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances, and the amount reported in the statement of net assets available for benefits.
