Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of D.L. Martin Co. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of D.L. Martin Co. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Voya Retirement Insurance and Annuity Company, a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value includes the plan's gains and (losses) on investments bought and sold as well as held during the year.

Contributions

Contributions from the Plan participants and the Company matching and profit sharing contributions are recorded in the year in which the employee contributions are withheld from compensation and on compensation paid during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the general administration of the plan are allocated to the participant's accounts and are included in administrative expenses. Fees related to a specific participant are charged directly to that participant's account. Investment related expenses are included in net appreciation in fair value of investments.

NOTE 2 DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan covers employees of D.L. Martin Co., Alliance Elevator Solutions, LLC, a joint venture, and wholly-owned subsidiary DLM East, Inc., collectively referred to herein as the Company.

General

The Plan is a defined contribution plan covering all eligible full-time employees of the Company. The Plan is subject to the provisions of ERISA.

Participation and Eligibility

Employees are eligible to participate once they satisfy the Plan's eligibility conditions described in the Plan's agreement provided they are not an excluded employee. Employees become eligible to participate in the Plan once they have completed one year of service and are age 18 or older. To have completed a year of service, they must have been credited with at least 1,000 hours of service.

Contributions

Participants may contribute a percentage of their total annual compensation, as defined by the plan, not to exceed the maximum amount allowed under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Matching contributions are equal to a percentage of the participant contribution and determined from time to time by the Company. Beginning July 1, 2016, the Plan was amended to add an automatic deferral arrangement in which all new participants and existing participants who did not have an affirmative deferral election at the time of restatement, would have 3 percent of their compensation automatically withheld unless they opt out. The Company offers a discretionary matching contribution. For 2024, the matching contribution for the Company was 50 percent of the first 6 percent of the participant's elective salary deferral. The Company's matching contribution was \$178,001, for the year ended June 30, 2024. In addition to the matching contribution, the Company can elect to contribute to the Plan an amount from the Company's net earnings for the fiscal year ending with such plan year as determined by the Board of Directors. There was no additional Company profit sharing contribution provided to the plan for the year ended June 30, 2024. Both participant and company contributions are subject to limitations under applicable provisions of the Internal Revenue Code.

NOTE 2 DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is invested in accordance with the participant's instructions in one or more funds selected and approved by the Plan. Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the company matching and profit sharing contribution portions of their account are based on years of continuous service. Participants automatically become fully vested upon reaching normal retirement age (65 years old), or in the event of disability or death.

Participants become vested in the company matching profit sharing contributions as follows:

Notes Receivable from Participants

Participants may not borrow funds from their retirement accounts.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the vested balance of his or her account, or annual installments of at least \$1,000 over the life expectancy of the participant. Distributions of vested account balances of \$1,000 to \$5,000 that meet the provisions for a mandatory distribution will be paid as a direct rollover into an individual retirement account designated by the Plan Administrator if the participant does not elect the distribution method. Effective January 1, 2024, the \$5,000 threshold was increased from \$5,000 to \$7,000 for mandatory distributions. Distributions of vested account balances less than \$1,000 that meet the provisions for a mandatory distribution will automatically be paid directly to the participant if the participant does not elect the distribution method. In addition, hardship and in-service distributions are permitted if certain criteria are met.

Forfeited Accounts

At June 30, 2024 and 2023 forfeited nonvested accounts totaled \$3,775 and \$0, respectively. These accounts will be used to offset administrative fees and company contributions in the next plan year. During 2024, no forfeited nonvested account totals were used to reduce company contributions or pay administrative fees.

NOTE 3 INFORMATION CERTIFIED BY CUSTODIAN

The financial statements as of June 30, 2024 and 2023 and for the year ended June 30, 2024 were prepared from information provided by Voya Retirement Insurance and Annuity Company, the custodian of the Plan, which they certified to be complete and accurate to the best of their knowledge. Following is a summary of the unaudited information included in the Plan's financial statements and supplemental schedule that was prepared by the custodian of the Plan and furnished to the Plan Administrator.

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Pooled Separate Accounts (Registered Investment Companies)

Valued at their "accumulation unit value" (AUV). The separate account is valued daily as the number of accumulation units held multiplied by the AUV. The AUV is first established when a new fund starts and is then determined daily based on the net asset value of shares of the underlying fund, the fund's dividends and the contract's separate account charges. The fund AUV's are available from the custodian. The contract's daily asset charge (separate account charge) is communicated to plan management in the contract and applicable notice of change.

- (b) These funds seek conservation of capital, current income and long-term growth of capital and income. The fund uses a balanced approach to invest in a broad range of securities, including common stocks and investment-grade bonds.
- (c) These funds seek to maximize total return through income and capital appreciation. Under normal market conditions, the fund invests at least 80% of its net assets (plus borrowings for investment purposes) in a portfolio of bonds.
- (d) These funds seek long-term growth of capital. The fund seeks to take advantage of investment opportunities generated by changes in international trade patterns and economic and political relationships by investing in common stocks of companies located around the world.
- (e) These funds seek long-term capital appreciation. Under normal circumstances, at least 80% of the fund's assets will be invested in the equity securities of large, well-established companies.
- (f) These funds seek capital appreciation and current income. Under normal circumstances, at least 80% of the fund's assets will be invested in the equity securities of corporations that regularly pay dividends, including common stocks and debt securities and preferred securities convertible to common stock.

- (g) These funds seek to track the performance of the CRSP U.S. Mid Cap Index that measures the investment return of mid-capitalization stocks.
- (h) These funds seek long-term growth of capital. The fund pursues its investment objective by investing primarily in common stocks selected for their growth potential, and normally invests at least 50% of its equity assets in medium-sized companies.
- (i) These funds seek to maximize current income; long-term capital appreciation is a secondary objective. The fund invests at least 65% of its total assets in a multi-sector portfolio of Fixed Income Instruments of varying maturities.
- (j) These funds seek to track the performance of the CRSP U.S. Small Cap Index that measures the investment return of small-capitalization stocks.
- (k) These funds seek long-term capital appreciation and normally invests at least 80% of its net assets (plus the amount of any borrowings for investment purposes) in the stocks of small-capitalization companies.
- (l) These funds seek growth of capital. The fund invests mainly in common stocks of small-capitalization companies.
- (m) These funds seek to provide investors with a high level of current income consistent with preservation of capital and liquidity and the maintenance of a stable \$1.00 net asset value per share.

NOTE 5 GUARANTEED INVESTMENT CONTRACT WITH VOYA RETIREMENT INSURANCE AND ANNUITY COMPANY

The Plan maintains a fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company (Voya) totaling \$782,409 and \$939,364 as of June 30, 2024 and 2023, respectively. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. Such interest rates are reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 5 GUARANTEED INVESTMENT CONTRACT WITH VOYA RETIREMENT INSURANCE AND ANNUITY COMPANY (CONTINUED)

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 7 RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company, the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan made a direct payment to the third party administrator of \$4,559 and \$8,811 to the plan auditor, which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the plan's operations.

NOTE 8 TAX STATUS OF THE PLAN

The sponsor company adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan with a cash or deferral arrangement as a base for the D.L. Martin Co. 401(k) Profit Sharing Plan. The prototype plan sponsor has obtained an opinion letter dated June 30, 2020, noting that the plan documents are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine audits by taxing jurisdictions, generally for a period of three years after the returns are filed; however, there are currently no audits for any tax periods in progress.

NOTE 9 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer accounts.

NOTE 10 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

NOTE 11 SUBSEQUENT EVENTS

The Plan has evaluated events and transactions subsequent to June 30, 2024 through April 4, 2025, the date these financial statements were available to be issued. Based on definitions and requirements of generally accepted accounting principles, the Plan has not identified any events between June 30, 2024 and April 4, 2025 that require recognition or disclosure in the financial statements.
