### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Centers for Habilitation 403b Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023 and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

The supplemental schedule H, line 4i-schedule of assets held at end of year and schedule H, line 4a-schedule of delinquent participant contributions as of or for the year ended June 30, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Note 1 - Description of Plan**

The following brief description of The Centers for Habilitation 403b Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering all eligible employees of The Centers for Habilitation (the Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### **Eligibility**

Employees are eligible to participate in the Plan and receive employer matching contributions on their hire date. Employees who are 19 years of age or older, have completed one year of service, and have worked 1,000 hours during the plan year are eligible for employer discretionary profit-sharing contributions. Employees qualifying for prevailing wage contributions are eligible for the contributions on their hire date.

### **Entry Date**

Employees may enter the Plan upon employment commencement date for deferrals and the first day of each Plan quarter for employer matching contributions.

### **Contributions**

Each year, participants may contribute up to 90 percent of their pretax annual compensation, as defined in the plan document. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Organization may also make discretionary matching and discretionary profit-sharing contributions. Matching contributions of \$84,151 were made and no additional discretionary profit-sharing contributions were made for the year ended June 30, 2024. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Organization also makes prevailing wage contributions based on certain health and welfare benefit contract agreements. The benefit rate for the year ended June 30, 2024 was \$4.57 per hour.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, prevailing wages and allocations of the Organization's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant's earnings or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investment Options**

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

### **Vesting**

Participants are vested immediately in their contributions, employer matching contributions, and prevailing wage contributions, plus actual earnings thereon. Vesting in the discretionary profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is vested 20 percent after one year of credited service and vests an additional 20 percent each year until fully vested after five years of credited service.

### **Forfeitures**

At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$0. These accounts, if any, are used to reduce employer contributions or to pay administrative expenses which would otherwise be paid by the Plan. During the year ended June 30, 2024, administrative expenses were not reduced from forfeited non-vested accounts.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time funds are borrowed, as determined quarterly by the Plan Administrator. The notes bear an interest rate ranging from 4.25 percent to 9.50 percent as of June 30, 2024. Principal and interest is paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the note were used to acquire the participant's residence, in which case the notes will be 15 years. Participants may have no more than one note outstanding at any one time.

### **Payment of Benefits**

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or annual installments as defined in the plan document upon retirement, termination of service, death or disability. A terminated employee with a balance of less than \$5,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant's election prior to termination upon attainment of age 59½ or hardship as defined in the plan document.

### **Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer profit-sharing contributions.

## **Note 2 - Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Organization determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the Statement of Changes in Net Assets Available for Benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

### **Contributions**

Participant contributions and the related employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### **Payments of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Expenses**

The Plan's expenses are paid by either the Plan or the Organization, as provided by the plan document. Expenses that are paid directly by the Organization are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

### **Subsequent Events**

The Plan Sponsor has evaluated subsequent events through April 8, 2025, the date which the financial statements were available to be issued.

### **Note 3 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Notes to Financial Statements

June 30, 2024 and 2023

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Omnibus Accounts - Mutual Funds – Valued at fair value based on the net asset value (NAV) of the units held in the account. The NAV, as provided by the custodian is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the account less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Omnibus accounts consist of various mutual funds and are valued based on the investments held. While the majority of the underlying asset values are quoted prices, the net asset value of the omnibus accounts is not publicly quoted.

Asset Allocation – The accounts in this category are primarily “target date funds” that seek total returns consisting of long-term growth and current income. Selected funds within this category may invest in domestic and foreign equity, real assets and alternative investments, and fixed income funds.

Growth – The accounts in this category primarily invest in common stocks of small to large market capitalizations that possess above-average growth potential, or whose value is not fully recognized by the public.

Bond – The accounts in this category primarily invests in investment-grade bonds issued by U.S. Corporations or by the U.S. Government or its agencies.

Value – The accounts in this category primarily invest in value stocks issued by companies with mid or small-sized market capitalizations that are believed to be undervalued in the marketplace in relation to factors such as the Organization’s assets, earnings, or growth potential.

Blend – The accounts in this category primarily invest in the 500 common stocks included in the S&P Index to replicate, to the extent practicable, the weightings of such stocks in the Index.

Other – The mutual fund account in this category primarily invests in common stocks of well-established companies located around the world, as well as investment grade debt securities.

**Note 4 - Certified Information**

Other than the notes receivable from participants and the related interest income, certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by American United Life Insurance Company and Nationwide Trust Company, FSB, the custodians. Notes receivable of \$133,512 and \$80,283 as of June 30, 2024 and 2023, respectively, and interest income of \$6,414 for the year ended June 30, 2024 were not certified by the custodians.

**Note 5 - Tax Status**

The Plan uses a pre-approved plan document sponsored by CCH Incorporated DBA FTWilliam.com, which received an opinion letter from the Internal Revenue Service (IRS), dated March 31, 2017, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Contract with Insurance Company**

The Plan has traditional fully benefit-responsive guaranteed investment contracts (GIC) with American United Life Insurance Company (AUL) and with Nationwide Life Insurance Company (Nationwide). AUL and Nationwide maintain the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3.00% for AUL, and 2.45% in year 1 of the contract and 0.95% in year 2 of the contract for Nationwide. After year 2, the rate will be at least the minimum annual interest rate, as defined in the contract. Such interest rates are reviewed on a quarterly basis for resetting. The GIC's do not permit the insurance companies to terminate the agreement prior to the scheduled maturity date.

Because the GIC's are fully benefit-responsive, contract value is the relevant measure for the GICs, as this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the AUL investment contract at June 30, 2024 and 2023 was \$0 and \$104,449, respectively. The contract value of the Nationwide investment contract at June 30, 2024 and 2023 was \$783,681 and \$669,656, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following for the AUL GIC: (1) full or partial plan termination; (2) the insolvency of the plan sponsor; or (3) aggregate terminations in any contract year that exceed 20 percent of the full contract value as determined on the first day of the contract year. Such events include the following for the Nationwide GIC: (1) amendments to the plan document; (2) the insolvency of the plan sponsor; or (3) premature termination of the contract. The Plan Administrator does not believe any events which would limit the Plan's ability to transact at contract value with the participants are probable of occurring.

The contracts do not stipulate any event or circumstance that would cause the issuers to terminate and settle at an amount different than contract value.

#### **Note 7 - Related Party and Party-in-Interest Transactions**

The Plan's investments are held by American United Life Insurance Company and Nationwide Trust Company, FSB, the custodians of the Plan. As discussed in Note 2, the Plan paid certain expenses related to plan operations and investment activity to the custodians. These transactions are exempt party-in-interest transactions under ERISA.

#### **Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 9 - Delinquent Participant Contributions**

It was noted in 2024 and 2023, that there were delays by the Organization in submitting employee contributions to the custodian in the aggregate amount of \$7,706 and \$19,243, respectively. In 2024, the Organization reimbursed the Plan for lost earnings from the 2023 late contributions and the Organization is in the process of filing Form 5330 and correcting lost earnings for the 2024 late contributions.


