## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrators of the 401(k) Profit Sharing Plan of  
Central State Community Services Oklahoma, Inc.:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

1. DESCRIPTION OF THE PLAN AND ACCOUNTING POLICIES

The following description of the 401(k) Profit Sharing Plan of Central State Community Services Oklahoma, Inc. provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The 401(k) Profit Sharing Plan of Central State Community Services Oklahoma, Inc. (the Plan) is a defined contribution plan covering all employees of Central State Community Services Oklahoma, Inc. (the Employer). The Plan has no minimum age or service requirement for employee contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). Central State's Board of Directors adopted the Plan on November 28, 2000, effective as of January 1, 2001.

In 2012, the Plan was amended to eliminate employer matching contributions.

Accounting Policies

Basis of Accounting --

The Plan's financial statements are prepared on the accrual basis of accounting.

Date of Management's Review --

Subsequent events were evaluated through April 7, 2025, which is the date the financial statements were available to be issued.

Contributions --

Each year participants may make salary reduction contributions up to 20% of pretax annual compensation, as defined in the Plan, or the maximum amount allowed by law. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also accepts rollover contribution amounts. Participants direct the investment of their contributions into the various investment

options offered by the Plan. The Plan currently offers mutual funds, a money market fund, and an interest accumulation account as investment options for participants.

#### Participant Accounts -

Mutual of America Life Insurance Company is the custodian and recordkeeper of the Plan. They maintain all participant account information (e.g. allocation of all contributions, investment earnings, and plan distributions). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting –

All employee contributions and earnings thereon are 100% vested to the participant at all times.

#### Payment of Benefits—

Benefits under the Plan begin when a participant retires, dies, or ceases to be an employee, whichever applies. Benefits are recorded when paid.

#### Estimates—

The preparation of financial statements in conformity with generally accepted accounting principles requires the administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition—

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the plan's gains and losses on investments bought and sold, as well as held, during the year.

## 2. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Accordingly, Mutual of America Life Insurance Company, the custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value.

That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2    Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Mutual funds:* Valued at the net asset value (“NAV”) of shares held by the plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. AMENDMENT OR TERMINATION OF THE PLAN

The Employer may amend or terminate the Plan at any time. Any such termination or amendment shall be effective at such dates as the Employer shall determine.

An amendment may affect participants' interests in the Plan at the time thereof as well as future participants' interests, but may not diminish the interests of participants' accrued benefits as of the effective date of such an amendment.

#### 5. TAX QUALIFICATION

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2014, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income examination for years prior to 2021.

#### 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### 7. RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Mutual of America. Mutual of America is the service provider as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.
