Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of **Ballet West 401(k) Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of June 30, 2024 and 2023 and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

1. DESCRIPTION OF THE PLAN

The following description of the **Ballet West 401(k) Plan** (the “Plan”) sponsored by Ballet West (the “Sponsor”, “Ballet”, or “Administrator”) is provided for general information purposes only. Participants should refer to the plan document, adoption agreement, and summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a prototype plan of Principal Life Insurance Company covering eligible employees of the Plan Sponsor. Employees 21 years and older are eligible to participate in the Plan upon completing 30 days of service, except for employees who are subject to the American Guild of Musical Artists collective bargaining agreement and enter the Plan on the first day of the month subsequent to reaching the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended, and is intended to be a qualified retirement plan under the Internal Revenue Code (“IRC”).

The Plan Administrator is responsible for oversight of the Plan. The Administrator determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

The Plan arranged for Principal Trust Company (“Principal”) to serve as trustee and provide record keeping services for the Plan.

Contributions

Each year, participants may elect to contribute any amount of pretax annual compensation, as defined in the Plan, subject to the maximum amount allowable by the Internal Revenue Service (“IRS”). Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Ballet may elect to make matching contributions to the Plan equal to a uniform percentage of a participant’s salary. In addition, the Ballet may make profit sharing contributions based on a formula described in the Plan document. For the year ended June 30, 2024, no matching or profit-sharing contributions were made to the Plan by the Ballet.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Ballet’s matching contribution, if any, and (b) the Plan’s earnings or losses. Allocations are based on participant earnings or account balances as defined by the Plan. Participant’s accounts are also charged with (a) individual account processing fees for loans, benefit payments, and withdrawals, (b) investment management fees and other expenses that apply to specific investments in a participant’s account, and (c) allocated Plan expenses for general administration and recordkeeping of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in employee contributions, rollover contributions, and actual earnings thereon. Vesting in the Ballet's employer matching and profit-sharing contributions is based on years of continuous service as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
1	20%
2	40%
3	60%
4	80%
5	100%

Participants also become 100% vested in employer matching and profit-sharing contributions upon death or disability, as defined by the Plan, or at normal retirement age (65).

Investment Options

Upon enrollment in the Plan, a participant may direct their contributions in any of the investments listed in the accompanying supplemental schedule of assets. Unless limited by restrictions imposed by individual investment options and subject to redemption fees, participants may change their investment options daily.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. General-purpose loans must be repaid over a period not to exceed five years. Participant loans are secured by the participant's vested balance and bear a reasonable rate of interest. The interest rates on outstanding notes receivable as of June 30, 2024 and 2023 ranged from **9%** and 9% to 9.25%, respectively, and maturities ranged from **2024** and 2023 to 2024, respectively.

Benefit Payments

Participants may receive the vested portion of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Under certain circumstances, including financial hardship, participants may withdraw the vested portion of their Plan account. Benefit payments are made in a lump sum distribution, rollover contributions to another plan, or annual installments over a reasonable period.

Forfeitures

The non-vested portion of employer contributions and earnings thereon forfeited by participants are held in a separate account and are first used to offset administrative costs of the Plan and then to reduce employer contributions, if such contributions are made. As of the years ended June 30, 2024 and 2023, there were no forfeited contributions available for use by the Plan. There was no forfeiture activity for the year ended June 30, 2024.

Plan Termination

Although it has not expressed any intent to do so, the Ballet has the right to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Revenue Recognition

The Plan's investments are stated at fair value. Quoted market prices are used to determine the fair value of shares of registered investment companies, which represent the net asset value of shares held by the Plan at year end. The common/collective trust and pooled separate accounts are stated at unit value, which is based on the aggregate fair value of the account in relation to the total number of units outstanding.

Purchases and sales of investments are recorded on a settlement-date basis. Interest income is recorded on the accrual basis and dividend income is accrued on the ex-dividend date. Net appreciation/(depreciation) for each year includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held, during the year.

Unit Values

Individual participant accounts for common/collective trust, and pooled separate accounts are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds, but have an interest therein represented by units valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to, and withdrawals from, each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

Contributions Receivable and Allowance for Doubtful Accounts

Employee contributions that have been withheld through payroll deductions but have not been credited to the participant accounts as of the end of the fiscal year are recorded as contributions receivable. As of June 30, 2024 and 2023, contributions receivable totaled \$0 and \$0. An allowance for doubtful accounts is deemed unnecessary and is not provided as of June 30, 2024 and 2023.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest and are secured by the participants' account balances. Interest income is recorded on the accrual basis. Related fees are charged to the participant's account as administrative expenses and are expensed when incurred. If a participant ceases to make repayments and the Plan Administrator deems the note receivable to be in default, the note receivable balance is reduced, and a benefit payment is recorded. Principal and interest are paid to the Plan through payroll deductions. Notes receivable from participants are exempt party-in-interest transactions. No allowance for credit losses has been recorded as of June 30, 2024 and 2023.

Benefit Payments

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Expenses related to investment advisory services, management fees, and maintenance of participant accounts are paid by the Plan. Expenses are generally allocated among the accounts of all participants in the Plan. Overall Plan-related expenses not paid by the Ballet are allocated proportionately based on the value of the account balances and are netted against investment returns. In addition, participants are charged set fees for specific account transactions, such as distributions following termination. The plan sponsor pays the cost of the annual audit for the Plan and any legal expenses, when applicable.

3. TAX STATUS

The Plan obtained its latest opinion letter on March 31, 2014, in which the IRS stated that the Plan, as then designed, was compliant with the applicable requirements of the Internal Revenue Code (the "Code"). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the accompanying financial statements.

3. TAX STATUS (Continued)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan's form 5500 filings remain open to examination for three years from the date filed.

4. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments and notes receivable from participants:

- Investments in common/collective trusts, registered investment companies, and pooled separate accounts
- Net change in fair value of investments
- Dividend income
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value methods used by the Plan may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments in pooled separate accounts and common/collective trusts are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds, but have an interest therein represented by units valued daily.

7. PARTY-IN-INTEREST TRANSACTIONS

The Ballet's contributions and investments are held and managed by Principal, the Plan's trustee, who invests cash received, interest and dividend income, and makes distributions to participants. Therefore, these transactions are considered exempt party-in-interest transactions. The trustee also administers the payment of interest and principal on the notes receivable from participants, which is reimbursed to the trustee through contributions as determined by the Ballet. Notes receivable from participants are also considered to be party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Ballet. No such officer or employee receives compensation from the Plan. Certain administrative expenses paid to the trustee qualify as party-in-interest transactions and totaled \$17,190 for the year ended June 30, 2024. All other administrative expenses, including audit fees, were paid by the Ballet, a party-in-interest, for the year ended June 30, 2024.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market risk, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. SUBSEQUENT EVENTS

Management has evaluated subsequent events through the date of the independent auditor's report, which is the date the financial statements were available to be issued. No additional events have occurred subsequent to June 30, 2024 that would require additional recording or disclosure in these financial statements.
